Subject: Tax Deducted at Source (TDS) on Interim Dividend

We are pleased to inform you that the Board of Directors of Aptus Value Housing Finance India Limited ("Company"), at its Meeting held on May 06, 2026, has declared an interim dividend of Rs. 2.50/- (Indian Rupees Two and Fifty Paise only) per equity share of face value of Rs. 2/- for the financial year 2025-26.

As you may be kindly aware, in terms of the extant provisions of the Income Tax Act, 2025 ("Act"), dividend paid or distributed by a company shall be taxable in the hands of shareholders. The Company shall therefore be required to deduct tax at source at the time of payment of dividend or the time of entry in books of accounts whichever is earlier/ on record date. The tax deduction/ withholding tax rate may vary depending on the residential status and category of the shareholder and dividend will be paid after deducting the tax at source/ withholding tax including surcharge and cess, as applicable.

All the shareholders are requested to update their records such as tax residential status, Permanent Account Number (PAN), bank account details and register your email address, mobile numbers and other details with your relevant depositories through your depository participants in case you are holding shares in dematerialized form and if you are holding shares in physical mode, you are requested to furnish details to the Company's Registrar and Share Transfer Agent ("RTA"), i.e. KFin Technologies Limited<sup>1</sup>.

This communication provides a brief of the applicable Tax Deduction at Source (TDS) provisions under the Act for Resident and Non-Resident shareholder categories.

## I. FOR RESIDENT SHAREHOLDERS

The summary of applicable rates of TDS for resident shareholders is given below:

Sl. No	Category of shareholder	Rate of deduction (%)
1	Resident Individuals	<ul style="list-style-type: none"> <li>Exempt where the total dividend for the year does not exceed INR 10,000</li> <li>In other cases, 10% shall apply</li> </ul>
2	Alternative Investment Fund	<ul style="list-style-type: none"> <li>Category I or a Category II AIF – Exempted</li> <li>Category III AIF – 10%</li> </ul>
3	Mutual Funds	Exempt
4	Insurance Companies	Exempt
5	Government (Central/State)	Exempt
6	Others	10%

Tax is required to be deducted at source under Section 393 of the Act, at the rate of 10% on the amount of dividend payable where shareholders have registered their valid PAN. In case, shareholders do not have PAN / have not registered their valid PAN details in their account, TDS at the rate of 20% (plus applicable surcharge and cess) shall be deducted as per Section 397(2) of the Act.

### A. Resident Individuals

No tax shall be deducted on the dividend payable to resident individuals if –

- i. Total dividend amount to be received by them during the Financial Year 2025-26 does not exceed Rs. 10,000/; or
- ii. The shareholder provides a written declaration in prescribed Form 121, provided that all the required eligibility conditions are met. Please note that all fields are mandatory to be filled up and Company may at its sole discretion reject the form if it does not fulfil the requirement of law; or

- iii. Exemption certificate is issued by the Income-tax Department, if any.

### B. Resident Non-individuals: No tax shall be deducted on the dividend payable to the following resident non- individuals where they provide details and documents as below:

Government (Central/State)	No tax is required to be deducted at source on dividend payable to the Government of India, the Reserve Bank of India (RBI), or a corporation established under a Central Act which is specifically exempt from income-tax, as per the exemption provisions under the Income-tax Act (corresponding to Section 196 of the Income-tax Act, 1961), subject to submission of a valid self-declaration along with self-attested copies of relevant documentary evidence in support of the claim.	
Any other entity entitled to exemption from TDS	Valid self-attested documentary evidence in support of the entity being entitled to TDS exemption along with a self-attested copy of PAN card should be submitted to the Company.	

- C. In the event that a shareholder (individual or non-individual) obtains a certificate under Section 395 of the Income-tax Act, 2025 for deduction of tax at a lower rate, the Company shall deduct tax at the rate specified in such certificate. A self-attested copy of the valid certificate must be submitted.

## II. FOR NON-RESIDENT SHAREHOLDERS

The applicable rate of TDS for non-resident shareholders are given below :

Further, Taxes are required to be withheld in accordance with the provisions of Section 393 of the Income tax Act, 2025 at the applicable rates in force. As per the relevant provisions of Section 393 of the said Act, the withholding tax shall be at the rate of 20% (plus applicable surcharge and cess) on the amount of Dividend payable to them. In case of FII/FPIs, the withholding tax shall be as per the rates specified in 196D of the Act respectively plus applicable surcharge and cess on the amount of Dividend payable to them. However, as per Section 159 of the Income tax Act, the non-resident shareholder has the option to be governed by the provisions of the Double Tax Avoidance Agreement (DTAA) between India and the country of tax residence of the shareholder, if they are more beneficial to them. For this purpose, i.e. to avail the Tax Treaty benefits, the non- resident shareholder will have to provide the following:

- In case of FPI / FII, copy of SEBI registration certificate;
- Self-attested true copy of Tax Residency Certificate (“TRC”) obtained from the tax authorities of the country of which the shareholder is resident for the Financial Year 2025-26;
- Self declaration in Form 41 [Click Here](#) to download Form 41)
- Self-attested true copy of the PAN Card if allotted by the Indian Income Tax authorities;
- Self-declaration in the format given below, certifying the following points:

- i. Shareholder is and will continue to remain a tax resident of the country of its residence during the Financial Year 2025-26;
- ii. Shareholder is eligible to claim the beneficial DTAA rate for the purposes of tax withholding on dividend declared by the Company;
- iii. Shareholder has no reason to believe that its claim for the benefits of the DTAA is impaired in any manner;
- iv. Shareholder does not have a taxable presence or a Permanent Establishment (PE) in India during the Financial Year 2025-26. In any case, the amounts paid/payable to the Shareholder are not attributable or effectively connected to the PE or fixed base, if any, which may have got constituted otherwise;
- v. Shareholder is the ultimate beneficial owner of its shareholding in the Company and dividend receivable from the Company; and
- vi. Self-declaration by the shareholder regarding the satisfaction of the Place of Effective Management (POEM), principal purpose test, GAAR, Simplified Limitation of Benefit test (wherever applicable), as regards the eligibility to claim recourse to concerned Double Taxation Avoidance Agreements.
- vii. In case of shareholder being tax resident of Singapore, please furnish the letter issued by the competent authority or any other evidence demonstrating the non-applicability of Article 24 - Limitation of Relief under India-Singapore DTAA.

Please note that the Company is not obligated to apply the beneficial DTAA rates at the time of tax deduction/withholding on dividend amounts. Application of beneficial DTAA rate shall depend upon the completeness and satisfactory review by the Company, of the documents submitted by the non-Resident shareholder.

Shareholders who are exempted from TDS provisions through any circular or notification may provide documentary evidence in relation to the same, to enable the Company in applying the appropriate TDS on dividend payment to such shareholder.

Kindly note that the aforementioned documents are required to be submitted on or before 20<sup>th</sup> May 2026 to enable the Company to determine and deduct appropriate TDS/ withholding tax rate. No communication on the tax determination/deduction shall be entertained post 20<sup>th</sup> May 2026. It may be further noted that in case the tax on said dividend is deducted at a higher rate in absence of receipt of the aforementioned details/documents from you or incomplete documents, there would still be an option available with you to file the return of income and claim an appropriate refund, if eligible.

The above referred documents submitted by you will be verified by us and we will consider the same while deducting the appropriate taxes, if any, provided that these documents are in accordance with the provisions of the Act.

**Notes:**

1. All the above referred tax rates will be enhanced by surcharge and cess, wherever applicable.
2. Shareholders holding Ordinary shares under multiple accounts under different status/ category and single PAN, may note that, higher of the tax as applicable to the status in which shares held under a PAN will be considered on their entire holding in different accounts.
3. For all self-attested documents, Shareholders must mention on the document "certified true copy of the original". For all documents being submitted by the Shareholder, the Shareholder undertakes to send the original document(s) on the request by the Company.
4. Above communication on TDS sets out the provisions of law in a summary manner only and does not purport to be a complete analysis or listing of all potential tax consequences. Shareholders should consult with their own tax advisors for the tax provisions that may be applicable to them.
5. We shall arrange to email the soft copy of TDS certificate at your registered email ID in due course, post payment of the dividend.
6. It may be further noted that in case the tax on dividend is deducted at a higher rate in absence of receipt of the aforementioned details/documents, there would still be an option available with the shareholder to file the return of income and claim an appropriate refund, if eligible. No claim shall lie against the Company for such higher taxes deducted.
7. In the event of any income tax demand (including interest, penalty, etc.) arising from any misrepresentation, inaccuracy or omission of information provided / to be provided by the Shareholder(s), such Shareholder(s) will be responsible to indemnify the Company and also, provide the Company with all information / documents and co-operation in any appellate proceedings.
8. Shareholders holding shares in dematerialized mode, are requested to update their records such as tax residential status, Permanent Account Number (PAN), registered email addresses, mobile numbers, bank account details and other details with their relevant depositories

through their depository participants. Shareholders holding shares in physical mode are requested to contact the Company's registrar and share transfer agent KFin Technologies Limited at [einward.ris@kfintech.com](mailto:einward.ris@kfintech.com) for updating the above-mentioned details. The Company is obligated to deduct tax at source (TDS) based on the records available with RTA and no request will be entertained for revision of TDS return.

Incomplete and/or unsigned forms, declarations and documents will not be considered by the Company for granting any exemption.
