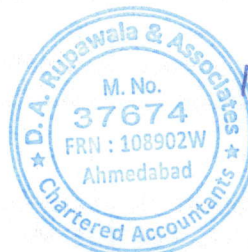
The Notice dated August 10, 2026 of AGM of the company along with the statement setting out material facts u/s 102 of the Act, if any, were sent to the Shareholders in respect of the below mention resolutions to be passed at the said AGM of the company held on September 17, 2026 at 11.30 a.m. through Video Conferencing ("VC") / Other Audio Visual Means ("OAVM").

The Company has availed remote e-voting facility as well as e-voting facility at the Annual General Meeting offered by National Securities Depository Limited (NSDL) for conducting electronic voting by the shareholders of the company.

The shareholders of the company holding shares as on the cut-off date of September 10, 2026, were entitled to vote on the proposed resolutions (containing ordinary and special business items) as set out at item nos. 1 to 3 in the Notice of the AGM.

The voting period for remote e-voting commenced on Monday, September 14, 2026 at 9.00 a.m. and ended on Wednesday, September 16, 2026 at 5.00 p.m. and the NSDL remote e-voting platform was blocked thereafter.

The Company has also provided e-voting facility to the shareholders present at the 40th Annual General Meeting through VC/OAVM, who did not cast their vote earlier through remote e-voting facility.

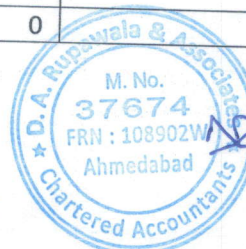

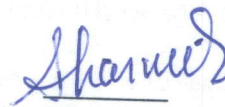

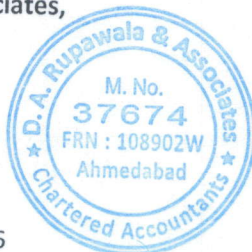
