We wish to inform that Adani Road Transport Limited ("**ARTL**"), a wholly owned subsidiary of the Company and Adani Road GRICL Limited ("**GRICL**"), a wholly owned subsidiary of ARTL and step down subsidiary of the Company, have acquired 99.99% and 0.01% stake respectively, in Path Highway LLP ("**PATH**") from Prakash Asphaltting and Tolls Highway (India) Limited ("**Seller 1**") and Mrs. Neeti Agarwal ("**Seller 2**").

Intimation regarding the aforesaid acquisition was received by the Company on 13th August, 2026 at 12:58 PM.

Prior to above acquisition, ARTL and PATH were holding 74%:25.99% stake in Mancherial Repallewada Road Limited ("**MRRL**"); Suryapet Khammam Road Limited ("**SKRL**") and Bilaspur Pathrapali Road Limited ("**BPRL**"). Consequent to the above acquisition, ARTL will hold 99.99% shareholding in MRRL, SKRL and BPRL.
