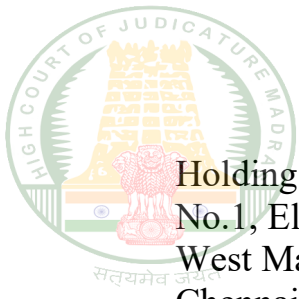

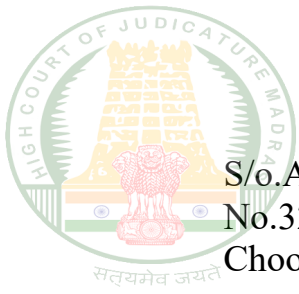

COMMON ORDER

These applications have been filed by the applicants/third parties seeking revocation of the order dated 21.11.2023 passed in O.P.No.20 of 2023.

2.During the pendency of the applications, the parties were referred to the Tamil Nadu Mediation and Conciliation Centre. The Mediation Report records that the parties have amicably settled their disputes. A Settlement Agreement dated 30.06.2026, signed by the parties and their respective learned counsel, has



been forwarded along with the report.

3. Under the Settlement Agreement, the applicants have agreed to receive a total sum of Rs.1,05,00,000/- in full and final settlement. A sum of Rs.10,00,000/- has been paid at the time of execution of the agreement. The first respondent has agreed to pay the balance sum of Rs.95,00,000/- within four months from the date of this order. The agreement further provides that, in the event of default in payment of the balance amount within the stipulated period, the applicants shall be entitled to seek revival of these applications.

4. The parties and their respective learned counsel confirm the settlement and request that the applications be disposed of in terms thereof. The Settlement Agreement dated 30.06.2026 is taken on record and shall form part of this order.

5. Accordingly, the applications in **A.Nos.6364 and 6365 of 2025 are disposed of in terms of the Settlement Agreement dated 30.06.2026**. The parties shall comply with their respective obligations under the Settlement Agreement.

6. O.P.No.20 of 2023 has already been disposed of by the order dated 21.11.2023. The said order is not set aside or modified by this order and shall remain undisturbed. There shall be no order as to costs.
