O R D E R

1. Leave granted.

2. The appellant challenges the judgment/order dated 25.07.2025 in LPA Nos.147/2011 & 144/2011 passed by the High Court of Judicature at Bombay.

3. We have heard Mr. C.U. Singh, learned senior counsel appearing for the appellant, Mr. Prashant S. Kenjale, learned counsel, and Mr. Ivo M.S. Dcosta, learned counsel, appearing for the respondents.

4. I.A. No.295349/2025 seeking deletion of the respondents from the array of parties is allowed. The Registry is directed to amend the cause title accordingly.

5. Having heard learned counsel for the parties and perused the material available on record, we are of the considered view that no interference is warranted with the impugned judgment/order, save and except that the respondents/employees shall be entitled to 40% of the wages as fixed/determined by the Tribunal. Ordered accordingly.

6. Let the amount be disbursed to the respondents/employees directly into their bank accounts within a period of six (06) weeks from today, failing which, the said amount would attract interest at the rate of 6% (six percent) per annum. The particulars of the bank accounts of the respondents/employees be provided by the learned counsel for the respondents to the learned counsel for the petitioner forthwith.

7. Accordingly, the appeals are disposed of as being partly allowed.

8. Pending application(s), if any, shall also stand disposed of.
