Under the impugned order, High Court had directed the respondent State of Karnataka to reconsider the entire issue in the light of observations made in the order and take appropriate decision to provide equal opportunity to Second Division Assistant (SDA) and Village Accountant (VA) in the matter of promotion to the post of First Division Assistant (FDA) and First Division Revenue Inspector (FDRI).
2. State of Karnataka appearing as Respondent No. 162 has filed counter affidavit annexing a notification dated 27.05.2026 enacting Karnataka State Revenue Services (Cadre and Recruitment) Rules, 2026, in compliance with the direction issued by the High Court.
3. In view of the above, the Special Leave Petition has been rendered infructuous.
