The instant application has been filed by the applicants/claimants praying for withdrawal of the 50% of the awarded amount deposited by the appellant before the Registry of this Court in compliance of the order dated 14.07.2026 passed in I.A(Civil) 165/2025.

Heard the learned counsel for the applicants/claimants Mr. Pfosekho Pfotte.

Learned counsel for the applicants/claimants submits that while disposing I.A(Civil) 165/2025, this Court vide order dated 14.07.2026 had directed the appellants to deposit 50% of the awarded amount before the Registry of this Court within 6 (six) weeks from the date of the order. The learned counsel states that in compliance thereof, the appellants have deposited the said 50% of the awarded amount i.e Rs.12,71,362/- vide Cheque No.006469 on 17.08.2026. The learned counsel submits that the applicants/claimants are undergoing severe financial hardship and therefore prays for allowing them to withdraw the 50% of the awarded amount.

The learned counsel Ms. Ayala is present for the respondents/appellants and has no objection.

Accordingly, this application is allowed.

Registry shall allow the counsel Mr. Pfosekho Pfotte to withdraw the deposited amount on behalf of the applicants/claimant Nos. 1,2,3,4 and 5 as the counsel has been duly authorised vide authorization letter dated 19.08.2026.

I.A stands disposed of.
