**JUDGEMENT**

1. The applicant has filed the present petition seeking following prayers:

- a. *Grant immediate interim relief to prevent any further degradation of the proceedings, ensuring that the sanctity of this judicial process is maintained.*
- b. *Direct a comprehensive investigation into the affidavits submitted by Respondents No. 3, 4, and adopted by Respondent No. 1, 2, 8, 9,10,11 to ascertain whether these statements are intentionally contradictory, misleading, or false with the specific aim to deceive this Hon'ble Tribunal, divert attention from unlawful activities, misrepresent legitimate presence and ownership, evade financial obligations with regard to Applicant 1's lands, achieve unjust enrichment, and deliberately cause delay in proceedings, thereby allowing for the continued unauthorized usage of the Madhapar agricultural lands to the detriment of Applicant 1.*
- c. *Issue an immediate injunction restraining Respondent No. 1 and any associated parties from unauthorized non-agricultural utilization of the Madhapar lands until the pendency of IA41/2022.*
- d. *Subject to verification of the aforementioned allegations, initiate consolidated proceedings against Respondents for contempt of court pursuant to the Contempt of Courts Act,*

1971, and for perjury in line with the relevant sections of the Indian Penal Code, treating both as a singular judicial action to address the compound violations of law and procedural integrity.

- e. Award costs, legal or otherwise, incurred by the applicants due to the delays and complications engendered by the aforementioned misleading false statements.
- f. Grant any other relief that this Tribunal may deem fit and necessary in the interest of justice

In view of the order passed in CP No. 114 of 2018, this contempt petition becomes infructuous.
