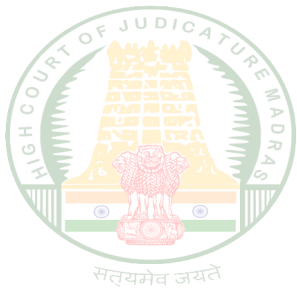
PRAYER : Writ Petition, filed under Article 226 of the Constitution of India, praying this court to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned rejection order passed by the 2nd respondent herein, in PaSeeThu/E1/388/2022 18.10.2022, and quash the same as arbitrary and consequently issue direction to the 1st and 2nd Respondent herein to revise petitioners present pay of Rs.19,300/- and scale of pay and to fix petitioners basic pay at Rs.42,200/- on par with his junior drivers and the drivers who joined the Tamil Nadu State Transport Corporation as drivers along with the petitioner duly granting notional continuity of service notional fixation of pay and notional increments from the date of dismissal from the service and date of reinstatement into service, that is from the period 27.04.2001 to 04.09.2012 for the purpose of pension, gratuity, contribution to provident fund and other retirement benefits with reference to Award dated 24.09.2014 made in ID No.29/2013 by the learned Presiding Officer, Labour Court, Madurai and petitioner's representations dated 27.02.2020 and 03.09.2020.

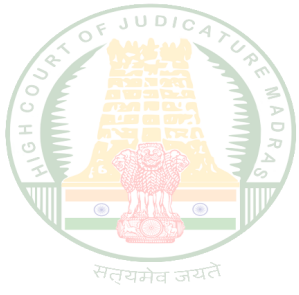

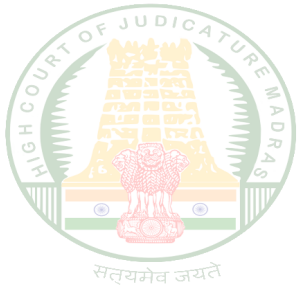
