Subject: Disclosure under Regulation 30 read with part A of Schedule III of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

In continuation of our earlier intimation dated February 05, 2025, wherein the Company had informed the Stock Exchange regarding the Order dated January 31, 2025 passed by the Hon'ble Supreme Court of India in relation to the proceedings concerning The Svadeshi Mills Company Limited ("Svadeshi"), we wish to inform you that the Hon'ble High Court of Judicature at Bombay has pronounced its Order dated September 02, 2026 (Order downloaded/received on September 4, 2026) in the matter relating to the revival of Svadeshi. The Company has applied for certified true copy of the Order.

Vide the said Order, the Hon'ble High Court has, inter alia, set aside the Judgment dated February 23, 2026 read with Order dated February 27, 2026 passed by the Learned Single Judge and allowed the appeal concerning the revival of Svadeshi, along with disposal of the connected appeals, including the appeal filed by the Company.

The Hon'ble High Court has accepted the revival proposal in respect of Svadeshi and observed that the revival would be conducive and not detrimental to commercial morality and the interests of the public at large. The Company holds approximately 22.70% equity shareholding in Svadeshi and is presently evaluating the implications of the Judgment.

The disclosure is being made with a delay, which was inadvertent and occurred due to the time taken for internal legal review of the Judgment and assessment of its implications and applicable disclosure requirements under Regulation 30 of the SEBI (LODR) Regulations, 2015.

The details of the above order, as required under Clause 20 of Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 read with SEBI Master Circular No. HO/49/14/14(7)2025-CFD-POD2/1/3762/2026 dated January 30, 2026 is enclosed as Annexure A.
