DIRECTOR'S REPORT

To

The Members,

Your Directors have the pleasure to present the 41st Annual Report of Apex Capital and Finance Limited ("**Company**") for the year ended March 31, 2026 along with the audited financial statements for the year ended March 31, 2026.

BACKGROUND:

Your Company was incorporated under the Companies Act, 1956 on June 18, 1985. The Company is a Non-Deposit Accepting Non-Banking Finance Company ("NBFC"), holding "Certificate of Registration No. B.14.00473 from the Reserve Bank of India ("RBI"). The Equity Shares of the Company are currently listed with BSE Limited (BSE) with effect from 23rd March, 2018.

STATE OF THE COMPANY'S AFFAIRS:

Your Company continues to take effective steps in broad-based range of activities as the Company is a NBFC and the main business of the Company is to make loans and advances.

BUSINESS PERFORMANCE:

The Company is a Non-Banking Financial Company registered with Reserve Bank of India. There has been no change in nature of the business of the Company, during the period under review.

The total revenue of the Company for the year ended on March 31, 2026 is Rs. 7,13,36,107/- as against Rs. 2,77,65,457/- for the previous year. The Net Profit for the financial year ended March 31, 2026 stood at Rs. 3,73,25,461/- as against Net Profit of Rs. 52,51,339/- in previous year.

TRANSFER TO STATUTORY RESERVE:

As per the provisions of Section 45-IC of the Reserve Bank of India Act, 1934, the Company is required to transfer an amount not less than twenty percent of its net profit every year to statutory reserve. Therefore, the Company has transferred an amount of Rs. 74,65,092/- being twenty percent of the net profits of the Company for the financial year ended on March 31, 2026 to Statutory Reserve.

DIVIDEND:

In order to conserve the resources of the Company for the future growth, the Directors of the Company do not recommend any dividend to the shareholders for the Financial Year 2025-26.

MATERIAL CHANGES AND COMMITMENTS, IF ANY, AFFECTING THE FINANCIAL POSITION OF THE COMPANY:

In the opinion of the Board, there has been no material changes and commitments, if any, affecting the financial position of the Company which have occurred between the end of the financial year of the Company to which the financial statements relate and the date of this Report.

CONVERSION OF SHARE WARRANTS AND CONSEQUENT INCREASE IN PAID UP SHARE CAPITAL OF THE COMPANY:

The Board of Directors of the Company wishes to inform you that, pursuant to the approval granted by the shareholders in their Extra-Ordinary General Meeting held on 29 July, 2024, the Securities Committee of the Board, in its meeting held on 09th December, 2024, had allotted 76,00,000 (Seventy-Six Lakh) Convertible Share Warrants of Rs. 10/- each for cash at an issue price of Rs. 125/- (including premium of Rs. 115/-) per warrant to raise the said funds of Rs. 95,00,00,000 (Rupees Ninety-Five Crore Only), to be received in 18 months from the date of allotment as per SEBI ICDR Guidelines. On receipt of the said funds of Rs. 95,00,00,000 (Rupees Ninety-Five Crore Only) and on receipt of the request from the warrant holders, the Securities Committee of the Board, in its meeting held on 11th May, 2026, has allotted 76,00,000 (Seventy-Six Lakh) equity shares of Rs. 10/- each to the Warrant Holders on conversion of their Share Warrants into Equity Shares of the Company. Consequently, the Paid up Share Capital of the Company has been increased from Rs. 5,91,99,780/- to Rs. 13,51,99,780/-.

SUBSIDIARIES & ASSOCIATES:

As at March 31, 2026, your Company do not have any subsidiary and associate company. During the year under review, neither any company becomes subsidiary/associate nor ceased to be a subsidiary/associate of your company.

RISK MANAGEMENT:

Risk Management Committee has been constituted by the Board in their meeting held on 26.05.2026 which identifies Risk activities, communicates and manages risks across the organization. It also ensures that responsibilities have been appropriately delegated for risk management. Key Risks and mitigation measures are provided in Management Discussion and Analysis Report annexed to the Annual Report.

INTERNAL FINANCIAL CONTROL SYSTEM:

The Company has a robust and well embedded system of internal financial controls. This ensures that all assets are safeguarded and protected against loss from unauthorised use or disposition and all transactions are authorised, recorded and reported correctly. The internal audit plan is also aligned to the business objectives of the Company, which is reviewed and approved by the Audit Committee.

Further, the Audit Committee monitors the adequacy and effectiveness of your Company's internal control framework. Significant audit observations are followed-up and the actions taken are reported to the Audit Committee. The internal control system is commensurate with the nature, size and complexities of operations of your Company.

VIGIL MECHANISM:

The Company believes in conduct of its affairs in a fair and transparent manner by adopting highest standards of professionalism, honesty, integrity and ethical behaviour. The Company is committed to develop a culture in which every employee feels free to raise concerns about any poor or unacceptable practice and misconduct. In order to maintain the standards, the Company has adopted a Whistle Blower Policy, to provide a framework to promote responsible and secure whistle blowing. The Board of Directors of your company has adopted the Vigil Mechanism and/or Whistle Blower Policy in compliance with Section 177(9) of the Act read with Regulation 22 of SEBI Listing Regulations.

His details as required under Secretarial Standard-2 are provided in the Annexure-A to the Notice of the ensuing Annual General Meeting of the Company. He is not disqualified to be appointed as Director of the Company as specified under Section 164 of the Companies Act, 2013. The Board recommends his reappointment.
- In terms of provisions of Section 161(1) of the Companies Act, 2013, Mr. Surinder Singh Kohli (DIN: 00169907) has been appointed as Director (Independent) in Non-Executive category w.e.f. 10th July 2025 for a period of 5 Years from the date of appointment by the shareholders in the Annual General Meeting held on 26.09.2025.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT**I. COMPANY OVERVIEW:**

Apex Capital and Finance Limited (the “Company”) is an NBFC and is engaged in the business of providing various financial services, such as loans, advances, investments, leasing, hire-purchase and more. The Company is regulated by the Reserve Bank of India (RBI) under the framework of the RBI Act, 1934. The main objective of the Company is to finance various individuals, corporates, firms, societies and Industrial enterprises by way of making loans and advances in India and to carry out all such activities as may be ancillary to the achievement of main objectives of the Company.

I. INDUSTRY STRUCTURE AND DEVELOPMENT**Overview of the Financial Services Landscape**

The Indian financial ecosystem continued to display robust health and resilience during FY 2025–26, supported by positive macroeconomic conditions, multi-year low inflation, and real GDP expansion exceeding 8%. Non-Banking Financial Companies (NBFCs) strengthened their position as vital credit intermediaries within the domestic economy, accounting for approximately a quarter of total Scheduled Commercial Bank (SCB) credit. Consolidated balance sheets across the sector maintained a double-digit expansion trajectory.

Sectoral Credit Growth and Asset Quality

- Credit Offtake: The sector recorded strong double-digit credit growth of outperforming broader systemic expansion across retail, MSME, vehicle, and affordable housing segments.
- Asset Quality Metrics: Systemic Gross Non-Performing Assets (GNPA) touched historic multi-decadal lows in FY 2025-26, driven by sustained efforts in stress resolution and implementation of stringent credit underwriting standards.

Regulatory Framework & Governance

- Under the Reserve Bank of India’s (RBI) Scale-Based Regulation (SBR) framework, supervisory focus remained centered on credit concentration, digital lending practices, cybersecurity standards, and risk-weights on unsecured consumer credit. Regulatory directives on co-lending mechanisms, higher risk-weights for personal loans, and draft guidelines on Expected Credit Loss (ECL) frameworks have enhanced corporate governance and balance sheet resilience across listed entities.

2. OPPORTUNITIES AND THREATS**OPPORTUNITIES****1. Digital Infrastructure & Public Tech Platforms:**

- Leveraging Public Tech Platforms—including the Unified Logistics Interface Platform (ULIP) and Account Aggregator networks—enables NBFCs to underwrite prime and below-prime borrowers with high accuracy and reduced customer acquisition costs.
- Innovative low-ticket financing models in Tier-2 and lower-tier cities expand market presence across underserved customer segments.

2. MSME Credit Demand:

- The MSME sector registered outsized credit growth, benefiting from cash-flow-based underwriting, customized loan offerings, and doorstep delivery models offered by specialized NBFCs.

3. Co-Lending Models (CLM):

- Strategic bank-NBFC co-lending partnerships enable entities to combine broad distribution channels with lower bank cost of capital, securing fee-based earnings while optimizing risk-weighted assets.

THREATS AND KEY RISK FACTORS

1. NIM Compression and Bank Borrowing Costs:

- Caution from banks in lending to NBFCs and persistent competition for deposits have maintained elevated wholesale funding costs. Net Interest Margin (NIM) pressures and marginal upticks in credit costs pose headwinds for entities dependent on bank lines.

2. Asset Quality Stress in Specific Pockets:

- Unsecured retail loans and microfinance segments show emerging stress, with NBFC-MFI GNPA's. The RBI has placed personal loan exposures under increased surveillance.

3. External and Operational Risks:

- Downside risks stemming from global growth deceleration, tariff changes, and volatile crude oil prices could affect domestic trade activity. Additionally, operational risks related to high-value digital frauds require ongoing infrastructure investments.

3. OUTLOOK

SECTORAL TRAJECTORY

The outlook for Indian listed NBFCs as of March 31, 2026, remains Stable. Systemic credit expansion is anchored by strong domestic consumption, tax rationalization benefits, and steady demand in retail and MSME categories.

STRATEGIC IMPERATIVES

Liability Diversification: NBFCs are rebalancing funding structures through non-convertible debentures (NCDs), commercial papers, and retail term deposits to manage interest-rate sensitivity.

Capital Profile & ECL Transition: Solvency and capital buffers will remain comfortable during the multi-year transition toward the proposed Expected Credit Loss (ECL) framework.

Proactive Risk Mitigation: Focus will remain on maintaining higher Provision Coverage Ratios (PCR), tightening LTV ratios on unsecured loans, and utilizing AI-driven tools for fraud detection and collections.

NBFCs are expected to play a crucial role in the India growth story fuelling formalised credit penetration among the underserved. Policy push, regulatory oversight and digital across the value chain are expected to define the growth of this sector.

Apex Capital and Finance Limited expects to improve its performance in financial year 2026-27. The approach would be to continue with the growth momentum while balancing risk. The Company will continue to invest in strengthening risk management practices; and in maintaining its investment in human resources to consolidate its position as a potential NBFC in India.

RISK MANAGEMENT:

Given the increasing volatility in today's global business environment, we are strengthening our risk management and mitigation framework. We view robust risk management as a cornerstone of good governance and sound business practice, essential for driving long-term organizational success and sustainability.

Embedding risk management into our core strategy demands a structured process encompassing risk assessment, defining risk appetite, continuous monitoring, and regular evaluation. Equally critical is fostering a risk-conscious culture where employees across all levels recognize their role in managing risks and feel empowered to report potential issues early. Ultimately, a strong risk management framework enhances our resilience and ensures sustained success in an unpredictable market.

II. INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY:

The Company maintains a robust internal control framework tailored to its scale, nature, and operational complexity. This system is structured to drive operational efficiency, safeguard corporate assets, ensure accurate and timely financial reporting, and maintain strict compliance with statutory regulations. To evaluate the strength and effectiveness of these controls, the Company relies on an independent internal audit process that regularly assesses operational systems, processes, and regulatory adherence. Audit findings are thoroughly discussed with Management and presented to the Board's Audit Committee, which reviews the overall adequacy, efficacy, and continuous improvement of the Company's internal control environment.

Note No. 1

1 Corporate Information

Apex Capital and Finance Limited (referred to as "ACFL" or "the Company") is a Non-Deposit Accepting Non-Banking Finance Company (NBFC) registered with Reserve Bank of India (RBI). The Company currently holds a valid Registration Certificate issued by RBI. The original Registration Certificate issued by RBI is B-14.00473 dated May 06, 2002. Further the RBI has issued a fresh Registration Certificate bearing no. B-14.00473 dated June 17, 2019 on change of name of the Company from Apex Home Finance Limited to Apex Capital and Finance Limited. The main business of the Company is lending/advancing of short term and /or long term finance to any individual, firm, company, bodies corporate, corporation, society etc. whether at interest or without interest and with or without security. The Company has its Registered Office at L-3, Green Park Extension, New Delhi 110016.

2 Basis of Preparation

The Financial Statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as per the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time and notified under section 133 of the Companies Act, 2013 (the Act) along with other relevant provisions of the Act and the Master Direction - Non- Banking Financial Company- Systematically important Non-deposit taking and deposit taking Company (Reserve Bank) Directions, 2016 (the NBFC Master Directions) issued by RBI. The Financial Statements have been prepared on a going concern basis and it uses actual basis of accounting except in some cases of significant uncertainties.

The Company generally reports financial assets and financial liabilities on a gross basis in the Balance Sheet. They are reported net only when Ind AS specifically permits the same or it has an unconditional legally enforceable right to offset the amounts without being contingent on a future event. The Company prepare its Financial Statement in order of Liquidity.

3 Significant Accounting Policies

A Financial Instruments

A Financial Instrument is defined as a Contract that gives rise to a financial asset and a financial liability or Equity instrument of another entity. Trade receivables and payables, loan receivables, investments in securities, debt securities and other borrowings, preferential and equity capital etc. are some example of financial instruments.

All Financial Instruments are recognised on the date when the Company becomes party to the contractual provisions of the Financial instruments. For tradable securities, the Company recognises the financial instruments on settlement date.

- i Financial assets include Cash, or an equity instrument of another entity, or a contractual right to receive cash or another financial assets from another entity. The Company derecognises a financial assets when:
 - > The right to receive cash flows from the asset have expired, or
 - > The Company has transferred its right to receive cash flows from the asset or has assumed an obligation to pay the received cash flows in full without material delay to a third party under an assignment arrangement and the Company has transferred substantially all the risks and rewards of the assets. Once the asset is derecognised, the Company does not have any continuing involvement in the same.
 - > The Financial assets are written off in full , when there is no realistic prospect of recovery

- ii Financial liabilities include liabilities that represent a contractual obligation to deliver cash or another financial assets to another entity or a contract that may or will be settled in the entities own equity instruments.

All financial liabilities are recognised initially at fair value and, in the case of borrowings and payables, net of directly attributable transaction costs. After initial recognition, all financial liabilities are subsequently measured at amortised cost by using the EIR. Any gain or losses arising on derecognition of liabilities are recognised in the statement of profit & loss.

The Company derecognises a financial liability when the obligation under the liability is discharged, cancelled or expired.

B Use of Estimates

The preparation of Financial Statements in conformity with Ind AS requires the Management to make estimates and assumptions that affect the reported balances of assets and liabilities and the disclosures of contingent assets and liabilities on the date of Financial Statements and the reported income and expenses during the year. Although estimates are based on management knowledge & skill of financial market events and actions, the actual result could differ from those estimates and revisions if any, are recognised in the current & future periods.

C Property, Plant and Equipment

Property, Plant & Equipment are stated at cost, less accumulated depreciation and impairment losses, if any. Cost comprises the purchase price and any attributable cost of bringing the assets to its working condition for its intended use. Any trade discounts and rebates are deducted in arriving at the purchase prices.

Property, Plant and Equipment are derecognised from financial statement, either on disposal or when no economic benefits are expected its use or disposal. The gain or loss arising from disposal of property, plant and equipment are determined by comparing the proceeds from disposal with the carrying amount of Property, Plant and Equipment recognised in the statement of profit and loss account in the year of occurrence.

Subsequent expenditure is capitalised only if it is probable that the future economic benefits associated with the expenditure will flow to the Company in the succeeding years.

D Depreciation on Property, Plant & Equipment

Depreciation on Property, Plant & Equipment has been provided to the extent of depreciable amount on the basis of straight line method (SLM). Depreciation is provided based on useful life of the assets as prescribed in schedule III to the Companies Act, 2013. Depreciation on the Property, Plant & Equipment is provided from the date the said asset is put to use for its intended use.

E Impairment of Non-Financial Assets

The Company assesses at each balance sheet date whether there is any indication that an asset may be impaired. If any such indication exists, the Company estimates the recoverable amount of the asset, and such recoverable amount of the assets or the recoverable amount of the cash generating unit to which the asset belongs is less than its carrying amount, the carrying amount is reduced to its recoverable amount and the reduction is treated as an impairment loss and is recognised in the Statement of Profit and Loss. On the balance sheet date, if there is any indication that previously assessed impairment loss no longer exists, the recoverable amount is reassessed and the asset is reflected at the recoverable amount subject to maximum of depreciated historical cost and accordingly reversed in the Statement

of Profit and Loss.

F Investments

On initial recognition, all investments are measured at cost. The cost comprises purchase price and directly attributable acquisition charges. If an investment is acquired, or partly acquired, by the issue of shares or other securities, the acquisition cost is the fair value of the securities issued.

Current Investment are carried at cost or market value whichever is less. Long term investment are carried at cost. However, provision for diminution in value is made to recognise a decline other than temporary in the value of long term Investments.

On disposal of an investment, the difference between its carrying amount and net disposal proceeds is charged or credited to the statement of profit and loss.

G Loans and Advances

Loans and advances are stated at the amount advanced, as reduced by the amounts received up to the Balance sheet date.

H Cash and cash equivalent

Cash and Cash equivalents for the purpose of Cash Flow Statement comprise cash at bank and in hand and short term investment with an original maturity of One year or less.

I Taxes

Tax expenses comprises of Current and Deferred Tax.

Current income tax is the amount of tax payable as determined in advance in accordance with the provisions of the Income Tax Act, 1961 and other relevant tax laws and tax rates in force.

Deferred tax is provided using the Balance Sheet approach on temporary differences between the tax bases of assets & liabilities and their carrying amounts for financial reporting purposes at the reporting date. Deferred tax liabilities are recognised for all temporary differences and deferred tax assets are recognised for deductible temporary differences to the extent that it is probable that taxable profits will be available against which the deductible temporary differences can be utilised. The deferred tax asset is recognised and carried forward only to the extent that there is a reasonable certainty that the asset will be realised in future.

J Employee Benefits

The employees either avail their leave during a particular financial year or are encashed in the same financial year and therefore the balance is not carried forward.

Expenses in respect of other short term benefit is recognised on the basis of amount paid or payable for the period during which services are rendered by the employee.

K Earning per share

Basic Earning per share are calculated by dividing the net profit or loss for the year attributable to equity shareholders by the weighted average number of equity shares outstanding during the year. The weighted average number of equity shares outstanding during the year is adjusted for events of bonus issue.

For the purpose of calculating diluted earnings per share, the net profit or loss for the year attributable to equity shareholders and the weighted average number of shares outstanding

during the year are adjusted for the effects of all dilutive potential equity shares.

L Provisions and Contingent Liabilities

A Provision is recognised when the Company has a present obligation as a result of past event, it is probable that an outflow of resources will be required to settle the obligation, in respect of which a reliable estimate can be made. Provisions are not discounted to its present value and are determined based on the best estimate required to settle the obligation at the Balance Sheet date and adjusted to reflect the current best estimates

A contingent liability is a possible obligation that arises from past events whose existence will be confirmed by the occurrence or non occurrence of one or more uncertain future events beyond the control of the Company or a present obligation that is not recognised because it is not probable that an outflow of resources will be required to settle the obligation. A contingent liability also arises in extremely rare cases where there is a liability that can not be measured reliably. The Company does not recognise a contingent liability but disclose its existence in the financial statements.

Contingent assets are not recognised in the Financial Statements

M Revenue Recognition

I Interest Income

Interest Income is recognised on accrual System of accounting on a time proportion basis using Effective Interest Rate (EIR) on Financial Assets subsequently measured at amortised cost or fair market value through other comprehensive income. The Company recognises Interest Income by applying the EIR to the Gross Carrying amount of Financial assets other than credit impaired assets. In case of Credit Impaired Financial assets, the Company recognises interest income on the amortised cost net of impairment loss of the Financial assets at EIR. If the Financial asset is no longer credit - impaired, the Company reverts to calculating interest income on a gross basis.

The Company recognises income on recoveries of Financial assets written off on realisation or when the right to receive the same without any uncertainties of recovery is established.
