O R D E R

1. We heard Mr. Gopal Sankaranarayanan, the learned senior counsel appearing for the petitioners and Mr. Niranjan Reddy, the learned senior counsel appearing for the respondents.
2. We are of the view that no error, not to speak of any error of law, could be said to have been committed by the High Court in passing the impugned order.
3. It is needless to say that the matter will have to be now heard by the Section 34 Court on its own merits.
4. It shall be open for the parties to raise all contentions available to them in law before the Section 34 Court.
5. In view of the impugned order passed by the High Court under Section 37 of the Act, the matter shall now go back to the Section 34 Court. The same shall stand restored, to be heard on its own merits, expeditiously.
6. In view of the aforesaid, the Special Leave Petition stands disposed of.
7. Pending application(s), if any, shall also stand disposed of.
