Respected Sir/ Ma'am,

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Management of the Company is pleased to inform the stakeholders that, in furtherance of the debt resolution process being undertaken by the Company, the Hon'ble National Company Law Tribunal ("NCLT"), Mumbai Bench, vide its order dated 15th May 2026, has granted an extension of 30 (Thirty) days to the Company for making the balance payment under the approved Scheme.

The balance payment could not be completed within the stipulated timeline due to certain circumstances beyond the control of the Company and not attributable to any default or lapse on the part of the Company.

While considering the application filed by the Company, the Hon'ble NCLT has taken note of the fact that (i) settlements with a majority of the lenders have already been completed, representing approximately 80% of the total lenders (ii) Further, more than 80% payment has been made in accordance with the agreed settlement terms to the balance lender, reflecting the Company's continuous efforts towards effective implementation of the Scheme.

The extension granted by the Hon'ble NCLT will facilitate successful implementation of the approved Scheme and support continuity of the Company's business operations, thereby enabling the Scheme to achieve its intended objectives.
