O R D E R**

1. All the applications for impleadment/intervention are allowed, subject to just exceptions at the time of final hearing.
2. Amended Memo of Parties, in each of the special leave petitions (wherever required), be filed by the petitioners within two weeks from date.
3. Counter affidavits to the special leave petitions may be filed by all the respondents within four weeks.
4. Rejoinder thereto, if any, may be filed by two weeks thereafter.
5. Re-list the special leave petitions in the week commencing 16th November, 2026.
6. Interim order, if any, shall continue till the next date of hearing.
7. It is reported that some of the respondents in all three special leave petitions are common. If notice has already been issued to such of the common respondents, further notice need not be served to them.
