O R D E R

1. Heard the learned counsel appearing for the petitioner.
2. The petitioner is the original borrower. His account came to be declared as a Non-Performing Asset. As a consequence of the same, SARFAESI proceedings were initiated by the Bank. The secured asset was put to auction. The auction has attained finality. The petitioner is dissatisfied with the auction proceedings conducted by the Bank. For this purpose, he instituted a civil suit in the Bombay City Civil Court, however, the plaint was ordered to be returned.
3. Being dissatisfied with the order passed by the Bombay City Civil Court, an appeal has been preferred before the High Court.
4. Let the appeal which has been preferred by the petitioner before the High Court be heard at the earliest.
5. The learned counsel may request the Court concerned to take up this matter.

6. In view of the aforesaid, this Writ Petition is dismissed as not pressed.
