UPON hearing the counsel the Court made the following
O R D E R

1. The petitioner challenges the impugned judgment and order dated 28.01.2026 in LPA Nos.476 and 477 of 2025 passed by the High

Court of Delhi at New Delhi.

2. Delay condoned.

3. We have heard learned counsel for the parties.

4. As prayed by Mr. Vikramjit Banerjee, learned Additional Solicitor General appearing for the petitioner, we implead University Grants Commission as a party-respondent. The particulars of the newly impleaded party-respondent are as follows:

7. Mr. Parmanand Gaur, learned counsel, accepts notice on behalf of newly impleaded respondent/University Grants Commission. Hence, the formal service of notice on the said respondent stands waived.

8. The petitioner to serve a copy of the present petition to the learned counsel for newly impleaded respondent/University Grants Commission immediately.

9. Let counter affidavit be filed by respondent nos.1 to 5 within three (03) weeks. Rejoinder affidavit thereto, if any, be filed before the next date of listing.

10. In the notice itself, let it be mentioned that newly impleaded respondent is required to file the counter affidavit and reply to

the interlocutory application(s), if any, before the next date of listing.

11. In the meanwhile, the operation of the impugned judgment and order dated 28.01.2026 in LPA Nos.476 and 477 of 2025, passed by the High Court of Delhi at New Delhi, shall remain stayed.
