Ordinary Business :

1. To consider and adopt the Audited Financial Statements for the Financial Year ended 31st March, 2026, the Reports of the Board of Directors and Auditors thereon;
2. To declare dividend @ 60% (i.e. ₹ 03.00 per share) on equity shares of ₹ 5.00 each for the Financial Year ended 31st March, 2026;
3. To appoint a Director in place of Shri. Varun S. Kabra (DIN 03376617), Director, liable to retire by rotation in terms of Section 152(6) of the Companies Act, 2013 and being eligible, offers himself for reappointment;

Special Business :

4. To consider and if thought fit, to pass, with or without modification(s), the following resolution as a **Special Resolution** :

"RESOLVED THAT in accordance with the provisions of Sections 188, 196, 197, 203, Schedule V of the Companies Act, 2013 (Act) and other applicable provisions of the Act read with Companies (Appointment and Qualification of Directors) Rules, 2014 and Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014, the Company hereby accords its approval and consent to the re-appointment of Shri Varun Satyanarayan Kabra (DIN : 03376617) as Vice -Chairman and Managing Director of the Company for a period of 5 (five) years with effect from 1st August, 2026 to 31st July, 2031 on the terms, conditions and stipulations including remuneration as recommended by the Nomination and Remuneration Committee and approved by the Board which have been detailed in the Explanatory Statement annexed hereto (which shall form part hereof), with a liberty to the Board of Directors of the Company (hereinafter referred to as "the Board" which terms shall be deemed to include Nomination and Remuneration Committee of the Board) to fix, increase, alter or vary from time to time, the terms and conditions of the said appointment and remuneration and/or monetary value of the perquisites as may be agreed upon by the Board of Directors and Shri Varun Satyanarayan Kabra, subject to the same not exceeding at any point of time, the ceiling specified in Schedule V to the said Act, (including any Statutory Modifications or re-enactment thereof for the time being in force) or any amendment and/or modifications that may hereinafter from time to time be made thereto by the Central Government.

NOTES :

1. The Ministry of Corporate Affairs (MCA) inter alia vide its Circular No. 14/2020 dated April 08, 2020, Circular No.17/2020 dated April 13, 2020 and subsequent circulars, the latest being Circular No.03/2025 dated September 22, 2025 (collectively referred to as “MCA Circulars”), has permitted holding of the Annual General Meeting (“AGM”) through Video Conferencing (“VC”) / Other Audio Visual Means (“OAVM”), without the physical presence of the Members at a common venue. In compliance with the provisions of the Companies Act, 2013 (“Act”), SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 (“SEBI Listing Regulations”) and MCA Circulars, the AGM of the Company is being held through VC / OAVM. The deemed venue for the AGM shall be the Registered Office of the Company.
2. Pursuant to the provisions of the Act, although a Member entitled to attend and vote at the AGM is allowed to appoint a proxy to attend and vote on their behalf, the physical attendance of Members has been dispensed with for this AGM. Therefore, the facility for appointing proxies by the Members will not be available for this AGM and consequently, the Attendance Slip and Proxy Form are not annexed to this Notice. However, corporate members are entitled to appoint authorized representatives to attend the AGM through VC/OAVM, participate therein and cast their votes via e-voting.
3. Corporate Members are requested to send to the Company, at its registered office a duly certified copy of Board Resolution authorizing their representative to attend and vote at the AGM.
4. The Members can join the AGM in the VC/OAVM mode 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available for 1000 members on first-come, first-served basis. This will not include large Shareholders (Shareholders holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first-come, first-served basis.

10. Members who would like to express their views or ask questions during the AGM may pre-register themselves as a speaker by sending an email from their registered email address mentioning their name, Demat account number/folio number, mobile number at pbi_sd@kolsitegroup.com before August 18, 2026. Only those Members who have pre-registered themselves as a speaker will be allowed to express their views/ask questions during the AGM. The Company reserves the right to restrict the number of speakers depending on the availability of time for the AGM.

11. Dividend recommended by the Board, if approved by the Members at the Annual General Meeting will be paid to :
 - (i) those persons whose names appear as Beneficial Owners as at the end of business hours on Monday, August 17, 2026 as per the list to be furnished by the National Securities Depository Ltd. (NSDL) and Central Depository Services (India) Ltd. (CDSL) in respect of shares held in demat form, and
 - (ii) to the Members holding shares in physical mode as per Register of Members after giving effect to Transmissions and Transpositions in respect of which request were lodged with the R & T Agent of the Company on or before Monday, August 17, 2026.

13. The Scrutinizer shall, immediately after the conclusion of voting at the general meeting, count the votes cast at the meeting and votes cast through remote e-voting in the presence of at least two witnesses not in the employment of the Company and make, not later than 48 hrs of conclusion of the General Meeting, a consolidated Scrutinizer's report of the total votes cast in favour or against, if any, to the Chairman or a person authorized by him in writing who shall countersign the same.

14. The results declared along with the Scrutinizer's Report shall be placed on the Company's website www.plastiblends.com and on the website of NSDL within 48 hrs of conclusion of the General Meeting and communicated to BSE Limited and National Stock Exchange of India Limited.

GENERAL INFORMATION / GUIDELINES FOR SHAREHOLDERS

16. Brief profile of the Directors proposed to be appointed/ re-appointed at this Annual General Meeting has been furnished in this Annual Report.
17. Members desirous of obtaining any information with regard to accounts are requested to write to the Company Secretary at the Registered Office of the Company, at least 10 days in advance, so as to compile the same.
18. Pursuant to the provisions of Section 124 of the Companies Act, 2013, as amended, all the dividends remaining unclaimed/unpaid for a period of seven years from the date it is lying in the unpaid dividend account, are required to be transferred to the Investor Education and Protection Fund (IEPF) of the Central Government. Accordingly, unclaimed / unpaid dividend for the Financial Year up to 2017-18 have been transferred to the Investor Education and Protection Fund (IEPF) established by Central Government.

Pursuant to the recommendation of the Nomination and Remuneration Committee, the Board of Directors at its meeting held on April 27, 2026, approved re-appointment of Shri Varun Satyanarayan Kabra, as Vice-Chairman and Managing Director of the Company w.e. f. 1st August, 2026.

Shri Varun S. Kabra is a son of Shri Satyanarayan G. Kabra, Chairman & Managing Director of the Company.

Shri Varun S. Kabra, aged 40 years, joined the Company on 13th February 2015, as Director. He was appointed as Director Business Development effective from 21st July, 2016. He was re-designated as Managing Director effective from 10th August, 2018 and elevated to the position of Vice-Chairman on 15th January, 2021. Shri Varun S. Kabra holds B.E. degree in Production Engineering from Mumbai University and M. Sc. in Industrial & Operations Engineering from University of Michigan, Ann Arbor (USA). He has been managing all the affairs of the Company and has steered the Company to its present heights.

His brief resume form part of this Annual Report. This statement, be regarded as disclosure under 36 (3) of SEBI (Listing Obligations and Disclosures Requirements) Regulations, 2015.

The Board is of view that Shri Varun S. Kabra's qualification, knowledge and experience will be of immense benefit and value to the Company and therefore recommends his re-appointment to the Members.

Pursuant to Section 188, 196, 197 Schedule V and other applicable provisions of the Companies Act, 2013 read with Companies (Appointment and Remuneration of Managerial Personnel) Rules, 2014, the appointment of and remuneration payable to Shri Varun S. Kabra is placed before the Members at this Annual General Meeting for their approval.

The Basic Salary is fixed at Rs. 5,00,000/- (Rupees Five Lakh Only) per month, with an annual increment to be decided by the Board at such percentage not exceeding 20% of the basic salary, subject to the same not exceeding at any point of time, the ceiling laid down under the provisions of the Companies Act, 2013 and Schedule thereto.

In addition to the above, he shall be entitled to perquisites restricted to an amount equal to his annual salary as given herein below: -

- (i) Accommodation (Furnished or otherwise) or House Rent Allowance in lieu thereof subject to a ceiling of 50% of above Salary.

- (vi) Provident Fund, Superannuation Fund, Annuity Fund or National Pension System : Company's contribution to Provident Fund, Superannuation Fund, Annuity Fund or National Pension System as per the Schemes of the Company will not be included in the computation of the ceiling on perquisites to the extent these, either singly or put together are not taxable under the Income-Tax Act, 1961.
- (vii) Gratuity : As per rules of the Company.

(viii) Encashment of leave : As per rules of the Company.

For the purpose of gratuity & encashment of leave, the period of service of said appointee shall be considered as service with the Company without any break in service & on a continuous basis.

(ix) Provision of car and telephone at residence for use of Company's business will not be considered as perquisites. However, personal long distance telephone calls and use of car for private purpose shall be billed by the Company to him.

General :

(x) The office of said appointee may be terminated by the Company or the concerned Directors by giving the other three (3) months' prior notice in writing.

(xi) He shall be liable to retire by rotation.

(xii) The terms & conditions set out for re-appointment as above & payment of remuneration herein may be altered & varied by the Board as it may, from time to time, deem fit.

2 Operations

The Board of Directors are pleased to present the key highlights of the Company for the Financial Year 2025-26 are as under :-

- Revenue from operations grew by 1.05 % to ₹ 78,866 Lakhs in FY 25-26 as against ₹ 78,045 Lakhs in FY24-25.
- EBIDTA margin grew by 51 bps to 8.38 % in FY 25-26 from 7.87 % in FY24-25.
- PBT margin grew by 43 bps to 6.19 % in FY 25-26 from 5.76 % in FY24-25.
- PAT margin grew by 37 bps to 4.65 % in FY 25-26 from 4.28 % in FY24-25.

During the year various geopolitical factors led to wide fluctuation in raw material prices and supply chain disruptions. Escalation in West Asia conflict resulted in significant rise in raw material prices. Company had one time marginal gain due to holding minimum inventory. This gain shall not last long and considering the escalated rates, weakening rupee etc, company is actively implementing cost optimization measures to mitigate the resulting risks.

Company also undertook strategic capital expenditure to the extent of Rs. 2,433 Lakhs to strengthen its manufacturing infrastructure and support its long-term growth strategy. Investments were made in expansion of Engineering plastics plant, masterbatch capacity enhancement, laboratory and testing facilities, renewable energy projects and other infrastructure improvements. These initiatives are expected to enhance manufacturing efficiency, improve product quality and consistency, support development of value-added masterbatch solutions, reduce energy cost and reinforce the Company's ability to cater to the evolving requirements of the packaging, automotive, agriculture, consumer goods and infrastructure sectors. The Company believes that these investments will strengthen its competitive position and create sustainable value for all stakeholders.

As on March 31, 2026, the Company has a capital work-in-progress of Rs. 615 Lakhs pertaining to capacity enhancement, which is expected to be completed and commissioned with in the next financial year.

Company continued its commitment towards environmental sustainability by augmenting its captive renewable energy portfolio through the installation of additional 5.2 MW solar power capacity. This initiative is expected to increase the share of renewable energy in the Company's overall power consumption, reduce dependence on conventional sources of electricity and contribute towards lowering its carbon footprint.

Despite the challenges posed by the current business environment, the Company's long-standing commitment to sound governance, financial prudence, and operational excellence continues to underpin its resilience. While the near-term outlook may remain subject to external uncertainties, the Company is focused on strengthening its competitive position, improving efficiencies, and capitalising on emerging opportunities. Supported by its robust business fundamentals, the Company remains cautiously optimistic about its long-term prospects and its ability to deliver sustainable value to all stakeholders.

3 Dividend and Dividend Distribution Policy

The Board of Directors have recommended a dividend of ₹ 3.00 per share i.e. @ 60 % for the year ended 31st March, 2026. The total outflow amounts to ₹ 779.68 Lakhs. (Previous Year the Company has paid dividend of ₹ 2.50 per share @ 50% and the total outflow was ₹ 649.73 Lakhs).

In terms of Regulation 43A of the Securities and Exchange Board of India (Listing Obligations and Disclosures Requirements) Regulations, 2015 ("Listing Regulations") the Board of Directors of the Company has formulated and adopted the Dividend Distribution Policy ('DDP'). The Board of Directors while taking decision for recommendation of the dividend will take guidance from this policy and would ensure to maintain a positive approach to dividend payout plans. MANAGEMENT DISCUSSION AND ANALYSIS

I ECONOMIC OVERVIEW

Global economic overview

During FY 2025-26, the global economy demonstrated moderate resilience despite continuing geopolitical tensions, trade policy uncertainties, inflationary pressures in certain regions, and fluctuations in energy markets. While inflation moderated across several advanced economies compared to the elevated levels witnessed in previous years, monetary policy remained relatively cautious, resulting in a mixed growth environment across major global markets.

According to the International Monetary Fund (IMF), global economic growth is projected at around 3.1% to 3.3% during 2026, supported by gradual stabilization in inflation, improving supply chain conditions, technology-led investments, and resilient domestic demand across several emerging economies. However, geopolitical conflicts, energy price volatility, trade restrictions, and evolving global tariff structures continued to influence business sentiment and investment decisions across industries.

The manufacturing sector witnessed varied trends across regions. While industrial activity showed signs of recovery in select economies, demand conditions remained uneven due to slower consumer spending, elevated financing costs, and uncertainty in global trade flows. The chemicals, petrochemicals, and polymer industries experienced relatively improved supply conditions compared to previous years, although fluctuations in crude oil prices and feedstock costs continued to impact operating margins.

Looking ahead, the global economic environment is expected to remain supported by easing inflationary pressures, gradual normalization of monetary policies, and recovery in industrial demand. However, geopolitical developments, energy market volatility, supply chain disruptions, and evolving environmental regulations may continue to influence business conditions across the global manufacturing landscape.

Indian economic overview

India continued to remain one of the fastest-growing major economies in the world during FY 2025-26, supported by strong domestic demand, robust government capital expenditure, expanding manufacturing activity, and sustained growth across key sectors of the economy. Despite global economic uncertainties, India demonstrated resilience through stable macroeconomic fundamentals, improving infrastructure, rising investments, and a growing consumption-driven economy.

Various multilateral institutions, including the IMF, projected India's economic growth in the range of approximately 6.3% to 6.5%, reinforcing its position among the fastest-growing large economies globally. Growth was supported by strong private consumption, public infrastructure spending, expanding services activity, and continued momentum in manufacturing sectors.

Government initiatives such as Make in India, Production Linked Incentive (PLI) schemes, National Logistics Policy, PM Gati Shakti, and continued infrastructure investments contributed significantly to strengthening India's manufacturing ecosystem. Investments in transportation, logistics networks, industrial corridors, renewable energy, and urban infrastructure continued to enhance industrial competitiveness and attract domestic as well as foreign investments.

At the same time, the industry continued to face challenges arising from fluctuations in crude oil prices, volatility in polymer resin costs, foreign exchange movements, global supply-demand imbalances, and increasing environmental regulations relating to plastic waste management and recycling. The growing regulatory focus on sustainability and circular economy practices has accelerated industry efforts toward recyclable materials, recycled polymer applications, biodegradable solutions, and environmentally responsible manufacturing processes.

The Indian masterbatch industry remains well-positioned for long-term growth, supported by increasing plastics consumption, expansion of downstream processing industries, rising demand for specialty applications, and growing focus on sustainable and value-added solutions. Companies with diversified product portfolios, strong customer relationships, technological capabilities, operational efficiencies, and innovation-led strategies are expected to benefit from the evolving opportunities within the industry landscape.

II. INDUSTRY STRUCTURE AND DEVELOPMENTS

The masterbatch industry forms a critical segment of the plastics value chain and plays an essential role in enhancing the functionality, appearance, processability, and performance characteristics of plastic products. Masterbatches are concentrated mixtures of pigments, additives, fillers, and carrier resins that are incorporated into polymer matrices during manufacturing to impart specific properties such as coloration, UV resistance, flame retardancy, antistatic behavior, antimicrobial protection, processing enhancement, and other performance attributes.

The global masterbatch industry continues to evolve from being primarily a commodity-driven market toward a technology-oriented and application-focused industry. Increasing demand for customized solutions, product differentiation, sustainability, and regulatory compliance has accelerated the adoption of specialty and high-performance masterbatches across multiple end-user industries.

The demand for masterbatches is closely linked to the growth of downstream plastics processing industries. Packaging continues to account for the largest share of consumption, followed by automotive, agriculture, consumer durables, infrastructure, healthcare, electrical and electronics, and textiles.

In India, the masterbatch industry has witnessed consistent growth driven by rising polymer consumption, increasing urbanization, expanding manufacturing activity, and strong demand from packaging and consumer sectors. The industry is characterized by the presence of both organized and unorganized participants. While commodity-grade products continue to face intense competition, the market is increasingly shifting toward value-added and specialized applications where technical expertise, product innovation, quality consistency, and customer support play a significant role in competitive differentiation.

Growing demand for high-performance polymers, specialty compounds, electric vehicle components, renewable energy applications, healthcare products, and sustainable packaging solutions is expected to create new growth avenues for the masterbatch industry over the medium to long term.

III. OPERATIONAL PERFORMANCE

The brief highlights of operations for the Financial Year 2025-26 are as under :-

- Revenue from operations grew by 1.05 % to ₹ 78,866 Lakhs in FY 25-26 as against ₹ 78,045 Lakhs in FY24-25.
- EBITDA margin grew by 51 bps to 8.38 % in FY 25-26 from 7.87 % in FY24-25.
- PBT margin grew by 43 bps to 6.19 % in FY 25-26 from 5.76 % in FY24-25.
- PAT margin grew by 37 bps to 4.65 % in FY 25-26 from 4.28 % in FY24-25.

V. BUSINESS OUTLOOK, OPPORTUNITIES AND THREATS

The outlook for the masterbatch industry remains positive, supported by favorable macroeconomic conditions, expanding industrial activity, increasing polymer consumption, and growing demand for specialized applications across end-user industries.

India's position as one of the fastest-growing major economies, coupled with government initiatives aimed at strengthening domestic manufacturing, is expected to provide sustained growth opportunities for the plastics and polymer processing sectors. Continued investments in infrastructure, logistics, urban development, housing, healthcare, renewable energy, and industrial manufacturing are expected to support demand for plastic products and consequently masterbatch solutions.

The packaging industry is expected to remain a major growth driver due to increasing demand from food processing, pharmaceuticals, personal care products, beverages, and e-commerce sectors. As brand owners focus on product differentiation, visual appeal, functionality, and sustainability, demand for customized color and additive masterbatches is expected to witness healthy growth.

The automotive sector is undergoing a significant transformation driven by lightweighting initiatives, electric vehicle adoption, improved safety standards, and enhanced aesthetic requirements. These developments are expected to generate increased demand for specialized masterbatch products capable of delivering superior performance, durability, and compliance with industry specifications.

The growing use of polymers in agriculture, healthcare, infrastructure, electrical and electronics, renewable energy, and consumer applications is expected to further diversify demand across various segments. At the same time, technological advancements and customer expectations will continue to increase the importance of product innovation, technical support, quality consistency, and operational efficiency.

The Company remains focused on strengthening its product portfolio, expanding customer relationships, improving operational excellence, enhancing sustainability initiatives, and developing innovative solutions that address evolving market requirements. With a diversified customer base, strong manufacturing capabilities, and emphasis on quality and innovation, the Company is well positioned to capitalize on emerging opportunities in the industry.

Masterbatch manufacturers remain exposed to fluctuations in crude oil prices, polymer resin costs, pigment prices, additive costs, and other petrochemical feedstocks, which may impact profitability. The industry faces competition from both organized and unorganized players, resulting in pricing pressures and margin challenges, particularly in commodity product segments. Increasing environmental regulations related to plastics usage, waste management, recycling obligations, and sustainability requirements may necessitate additional investments and operational adjustments. Volatility in currency markets may impact the cost of imported raw materials and influence export competitiveness. Geopolitical tensions, trade restrictions, supply chain disruptions, and economic slowdowns in key markets may affect customer demand and overall industry growth.

Despite these challenges, the long-term fundamentals of the masterbatch industry remain robust. Companies that focus on innovation, customer-centric solutions, sustainability, operational efficiency, and prudent risk management are expected to remain well-positioned to achieve sustainable growth and create long-term value for stakeholders.

VI. RISK AND CONCERNS

Risk management is an integral part of your Company's operational strategy. The Company is committed to managing risks effectively to ensure long-term value creation. Our approach to risk management includes a thorough and ongoing review of business risks, the implementation of mitigating controls, and a structured reporting mechanism. The risk management framework is periodically evaluated by the Board and the Risk Management Committee to ensure its continued effectiveness.

In line with the Companies Act 2013 and SEBI Regulations, the Board has delegated the responsibility of reviewing the Company's risk management system to the Risk Management Committee. Apart from the typical risks associated with business operations, manufacturing, and commercial activities, the key risks and areas of concern identified by the Company are outlined as follows :

a. Operational Issues

The Company has long term raw material supply MOU's and majority suppliers of the Company are regular in nature.

b. Financial Risks :

i) Currency value and interest rate fluctuations

The Company is committed to proactively managing its foreign exchange and interest rate risks to safeguard financial stability. It closely monitors currency fluctuations and implements strategies to mitigate any potential impact on international transactions and profitability. Additionally, the Company manages interest rate risk by maintaining a well-balanced portfolio of debt with varying interest rates and maturities, ensuring minimal exposure to market volatility and effectively managing financing costs.

ii) Credit Risk

The Company faces credit risk through its extended credit terms to customers, which may result in payment delays or defaults. To mitigate this risk, the Company employs a structured approach that includes regular monitoring

of receivables, proactive follow-ups and timely collection actions. Additionally, all domestic and export sales are protected by a receivable insurance policy, providing further security against payment defaults and reducing overall credit exposure.

iii) Liquidity Risk

The Company is exposed to liquidity risk, which arises from the potential inability to meet short-term financial obligations due to insufficient cash flow or limited access to financing. To manage this risk, the Company ensures the availability of adequate liquidity through careful cash flow management, regular forecasting, and maintaining access to credit lines. Additionally, the Company focuses on optimizing working capital by effectively managing inventory, receivables and payables, ensuring sufficient liquidity to meet financial commitments and maintain smooth operations.

c. Strategic risks

Strategic risk arises from factors that could impact the Company's long-term goals or market position. To manage this risk, the Company regularly reviews its strategy, monitors industry trends and adapts to changes in consumer demand and competition, ensuring alignment with its growth objectives and market opportunities.

d. Regulatory risks

The Company is exposed to risks arising from changes in statutes, laws and regulations that could affect its operations. To mitigate these risks, the Company conducts regular reviews of legal compliance and has implemented an enterprise-wide compliance management system. This system effectively tracks and manages both regulatory and internal compliance requirements, ensuring adherence to applicable laws and minimizing potential legal disruptions.

e. Cyber risk

Cyber risk refers to the potential threats posed by data breaches, cyber attacks or system failures that could compromise the Company's operations and sensitive information. To mitigate this risk, the Company has implemented a comprehensive data protection policy, advanced cyber security measures such as encryption and firewalls and robust tools and procedures for storing information across multiple secure locations. These measures ensure that the Company's data remains protected and accessible, even in the event of a cyber incident, safeguarding its operations from cyber threats.

NOTES FORMING PART OF THE STANDALONE FINANCIAL STATEMENTS

Note 1 (A): Company Overview and Material Accounting Policies

Company Overview :

Plastiblends India Limited (hereinafter referred to as “the Company”) is a Public Limited Company incorporated under the Companies Act, 1956, having its registered office at Mumbai, India. The Company has manufacturing facilities at Daman (UT), Roorkee (Uttarakhand) and Palsana (Surat-Gujrat). The Company is engaged into manufacturing of Masterbatches.

Material Accounting Policies:

a) Statement of Compliance:

These financial statements are prepared in accordance with the Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time, the relevant provisions of the Companies Act, 2013 (the Act) and guidelines issued by the Securities and Exchange Board of India (SEBI), as applicable. Accounting policies have been consistently applied except where newly issued accounting standard or revision to existing accounting standards requires changes in the existing accounting policies.

The financial statements were authorized for issue by the Board of Directors of the Company at their meeting held 27th April 2026.

b) Basis of preparation of Accounts:

Basis of Preparation:

The financial statements have been prepared on a historical cost basis, except for the following assets and liabilities:

- i. Certain financial assets and liabilities measured at fair value and classified as fair value through other comprehensive income or fair value through Profit or Loss; and
- ii. Employee's Defined Benefit Plan as per Actuarial Valuation.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date under current market conditions, regardless of whether that price is directly observable or estimated using another valuation technique. In determining the fair market value of an asset or liability if market participants would take those characteristics into account when pricing the asset or liability at the measurement data.

Functional and Presentation Currency:

The financial statements are presented in Indian Rupees, which is the functional currency of the Company and the currency of the primary economic environment in which the Company operates. All amounts have been rounded off to the nearest Lakh except share data, unless otherwise indicated.

Classification of Assets and Liabilities into Current/Non-Current:

The Company has ascertained its operating cycle as twelve months for the purpose of Current/ Non-Current classification of its Assets and Liabilities.

For the purpose of Balance Sheet, an asset is classified as current if:

- i. It is expected to be realised, or is intended to be sold or consumed, in the normal operating cycle; or
- ii. It is held primarily for the purpose of trading; or
- iii. It is expected to realise the asset within twelve months after the reporting period; or
- iv. The asset is a cash or cash equivalent unless it is restricted from being exchanged or used to settle a liability for at least twelve months after the reporting period.

All other assets are classified as non-current.

Similarly, a liability is classified as current if:

- i. It is expected to be settled in the normal operating cycle; or
- ii. It is held primarily for the purpose of trading; or
- iii. It is due to be settled within twelve months after the reporting period; or
- iv. The Company does not have an unconditional right to defer the settlement of the liability for at least twelve months after the reporting period. Terms of a liability that could result in its settlement by the issue of equity instruments at the option of the counterparty does not affect this classification.

All other liabilities are classified as non-current.

c) **Property, Plant and Equipment (PPE):**

PPE is stated at cost less accumulated depreciation. The initial cost of PPE comprises of its purchase price, including import duties and non-refundable purchase taxes, and any directly attributable costs of bringing an asset to working condition and location for its intended use, including relevant borrowing costs and any expected costs of decommissioning,

Subsequent expenditure relating to PPE are capitalized only when it is probable that future economic associated with these will flow to the Company and cost of the item can be measured reliably. Repairs and maintenance cost are charged to the Statement of Profit and Loss in the period in which the costs are incurred.

Material items such as spare parts, stand-by equipment and service equipment are classified as PPE when they meet the definition of PPE as specified in Ind AS 16 – Property, Plant and Equipment.

An item of property, plant and equipment and any significant part initially recognized is derecognized upon disposal or when no future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in the income statement when the asset is derecognized.

d) **Depreciation:**

Depreciation is calculated on cost of items of property, plant and equipment less their estimated residual values over their estimated useful lives using the straight-line method, and is generally recognized in the Statement of Profit and Loss. Freehold land is not depreciated.

The estimated useful life of items of property, plant and equipment are as follows: (work under process)

Depreciation on additions (disposals) is provided on a pro-rata basis i.e. from (up to) the date/month on which asset is ready for use (disposed of).

e) **Intangible Assets and Amortization:**

Intangible assets with finite useful life that are acquired separately are stated at acquisition cost less accumulated amortization and impairment losses, if any. The Company determines the useful life as the period over which the future economic benefits will flow to the Company after taking into account all relevant facts and circumstances.

Amortization is calculated over the cost of the asset, or other amount substituted for cost. Amortization is recognized in Statement of Profit and Loss on a straight-line basis over the estimated useful life of intangible assets from the date that they are available for use.

The Company has determined useful life of software as 3 to 10 years.

Gains or losses arising from derecognition of an intangible asset are measured as the difference between the net disposal proceeds and the net carrying amount of the asset and are recognized in the statement of Profit and Loss when the asset is derecognized.

Research and development costs

Expenditure pertaining to research is expensed as incurred. Expenditure incurred on development is capitalized if such expenditure leads to creation of an asset, otherwise such expenditure is charged to the Statement of Profit and Loss.

f) Capital Work in Progress:

Advances paid towards acquisition of PPE outstanding at each Balance Sheet date is classified as capital advances under other non-current assets and cost of the assets not put to use before such date are disclosed under Capital Work in Progress.

g) Investment property:

Investment property is property held either to earn rental income or for capital appreciation or for both, but not for sale in the ordinary course of business, use in the production or supply of goods or services or for administrative purposes. Investment properties are stated at cost less accumulated depreciation and accumulated impairment losses, if any. The cost includes the cost of replacing parts and borrowing costs for long term construction projects if the recognition criteria are met. When significant parts of the property are required to be replaced at intervals, the Company depreciates them separately based on their specific useful lives.

Subsequent expenditure is capitalized to the assets carrying amount only when it is certain that the future economic benefits associated with the expenditure will flow to the Company and the cost of the item can be measured reliably. All other repairs and maintenance and other costs are expensed when incurred.

Investment properties are de-recognized either when they have been disposed off or when they are permanently withdrawn from use and no future economic benefit is expected from their disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognized in the statement of profit and loss in the period of derecognition.

h) Reclassification to investment property:

When the use of a property changes from owner-occupies to investment property, the property is reclassified as investment property at its carrying amount on the date of reclassification.

i) Impairment of Non-Financial Assets:

Assets are tested for impairment whenever events or changes in circumstances indicate that the carrying amount may not be recoverable. An impairment loss is recognized for the amount by which the asset's carrying amount exceeds its recoverable amount. The recoverable amount is the higher of an asset's fair value less cost of disposal and value in use. For the purposes of assessing impairment, assets are grouped at the lowest levels for which there are separately identifiable cash inflows which are largely independent of the cash inflows from other assets or groups of assets (cash-generating units).

j) Inventories:

Inventories are valued as follows:

Inventories are valued at Lower of Weighted Average cost or estimated net realizable value & are net of Goods and Service Tax (GST). Cost includes cost of conversion and other costs incurred in bringing the inventories at their present location and condition. Cost of conversion for the purpose of valuation of WIP and finished goods includes fixed and variable production overheads incurred in converting the material into their present condition and location.

Inventory of machinery spares and maintenance materials not being material are expensed in the year of purchase. However, machinery spares that meets the definition of property, plant and equipment are capitalized in the financial statements.

k) Borrowing Costs:

Borrowing cost includes interest, amortization of ancillary costs incurred in connection with the arrangement of borrowings. Borrowing costs directly attributable to the acquisition, construction or development of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalized as part of the cost of the respective asset. All other borrowing costs are expensed in the year they occur.

l) Provisions, Contingent Liabilities and Contingent Assets:

Provisions are recognized when the Company has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

If the effect of the time value of money is material, provisions are discounted using a current pre-tax rate that reflects current market assessment of time value of money and, where appropriate, the risks specific to the liability. Unwinding of the discount is recognized in the Statement of Profit and Loss as a finance cost. Provisions are reviewed at each reporting date and are adjusted to reflect the current best estimate.

Contingent liabilities are also disclosed when there is a possible obligation arising from past events, the existence of which will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the Company.

Claims against the Company where the possibility of any outflow of resources in settlement is remote, are not disclosed as contingent liabilities.

Contingent assets are not recognized in financial statements since this may result in the recognition of income that may never be realized. However, when the realization of income is virtually certain, then the related asset is not a contingent asset and is recognized.

m) Revenue Recognition:

Revenue from contract with customers

Revenue is recognized on the basis of approved contracts regarding the transfer of goods or services to a customer for an amount that reflects the consideration to which the entity expects to be entitled in exchange for those goods or services.

Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price (net of variable consideration) allocated to that performance obligation. The transaction price of goods sold and services rendered is net of variable consideration on account of various discounts and schemes offered by the Company as part of the contract.

Variable consideration includes discounts provided to the dealers and customers. Accumulated experience is used to estimate and provide for the discounts and revenue is only recognized to the extent that it is highly probable that significant reversal will not occur.

Sales are recognized when substantial control of the products has been transferred to the customer, being when the products are delivered to the customer without any unfulfilled obligation that could affect the customer's acceptance of the products.

Any amount receivable from the customers are recognized as revenue after the control over the goods are transferred to the customer which is generally on dispatch of goods as this is the point in time that the consideration is unconditional because only the passage of time is required before the payment is due.

The Company does not expect to have any contracts where the period between the transfer of goods and payment by customer exceeds one year. Hence, the Company does not adjust revenue for the time value of money.

Dividend Income

Dividends are recognized in the Statement of Profit and Loss only when the right to receive payment is established, it is probable that the economic benefits associated with the dividend will flow to the Company and the amount of the dividend can be measured reliably.

Interest Income

Interest Income is recognized using Effective Interest Method

n) Lease:

The Company has applied Ind AS 116 Leases from the accounting periods beginning from April 1, 2019 using the modified retrospective approach. Accordingly, the comparative information for the year ended March 31, 2019 has not been restated and continues to be reported under Ind AS 17 and relevant appendices.

At inception of a contract, the Company assesses whether a contract is, or contains, a lease. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Company assesses whether:

1. the contract involves the use of an identified asset - this may be specified explicitly or implicitly and should be physically distinct or represent substantially all of the capacity of a physically distinct asset. If the supplier has a substantive substitution right, then the asset is not identified.
2. the Company has the right to obtain substantially all of the economic benefits from use of the asset throughout the period of use; and
3. the Company has the right to direct the use of the asset. The Company has this right when it has the decision-making rights that are most relevant to changing how and for what purpose the asset is used. In rare cases where the decision about how and for what purpose the asset is used is predetermined, the Company has the right to direct the use of the asset if either:
 - a - the Company has the right to operate the asset; or
 - b - the Company designed the asset in a way that predetermines how and for what purpose it will be used.

This policy is applied to contracts entered into, or modified, on or after April 1, 2019. At inception or on reassessment of a contract that contains a lease component, the Company allocates the consideration in the contract to each lease component on the basis of their relative stand-alone prices.

Company as a lessee

The Company recognizes a right-of-use asset and a lease liability at the lease commencement date. The right-of-use asset is initially measured at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or before the commencement date, plus any initial direct costs incurred and an estimate of costs to dismantle and remove the underlying asset or to restore the underlying asset or the site on which it is located, less any lease incentives received.

The right-of-use asset is subsequently depreciated using the straight-line method from the commencement date to the earlier of the end of the useful life of the right-of use asset or the end of the lease term. The estimated useful lives of right-of-use assets are determined on the same basis as those of property and equipment. In addition, the right-of-use asset is periodically reduced by impairment losses, if any, and adjusted for certain remeasurements of the lease liability.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date, discounted using the interest rate implicit in the lease or, if that rate cannot be readily determined, the Company's incremental borrowing rate. Generally, the Company uses its incremental borrowing rate as the discount rate. The lease liability is measured at amortized cost using the effective interest method.

Short-term leases and leases of low-value assets

The Company has elected not to recognize right-of use assets and lease liabilities for short-term leases that have a lease term of 12 months or less and leases of low-value assets. The Company recognizes the lease payments associated with these leases as an expense on a straight-line basis over the lease term.

o) Government Grant:

- Government grants are recognized where there is reasonable assurance that the grant will be received and all attached conditions will be complied with.
- When the grant relates to an expense item, it is recognized in Statement of Profit and Loss on a systematic basis over the periods that the related costs, for which it is intended to compensate, are expensed.
- When the grant relates to property, plant and equipment, the cost of property, plant and equipment is shown at gross value and grant thereon is recognized as deferred income and are credited to statement of Profit and Loss on a systematic basis over the useful life of the asset.

p) Employee Benefit Expense:

Defined benefit plan:

The Company pays gratuity to the employees whoever has completed five years of service with the Company at the time of resignation/superannuation. The gratuity liability amount is contributed to the approved gratuity fund formed exclusively for gratuity payment to the employees.

The liability in respect of gratuity and other post-employment benefits is calculated using the Projected Unit Credit Method and spread over the period during which the benefit is expected to be derived from employees' services.

Re-measurement of defined benefit plans in respect of post-employment are charged to the Other Comprehensive Income. Re-measurement recognized in OCI is reflected immediately in retained earnings and will not be reclassified to Statement of Profit and Loss.

The present value of the defined benefit plan liability is calculated using a discount rate which is determined by reference to market yields at the end of the reporting period on government bonds.

The defined benefit obligation recognized in the Balance Sheet represents the actual deficit or surplus in the Company's defined benefit plans. Any surplus resulting from this calculation is limited to the present value of any economic benefits available in the form of refunds from the plans or reductions in future contributions to the plans.

Defined contribution plan:

Payments to defined contribution plans are recognized as an expense when employees have rendered service entitling them to the contributions.

The eligible employees of the Company are entitled to receive benefits in respect of provident fund, for which both the employees and the Company make monthly contributions at a specified percentage of the covered employees' salary. The contributions as specified under the law are made to the Government Provident Fund monthly.

Short-term employee benefits:

A liability is recognized for benefits accruing to employees in respect of wages and salaries, annual leave in the period the related service is rendered. Liabilities recognized in respect of short-term employee benefits are measured at the undiscounted amount of the benefits expected to be paid in exchange for the related service.

q) Income Taxes:

The tax expense for the period comprises current and deferred tax. Tax is recognized in Statement of Profit and Loss, except to the extent that it relates to items recognized in the comprehensive income or in equity. In which case, the tax is also recognized in other comprehensive income or equity.

Current Tax:

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, based on tax rates and laws that are enacted or substantively enacted at the Balance sheet date.

Deferred Tax:

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit.

Deferred tax liabilities and assets are measured at the tax rates that are expected to apply in the period in which the liability is settled or the asset realised, based on tax rates (and tax laws) that have been enacted or substantively enacted by the end of the reporting period.

The carrying amount of Deferred Tax Liabilities and assets are reviewed at the end of each reporting period date and are reduced to the extent that it is no longer probable.

r) Foreign Currency Transactions:

Foreign currency transactions are recorded at exchange rate prevailing on the date of the transaction. Foreign currency denominated monetary assets and liabilities are restated into the functional currency using exchange rates prevailing on the Balance sheet date. Gains and losses arising on settlement and restatement of foreign currency denominated monetary assets and liabilities are recognised in the statement of Profit and Loss, Non- monetary assets and liabilities that are measured in terms of historical cost of foreign currencies are not translated.

s) Earnings Per Share:

The basic Earnings Per Share ("EPS") is computed by dividing the net profit / (loss) after tax for the year attributable to the equity shareholders by the weighted average number of equity shares outstanding during the year.

For the purpose of calculating diluted earnings per share, net profit/(loss) after tax for the year attributable to the equity shareholders and the weighted average number of equity shares outstanding during the year are adjusted for the effects of all dilutive potential equity shares.

t) Financial Instruments:

Financial Assets & Financial Liabilities are recognized when the Company becomes party to contractual provisions of the relevant instrument.

Initial Recognition and Measurement:

All financial assets are recognized initially at fair value plus, in the case of financial assets not recorded at fair value through Profit or Loss, transaction costs that are attributable to the acquisition of the financial assets. Transaction costs of financial assets carried at fair value through Profit or Loss are expensed in Profit or Loss. However, trade receivables that do not contain a significant financing component are measured at transaction price.

Classification and Subsequent Measurement: Financial Assets

Financial assets carried at Amortized Cost:

A financial asset is measured at amortized cost if it is held within a business model whose objective is to hold the asset in order to collect contractual cash flows and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at fair value through Other Comprehensive Income (FVTOCI):

A financial asset is measured at FVTOCI if it is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

Financial assets at fair value through Profit and Loss (FVTPL):

A financial asset which is not classified in any of the above categories are measured at FVTPL.

Investment in Equity Instruments designated to be classified as FVTOCI:

The Company carries certain equity instruments which are not held for trading. The Company has elected the FVTOCI irrevocable option for these instruments. Movements in fair value of these investments are recognized in other comprehensive income and the gain or loss is not reclassified to statement of profit and loss on disposal of these investments. Dividends from these investments are recognized in statement of Profit and Loss when the Company's right to receive dividends is established.

Classification and Subsequent Measurement: Financial Liabilities

Financial liabilities are carried at amortized cost using the effective interest method. For trade and other payables maturing within one year from the balance sheet date, the carrying amounts approximate fair value due to the short maturity of these instruments.

Impairment of financial assets:

In accordance with Ind AS 109, the Company uses 'Expected Credit Loss' (ECL) model, for evaluating impairment of financial assets other than those measured at fair value through Profit and Loss (FVTPL).

For trade receivables Company applies 'simplified approach' which requires expected lifetime losses to be recognized from initial recognition of the receivables. The application of simplified approach does not require the Company to track changes in credit risk. The Company calculates the expected credit losses on trade receivables using a provision matrix on the basis of its historical credit loss experience.

For other assets, the Company uses 12 month ECL to provide for impairment loss where there is no significant increase in credit risk. If there is significant increase in credit risk full lifetime ECL is used.

Derecognition of Financial Instruments:

The Company derecognizes a financial asset when the contractual rights to the cash flows from the financial asset expire or it transfers the financial asset and the transfer qualifies for derecognition under Ind AS 109.

A financial liability (or a part of a financial liability) is derecognized from the Company's Balance Sheet when the obligation specified in the contract is discharged or cancelled or expires.

u) Cash and cash equivalent:

Cash and cash equivalents in the Balance Sheet comprise cash at bank and in hand that are readily convertible into cash which are subject to insignificant risk of changes in value and are held for the purpose of meeting short-term cash commitments.

v) Assets Held for Sale:

Non-current assets or disposal groups comprising of assets and liabilities are classified as 'held for sale' when all of the following criteria's are met: (i) decision has been made to sell. (ii) the assets are available for immediate sale in its present condition. (iii) the assets are being actively marketed and (iv) sale has been agreed or is expected to be concluded within 12 months of the Balance Sheet date.

Subsequently, such non-current assets and disposal groups classified as held for sale are measured at the lower of its carrying value and fair value less costs of disposal. Non-current assets held for sale are not depreciated or amortized.

w) Derivative Financial Instruments:

The Company enters into derivative financial instruments viz. foreign exchange forward contracts to manage its exposure foreign exchange rate risks. The Company does not hold derivative financial instruments for speculative purposes.

Derivatives are initially recognized at fair value at the date the derivative contracts are entered into and are subsequently remeasured to their fair value at the end of each reporting period. The resulting gain or loss is recognized in Profit and Loss immediately.

x) Segment Reporting - Identification of Segments:

An operating segment is a component of the Company that engages in business activities from which it may earn revenues and incur expenses, whose operating results are regularly reviewed by the company's management to make decisions for which discrete financial information is available.

Based on the management approach as defined in Ind AS 108, the management evaluates the Company's performance and allocates resources based on an analysis of various performance indicators by business segments and geographic segments.

X) Cash Dividend:

The Company recognizes a liability to make cash distributions to equity holders when the distribution is authorized and approved by the shareholders. A corresponding amount is recognized directly in equity.

Note 1(B): Use of Estimates and Judgments

The preparation of the financial statements in conformity with Ind AS requires management to make judgments, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses. Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in any future periods affected. In particular, information about significant areas of estimation, uncertainty and critical judgments in applying accounting policies that have the most significant effect on the amounts recognized in the financial statements are included in the following notes:

a) Useful Lives of Property, Plant & Equipment:

The Company uses its technical expertise along with historical and industry trends for determining the economic life of an asset/component of an asset. The useful lives are reviewed by management periodically and revised, if appropriate. In case of a revision, the unamortized depreciable amount is charged over the remaining useful life of the assets.

b) Defined Benefit Plans and Compensated Absences:

The cost of the defined benefit plans, compensated absences and the present value of the defined benefit obligation are based on actuarial valuation using the projected unit credit method. An actuarial valuation involves making various assumptions that may differ from actual developments in the future. These include the determination of the discount rate, attrition rate, future salary increases and mortality rates.

Due to the complexities involved in the valuation and its long-term nature, a defined benefit obligation is highly sensitive to changes in these assumptions. All assumptions are reviewed at each reporting date.

c) Expected Credit Losses on Financial Assets:

The impairment provisions of financial assets are based on assumptions about risk of default and expected timing of collection. The Company uses judgment in making these assumptions and selecting the inputs to the impairment calculation, based on the Company's past history, customer's creditworthiness, existing market conditions as well as forward looking estimates at the end of each reporting period.

d) Fair Value measurement of financial instruments:

When the fair values of financial assets and financial liabilities recorded in the balance sheet cannot be measured based on quoted prices in active markets, their fair value is measured using valuation techniques including the Discounted Cash Flow model. The inputs to these models are taken from observable markets where possible, but where this is not feasible, a degree of Judgments is required in establishing fair values. Judgments include considerations of inputs such as liquidity risk, credit risk and volatility

e) Contingent Liability:

The Company has received various orders and notices from tax authorities in respect of direct taxes and indirect taxes and various other laws. The outcome of these matters may have a material effect on the financial position, results of operations or cash flows. Management regularly analyses current information about these matters and discloses the information of related contingent liability. In making the decision regarding the need of creating loss provision, management considers the degree of probability of an unfavorable outcome and the ability to make a sufficiently reliable estimate of the amount of loss. The filing of a suit or formal assertion of a claim against the Company or the disclosure of any such suit or assertions, does not automatically indicate that a provision of a loss may be appropriate.

Note 1(C): Standard Issued:

In May 2025, MCA notified amendments to Ind AS 21 - The Effects of Changes in Foreign Exchange Rates, Ind AS 1, Presentation of Financial Statements and Ind AS 7, Statement of Cashflows applicable w.e.f. 1st April, 2025. The Company has reviewed the amendments and based on its evaluation has determined that it does not have any significant impact in its financial statements.

In accordance with the recommendations of National Financial Reporting Authority (NFRA), Ind AS 118 – Presentation and Disclosure in Financial Statements will be applicable from 1st April, 2027. The Company will evaluate the impact of the new standards for implementation in due course.

Credit risk is the risk that counterparty will not meet its obligations under a financial instrument or customer contract, leading to a financial loss. 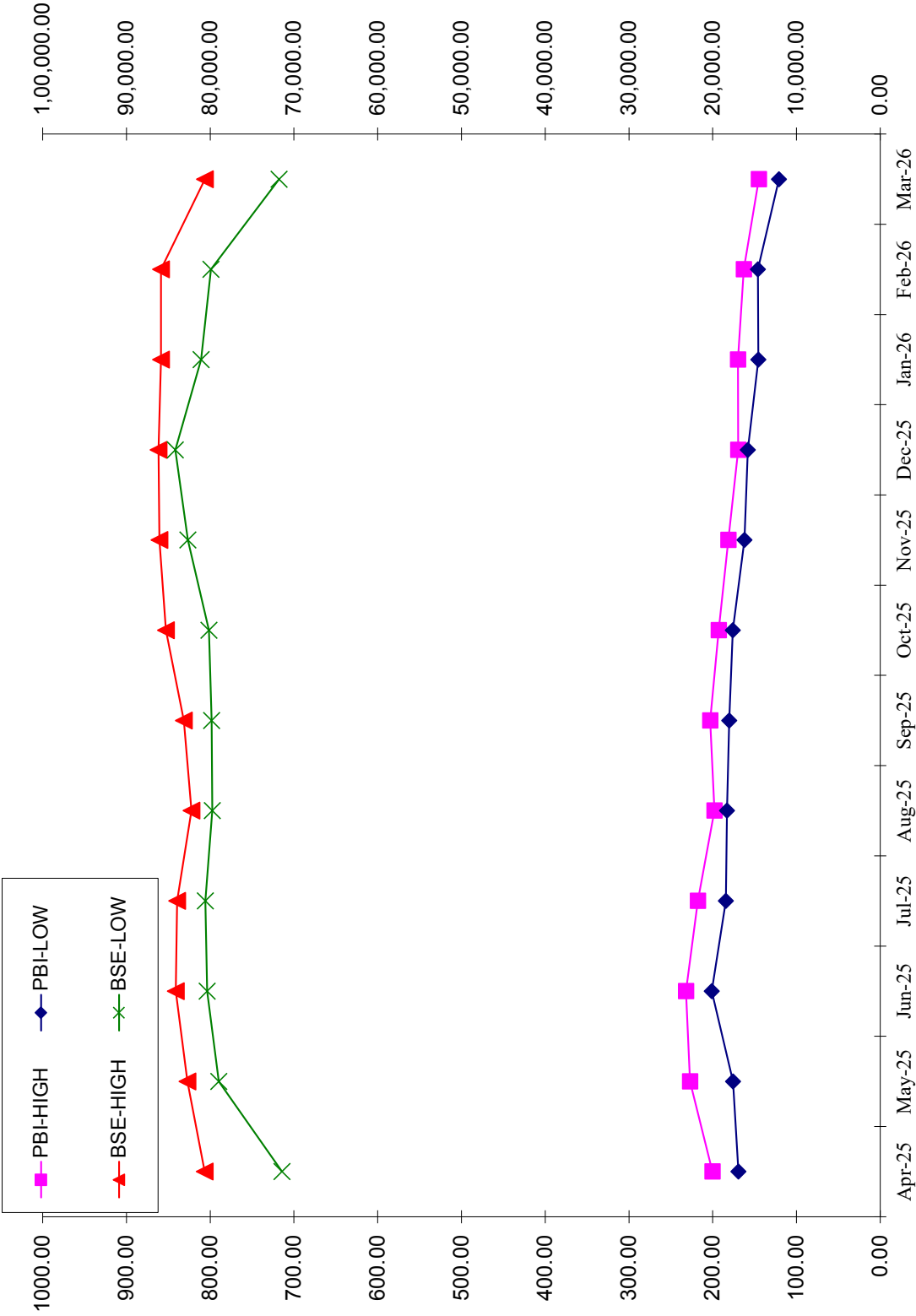
