Ms. Madhavi Divan, learned senior counsel, appearing for the Siliguri Jalpaiguri Development Authority¹, states that steps will be taken to bring a quietus to the matter by splitting up the land in question so as to lease it out piecemeal. She states that the process in that regard may take six weeks.

The matter is adjourned to enable the SJDA to do all that is necessary to raise sufficient funds to meet the decree holder's long pending dues.

Further, as the learned counsel appearing for SLRL Agencies Pvt. Ltd. now states that the said entity is not willing to abide and stand by the offer made by it earlier for purchase of the leasehold rights, it would be open to it to approach the High Court for release of the amounts deposited by it.
