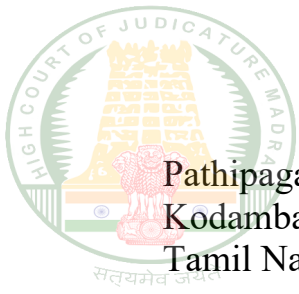

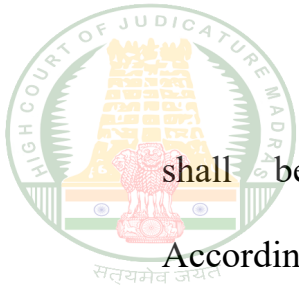

ORDER

This application has been filed under Clause 12 of the Letters Patent seeking leave to institute the suit before this Court.

2. On a reading of the plaint, the defendant has its registered office and carries on business in Chennai, within the ordinary original civil jurisdiction of this Court. The plaint also states that the entire cause of action arose in Chennai. The fact that the dealership is operated at Perungalathur, outside those limits, does not, by itself, make leave under Clause 12 necessary. Leave is required where jurisdiction is invoked on the ground that only part of the cause of action arose within the Court's limits; it is unnecessary where the whole cause of action arose here or the defendant carries on business here. The agreement between the parties also provides that disputes arising under it



shall be subject to the jurisdiction of the courts at Chennai.

Accordingly, leave under Clause 12 is unnecessary. Hence, this application is dismissed as unnecessary, without prejudice to the presentation and numbering of the plaint, if it is otherwise in order, subject to compliance with the other requirements of law. No costs.
