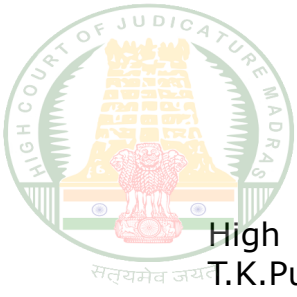

(Order of the Court was made by the Hon'ble Chief Justice)

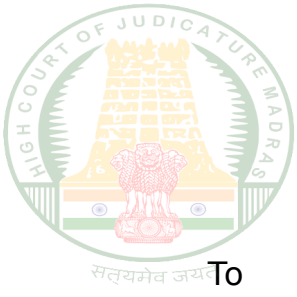
The petitioner appearing in person seeks leave of this Court to withdraw this writ petition. An endorsement is also made to that effect.
