(Order of the Court was made by the Hon'ble Chief Justice)

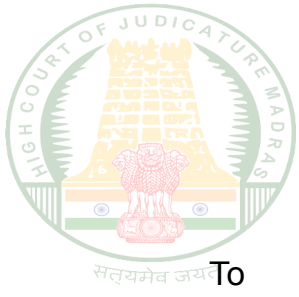
Learned counsel for the petitioners submits that the petition is rendered infructuous and therefore, may be dismissed as such.
