UPON hearing the counsel the Court made the following
O R D E R

1. Applications for exemption from filing certified copy of the impugned judgment and exemption from filing official translation are allowed.
2. Delay condoned.

3. Heard Mr. Ammet Kumar Deshpande, learned senior counsel appearing for the petitioner and Mr. Navin Pahwa, learned senior counsel appearing on caveat for respondent Nos. 2 and 3.

4. Learned senior counsel appearing for the petitioner contends that auction was never held whereas Mr. Navin Pahwa, learned senior counsel for respondent Nos. 2 and 3 is emphatic that auction was, in fact, held by the Bank.

5. On this issue and other issues we want to be satisfied from the Bank. The Bank is directed, before the next date of hearing, to file an affidavit setting out cogently the events that transpired leading to the sale of the property.

6. Issue notice, returnable on 5th October, 2026.

7. In the meantime, *status quo*, with regard to the nature, title and possession of the suit property shall be maintained by the parties.
