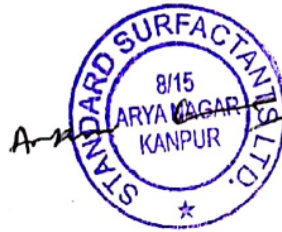

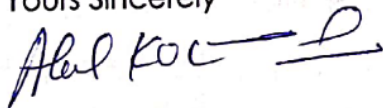
I confirm that there are no other material reasons for my resignation apart from those stated above.
