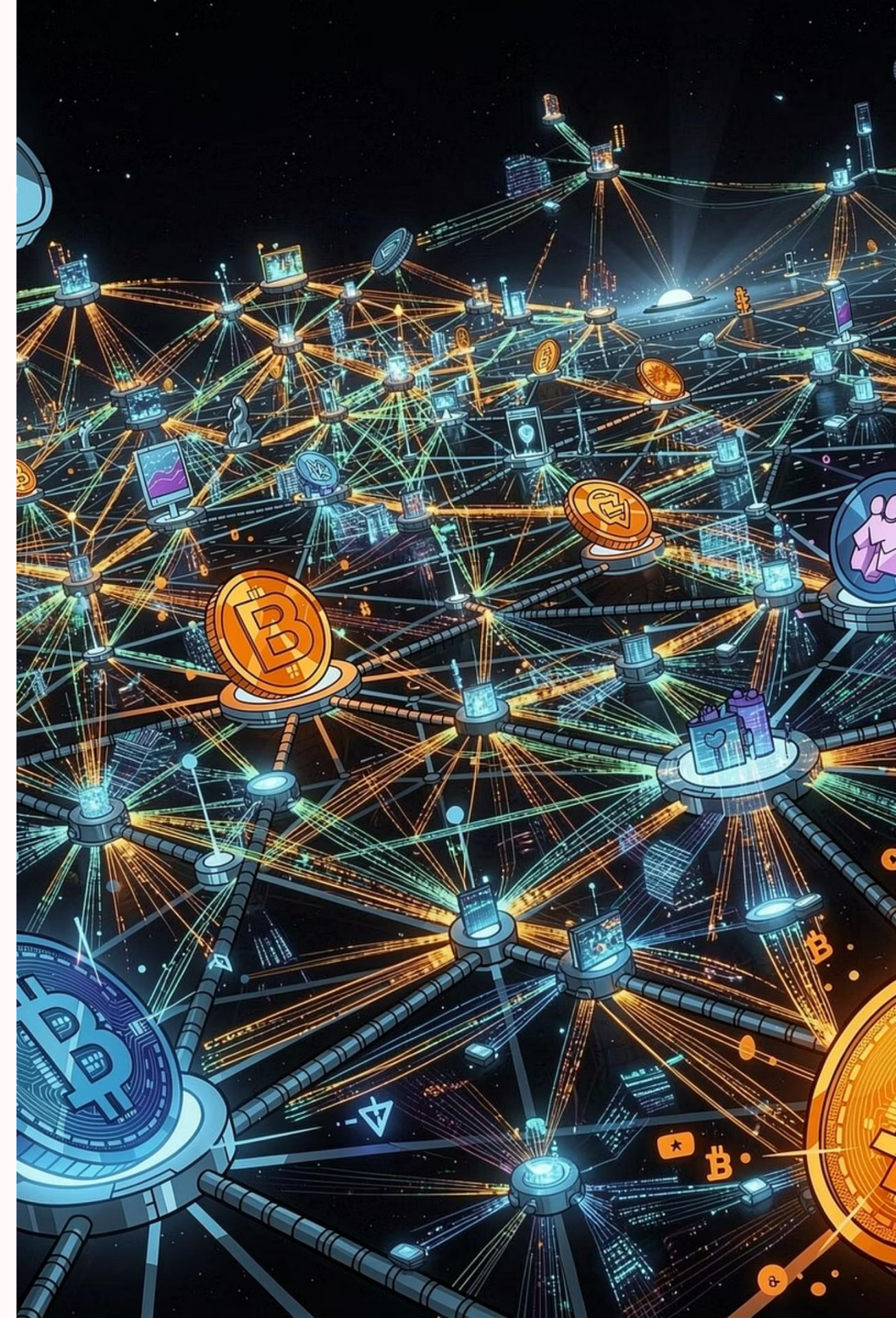

# String Metaverse – FY26 Annual Highlights

- **Revenue Growth FY26:** Achieved ₹1,076.55 Cr revenue, up 163.72% YoY from ₹408.22 Cr in FY25.
- **EBITDA FY26:** EBITDA rose 189.50% YoY to ₹122.88 Cr, reflecting exceptional operational leverage.
- **Profit Expansion:** PAT surged 190.89% YoY to ₹102.53 Cr, reflecting strong bottom-line growth.
- **Ecosystem User Milestone:** Crossed 5 million users across the String ecosystem.
- **DeFi & Tokenized Assets:** DeFi and tokenized asset volumes surpassed \$220+ Million.
- **Derivatives Trading:** Achieved \$4+ Billion in derivatives volume on centralized (CEX) exchanges.
- **Bills on Chain:** Launched Phase 1 of the Bills on Chain partnership with Hedera Blockchain, tokenizing bills on-chain.
- **String Pay X Card:** Introduced the String Pay X virtual crypto-backed debit card in partnership with Visa, with access across 150+ countries.

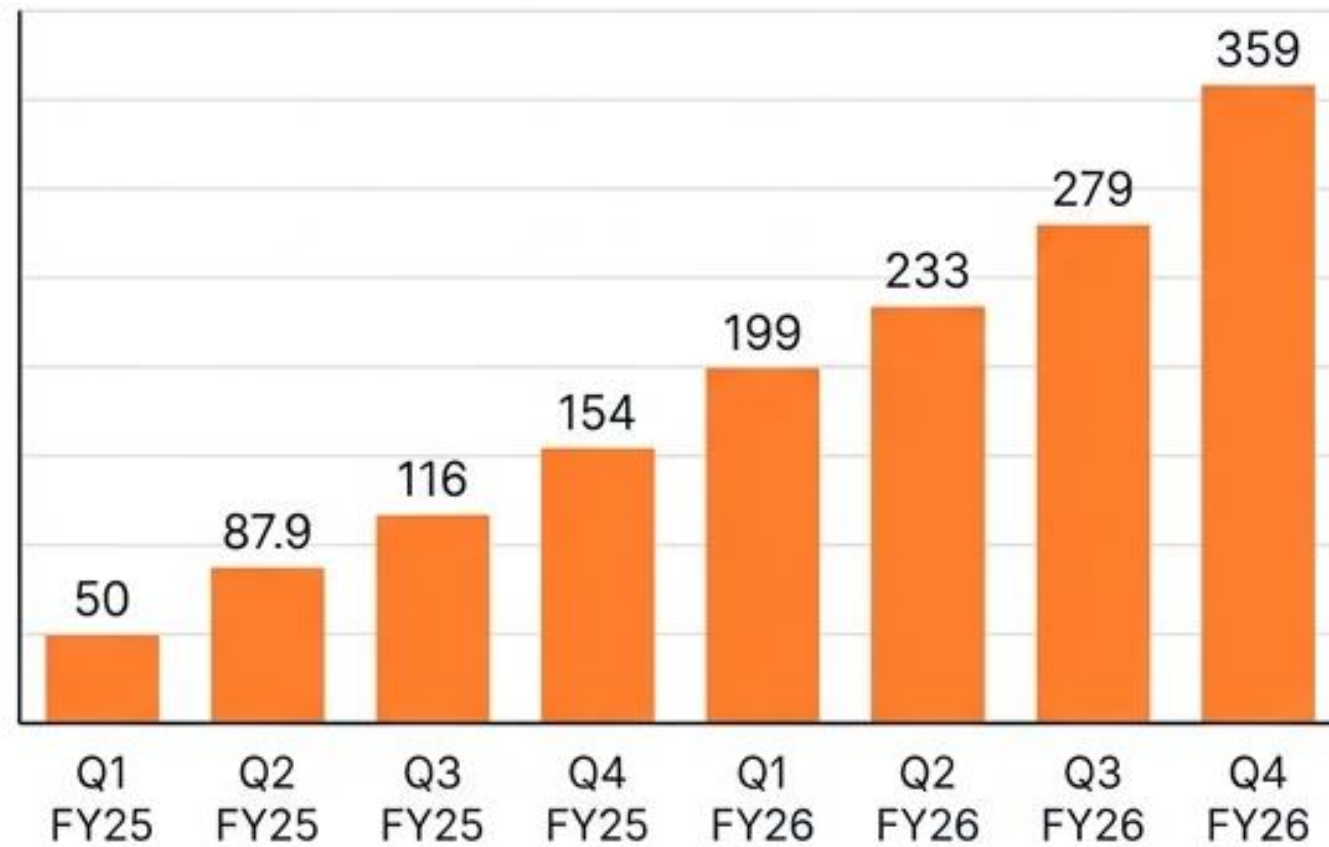

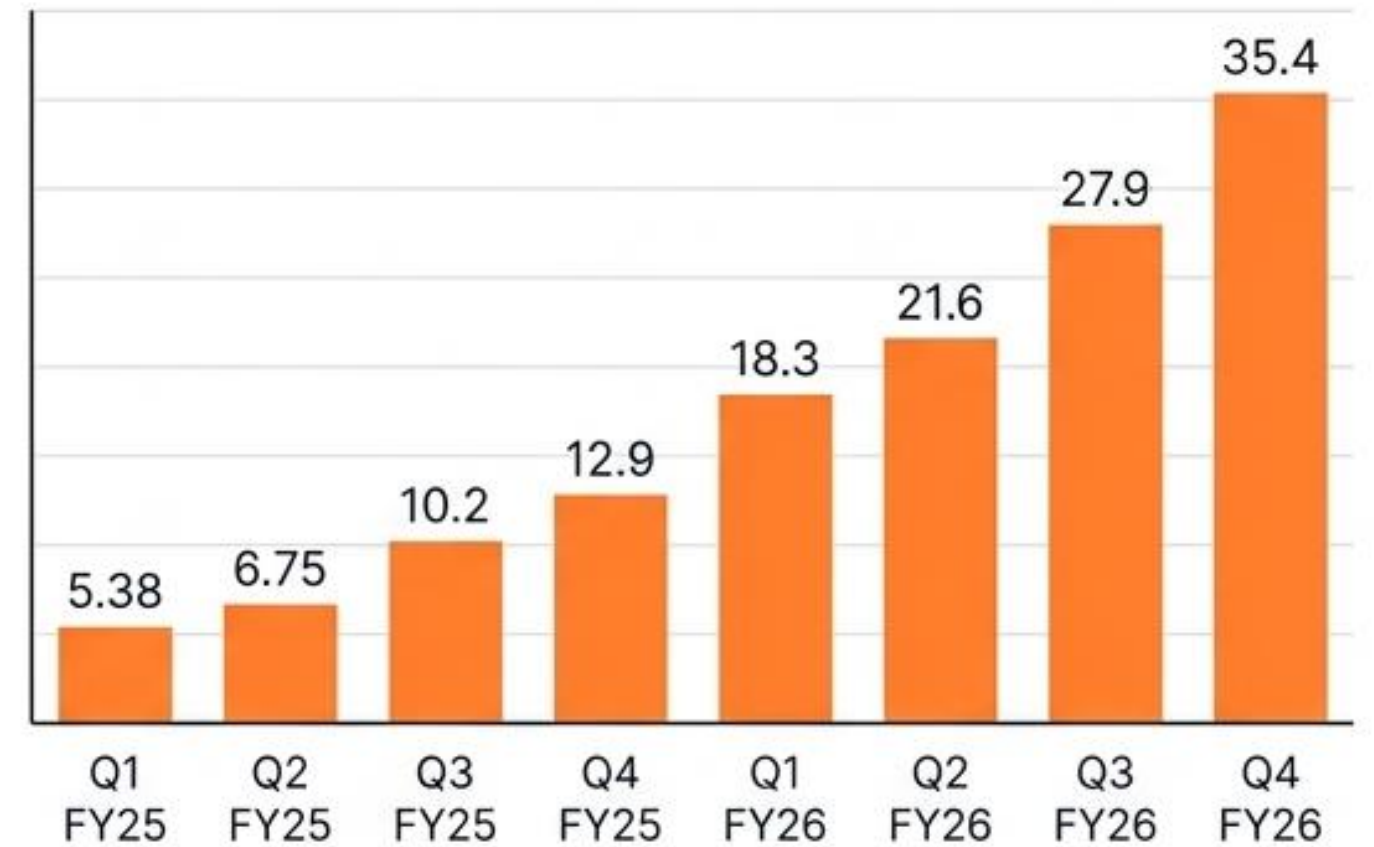

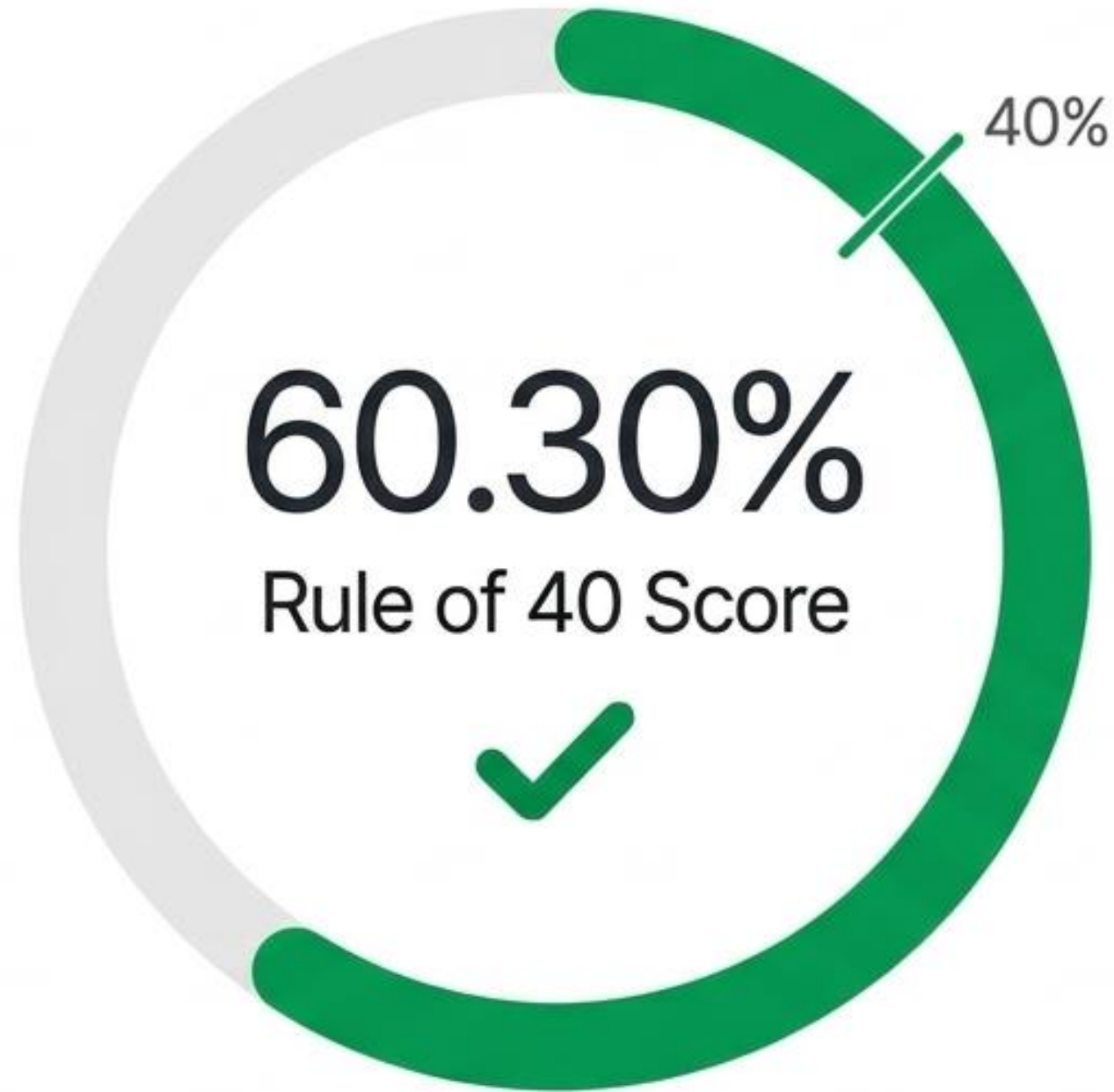

The **Rule of 40** is a guiding principle for evaluating the health and growth potential of companies, stating that a company's combined revenue growth rate and profit margin should equal or exceed 40%.

For FY26, String Metaverse delivered 50% YoY revenue growth and a 10.3% PAT margin, resulting in a Rule of 40 score of **60.30%** — **1.5x** the SaaS benchmark.
