It has been agreed between the parties that an amount of ₹37,00,000/- (Rupees thirty seven lakhs only) would be paid by the respondent-New India Assurance Company within a period of six weeks from today, subject to the learned counsel for the petitioner supplying the bank details of the petitioner, which he undertakes to supply today itself as the amount offered is acceptable to the petitioner.

It is clarified this amount of ₹37,00,000/- (Rupees thirty seven lakhs only) in lumpsum is over and above the amount which has already been assessed by the High Court and according to the learned counsel for the parties, disbursed also. There shall be no further claim by either of the parties against each other.

In the light of the settlement, learned counsel for the parties pray that an award may be passed.

Award is, accordingly, passed by this Special Lok Adalat.

The special leave petition shall be treated as disposed of in terms of the Award passed by the Special Lok Adalat.

We appreciate the efforts made by the learned counsel for the parties for bringing about an amicable solution to the issues involved.
