Ltd. & Ors.*' pending before the High Court of Judicature at Madras to the High Court of Delhi and to be tagged with CS (Comm.) 562 of 2017, pending before the High Court of Delhi.

2. We have heard learned counsel appearing for the petitioner and the learned counsel appearing for respondent no.2 and also perused the material placed on record.

4. Records of the aforesaid cases should immediately be transferred to the transferee court.

5. The Transfer Petitions are allowed accordingly.
