5. In view of payments having been received by the petitioners towards full and final settlement of their dues, it is ordered that the sale deeds mentioned in Exhibit A shall stand cancelled by reason of this order.
6. The sale deeds be returned to the alleged contemnors within a week from today.
7. The contempt petition stands closed.
8. Pending application(s), if any, shall stand disposed of.
