With reference to the above subject, I, SUDHAKARA VARMA YARRAMRAJU S/o RAVINDRA RAJU YARRAMRAJU Promoter of the Company and presently holding 9,81,155 equity shares in the Company (representing 1.16% of the total voting rights of the Company) hereby requests the Company pursuant to Regulation 31A(3) (a) (i) of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 for my re-classification from 'Promoter' to 'Public' category since I am complying with all the conditions prescribed 31A(3)(b) of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as mentioned below:

In connection with application for reclassification in accordance with the provisions of Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, I hereby confirm and certify that:

1. I along with persons related to me together:
 - a. do not hold more than ten percent of the total voting rights in the company.
 - b. do not exercise control over the affairs of the company, directly or indirectly.
 - c. do not have any special rights with respect to the company through formal or informal arrangements including through any shareholder agreements.
 - d. are not being represented on the board of directors (including not having a nominee director) of the Company
 - e. do not act as a key managerial person of the Company
 - f. are not 'wilful defaulter(s)' as per the Reserve Bank of India Guidelines
 - g. are not fugitive economic offender
2. There is no pending regulatory action against me.
3. I shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31A (3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 at all times from the date of re-classification, failing which, I shall be reclassified as promoter of the company.



4. I shall comply with the conditions mentioned in the of sub-clauses (iv) and (v) of clause (b) of Regulation 31A (3) of SEBI (Listing Obligation and Disclosure Requirements), Regulations, 2015 for a period of not less than three years from the date of reclassification, failing which, I shall be reclassified as promoter of the company.

The rationale behind this request is that I have no role to play in the affairs of the Company, have no special rights, no pecuniary or other interest in the company, directly or indirectly.

Accordingly, I request you to take the application on record and initiate the process of reclassification as per Regulation 31A of SEBI (Listing Obligations and Disclosure Requirements) Regulations (Listing Regulations), 2015 to reclassify my status from Promoter to Public.
