A W A R D

1. Heard Mr. Sharanagouda Patil, learned counsel appearing for the petitioners and Mr. J P N Shahi, learned counsel appearing for the respondent no.2 -Insurance Company assisted by Ms. Nikhita Bhowmik, Deputy Manager of the New India Assurance Co. Ltd.

2. We have interacted with learned counsel representing the

respective parties.

3. The Motor Accident Claims Tribunal (MACT) had awarded compensation of Rs 31,33,596/- (Rupees Thirty One Lakhs Thirty Three Thousand Five Hundred and Ninety Six) which was carried in appeal and the High Court has enhanced the compensation to Rs. 46,10,128/- (Rupees Forty Six Lakhs Ten Thousand One Hundred and Twenty Eight) however, on review, the matter was restored and the High Court reduced the compensation to Rs. 31,95,420/- (Rupees Thirty One Lakhs Ninety Five Thousand Four Hundred and Twenty).

4. After consultation and negotiations, the parties have arrived at full and final settlement by virtue of which the amount as originally enhanced by the High Court, being Rs. 46,10,128/- (Rupees Forty Six Lakhs Ten Thousand One Hundred and Twenty Eight) is agreed to be restored. The amount shall be paid, if not already paid, within a period of six weeks from today.

5. In view of the above settlement, the Special Leave Petitions stand disposed of.
