1) Relating to the transaction & the Offer

- a) In accordance with the SPA, the acquisition of the Sale Shares shall be completed upon the fulfillment of conditions agreed between the Acquirers and the Sellers. In terms of and in accordance with Regulation 23(1) of the SEBI (SAST) Regulations, if the conditions as stated in paragraph 7.4 of this Letter of Offer are not complied with, for the reasons beyond the reasonable control of the Acquirers, the Open Offer would stand withdrawn.
- b) This Offer is an offer to acquire only up to 5,46,000 Equity Shares (“**Offer Shares**”) representing 26.00% of the equity share capital of the Target Company. 3.1 BACKGROUND OF THE OFFER

The Acquirers have agreed to purchase the Sale Shares at a negotiated price of ₹ 18/- (Rupees Eighteen Only) per equity share aggregating to ₹ 2,14,77,600/- (Rupees Two Crore Fourteen Lakh Seventy Seven Thousand Six Hundred Only), payable in cash.

All the Sellers belongs to the Promoter Group of the Target Company.
- 3.1.4 The Sellers does not belong to any Group as such. None of the Sellers have been prohibited by SEBI from dealing in securities in terms of direction issued under Section 11B of the SEBI Act, or under any of the regulations made under the SEBI Act.
- 3.1.5 Salient features of SPA are as follows:**
- The purchase price for the Sale Shares is ₹ 18/- (Rupees Eighteen Only) per fully paid up Equity Shares of the Target Company which is negotiated price between Acquirers and the Sellers. The total consideration for the Sale Shares is ₹ 2,14,77,600/- (Rupees Two Crore Fourteen Lakh Seventy Seven Thousand Six Hundred Only).
 - ₹ 20,00,000/- (Rupees Twenty Lakhs Only) shall be payable by the Acquirers to the Sellers upon signing of the SPA and the balance amount of Sale Consideration payable by the Acquirers in tranches to the Sellers on or before transactional execution of the Sale Share transaction, but not later than 60 days from the date of Post Offer Public Announcement issued by Manager to the Offer.
 - Within 60 days from the date of the Post Offer Public Announcement under SEBI (SAST) Regulations, 2011, the acquisition of said shares will be completed and the shares would be transferred into the name of the Acquirers. The transaction of the Sale Shares will be either through the stock exchange settlement process (in term of the Regulations) or as an off market transaction.
- 3.1.6 Through the Share Purchase Agreement, the Acquirers propose to take substantial acquisition of shares and management control of the Target Company. After the acquisition of shares under the underlying transaction and the Open Offer, assuming full acceptance in the Offer, the shareholding of the Acquirers will be 17,39,200 Equity Shares constituting 82.82% of the Equity Share Capital of the Target Company. - 3.2.2 The Acquirers hereby makes this Offer to the existing shareholders (other than the parties to the SPA) to acquire up to 5,46,000 (Five Lakhs Forty Six Thousand) equity shares of face value of ₹ 10/- (Rupees Ten Only) constituting 26.00% of the equity share capital of the Target Company on the 10th (Tenth) working day from the closure of the Tendering Period (“Offer Size”) at a price of ₹ 20/- (Rupees Twenty Only) per equity share payable in cash, subject to the terms and conditions set out in the Public Announcement, the Detailed Public Statement and this Letter of Offer, that will be sent to the shareholders of the Target Company.
- 3.2.3 No trading was recorded on the date of the Public Announcement. 4.1.2 Rravvi Goyal (Trustee), aged about 50 years, holds a Bachelor's degree in Commerce from Delhi University. He has about 25 years of experience. He started his entrepreneurial journey by joining the family-run agro commodities business. He has strategically diversified the business across various sectors Education, Finance & Renewal Energies.

4.1.3 The Capital of R G Family Trust as on March 31, 2026 is ₹ 90.00 Crore & the Net worth is ₹ 97.91 Crore (based on provisional financial as on March 31, 2026) as certified by CA Vikas Aggarwal (Membership No. 524151), Proprietor of Aggarwal Vikas & Asso., (Firm Registration No. 026384N) Chartered Accountants, Email: vikas16garg@gmail.com and having office at S-15/B-2, 1st Floor, Naveen Shahdara, Delhi – 110 032.

4.2 SAMEER GUPTA (“ACQUIRER NO. 2”)

He is second-generation entrepreneur and had joined Jakson Group in the year 1991 and has played an instrumental role in the growth of the Jakson Group. He is a Vice-Chairman of Jakson Group. He has experience of more than 30 years. Under his guidance, Jakson become the first genset company in India to adopt advanced CNC technologies at its manufacturing plants. He also oversaw the setting-up of Jakson's solar manufacturing plant in Noida. He belongs to Jakson group of companies.

4.3.2 As on date of this LoF, he is Director in 6 public limited companies namely (1) Jakson Limited, (2) Jakson Engineers Limited, (3) Jakson Green Limited, (4) Jakson Infra Projects Limited, (5) Jakson Urban Infra Limited and (6) Jakson Integrated Solar Limited. He is not serving as a Whole Time Director in any public limited companies. Further he is Director in 12 private limited companies.

4.3.3 The Net worth of Sundeep Gupta as on February 28, 2026 is ₹ 241.54 Crore as certified by CA Meet Shah (Membership No. 171134) Partner of Shah Sanghvi & Asso., (Firm Registration No. 140107W) Chartered Accountants, Email: m.shah@valserve.in and having office at 11th Floor, A Wing, Safal Profitaire, Corporate Road, Prahlad Nagar, Ahmedabad – 380 015.

4.4 OTHER DETAILS OF THE ACQUIRERS

4.4.1 Rravvi Goyal (the trustee of the R G Family Trust), is the business associate of Sameer Gupta & Sundeep Gupta. Further Sameer Gupta is brother of Sundeep Gupta and belong to single family & are related to each other, as defined under section 2(77) of Companies Act, 2013.

4.4.2 As on the date of this LoF, the Acquirers are not holding any Equity Shares of the Target Company.

- 4.4.3 If the Acquirers acquire any equity shares of the Target Company during the Offer Period, then they will inform Stock Exchanges, the Target Company and the Manager to the Offer within 24 hours of the acquisition in compliance with Regulation 18(6) of the SEBI (SAST) Regulations. Further, they will not acquire or sell any equity shares of the Target Company during the period between three working days prior to the commencement of the Tendering Period and until the closure of the Tendering Period as per Regulation 18(6) of the SEBI (SAST) Regulations.

- 5.4 The main object of the Target Company is to carry on in India or elsewhere the business to prepare, market, trade, import, export, improve, process, sell and carry on the business of canners, preservers, growers of fresh and/or preservable products of vegetables, fruits, herbs, flowers, drinks, fluids and other and generally to carry on the manufacturing of juices, powder (edible) drinks, beverages, pickles, masalas, mixtures, vinegars, ketchups, gelatins, essences, table delicacies and other eatables.

- 8.5 All Shareholders who desire to tender their Shares under the Open Offer would have to approach their respective stock brokers ("**Selling Broker**"), during the normal trading hours of the secondary market during tendering period.

- 8.6** Public Shareholders have to ensure that their Equity Shares are made available to their Selling Brokers, before the closure of the Tendering Period.
- 8.7** The lien marked against unaccepted Equity Shares will be released, if any, or would be returned by registered post or by ordinary post or courier (in case of physical shares) at the Public Shareholders' sole risk. - 8.16.9 All non-resident Public Shareholders (i.e. Public Shareholders not residing in India including NRIs, OCBs and FPIs) are mandatorily required to fill the Form of Acceptance. The non-resident Public Shareholders holding Equity Shares in dematerialised form, directly or through their respective Selling Brokers, are required to send the Form of Acceptance along with the required documents to the Registrar to the Offer at its address given on the cover page of the LoF. The envelope should be super scribed as “**Fabino Enterprises Limited – Open Offer**”.

8.17 Procedure for tendering Equity Shares held in Physical Form:

As per the provisions of Regulation 40(1) of the Listing Regulations and SEBI’s press release dated December 03, 2018, bearing reference no. 8.19 Acceptance of Shares:

- 8.19.1 Registrar to the Offer shall provide details of order acceptance to Clearing Corporation within specified timelines.
