- The 16th Annual General Meeting of the Members of Ajooni Biotech Limited was held on Wednesday, 29th July, 2026 at 11.00 A.M through video conferencing ('VC')/ other Audio visual means (OAVM) facility.
- Mr. Jasjot Singh, Managing Director and the Chairman, chaired the proceedings of the Meeting.
- The numbers of shareholders as on record date 17th July 2026 were 60449.
- The requisite quorum being present, the Chairman called the meeting in order and introduced the Directors and Officials present at the meeting.
- The Chairman informed that this meeting has been convened and being conducted in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India (SEBI). The Chairman informed that the Company had tied up with National Securities Depositories Limited (NSDL) to provide facility for voting through remote e-voting, VC / OAVM facility for AGM and e-voting during the AGM.
- The Company provided the members the facility to cast their votes electronically on all the resolutions set forth in the Notice. The remote e-voting commenced at 9.00 a.m. on Saturday, 25th July 2026 and ended at 5.00 p.m. on Tuesday, 28th July, 2026. The Chairman informed the Members that the facility for voting through e-voting system was made available during the Meeting for Members who had not cast their vote prior to the Meeting.
