UPON hearing the counsel the Court made the following  
O R D E R

1. The submission of the learned counsel for the petitioner is that the total compensation/ fine payable under the order(s) of the Court below is Rs. 40,000/- out of which 30% had

already been deposited. He submits that bank draft of Rs. 28,000/- has already been prepared in favour of the complainant, therefore, the petitioner may be given opportunity to compound the offence. In such circumstances, he has prayed that the sentence awarded be suspended and he be released on bail to enable him to make payment of the balance amount of Rs. 28,000/- to the complainant.

2. Issue notice, returnable in six weeks.

3. Having regard to the submissions noticed above, the sentence awarded to the petitioner shall remain suspended.

4. The petitioner shall be released on bail on such terms and conditions as the trial court may deem fit to impose in the facts and circumstances of the case.

5. Within two weeks of being released on bail, the petitioner shall make payment of the balance amount of Rs. 28,000/- to the complainant and shall file receipt thereof by the next date.
