Dear Sir/Madam,

Aastha Spintex Limited ("Company") wishes to provide a business and operational update in relation to the rooftop solar PV project being implemented at the manufacturing premises of Falcon Yarns Private Limited ("Falcon"), whose acquisition by the Company has been previously disclosed.

Falcon has received registration from the Gujarat Energy Development Agency ("GEDA") for installation of a rooftop solar PV system having 1,000 kW AC capacity and 1,350 kW DC capacity (1.35 MW DC) at its Bharudi, Gondal facility in Rajkot district, Gujarat. The GEDA registration is dated 16 September 2026 and has been issued under the Gujarat Integrated Renewable Energy Policy - 2025 for the industrial/commercial category.

The project has now moved into on-site execution. As per the Daily Progress Report (DPR) dated 16 September 2026, 13 personnel were deployed at site; Module Mounting Structure (MMS) marking work was approximately 70% complete and MMS installation work was approximately 40% complete. Photographs of the ongoing rooftop execution are enclosed with this update.

A detailed project note, photographic progress update and copy of the GEDA registration letter are enclosed as annexures.

Detailed Project & Execution Update**1.35 MW DC Rooftop Solar PV Project - Falcon Yarns Private Limited****Executive Summary**

Falcon Yarns Private Limited has secured GEDA registration for a 1,000 kW AC / 1,350 kW DC rooftop solar PV system at its industrial facility in Bharudi, Gondal, District Rajkot. The project is registered under the Gujarat Integrated Renewable Energy Policy - 2025 and is being implemented in CAPEX mode, with electricity generated intended for Falcon's own use. Physical execution is underway, with meaningful progress in MMS marking and installation as of 16 September 2026.

Regulatory Position and Remaining Process

The GEDA letter confirms registration of the rooftop solar PV project. It is important to distinguish registration from final commissioning. The letter records a number of subsequent technical and regulatory steps, including:

- Technical feasibility assessment by the relevant DISCOM.
- Execution of the connectivity agreement with the DISCOM after technical feasibility is established.
- Installation of the appropriate bi-directional meter in accordance with DISCOM specifications.
- SLD approval and charging permission from the competent electrical authorities, where applicable.
- Compliance with the Gujarat Integrated Renewable Energy Policy - 2025, GERC regulations and applicable ALMM requirements.

Disclosure discipline

Accordingly, the project should be described as "GEDA registered and under execution" rather than as fully commissioned. The commercial and operating benefits will begin only after completion of installation, statutory / utility processes and successful commissioning.

Strategic & Operational Relevance

Captive renewable power: The project is registered in CAPEX mode and the electricity generated is intended for Falcon's own use. This directly links the renewable asset with manufacturing operations rather than a merchant-power model.

Potential energy-cost efficiency: After commissioning, captive solar generation can reduce the quantum of grid electricity required during solar-generation hours. Any actual savings will depend on irradiation, plant availability, captive consumption, tariff structure and other operating factors.

Execution visibility: The DPR and site photographs demonstrate that the project is not limited to a regulatory application; rooftop marking and mounting-structure installation activity is physically underway.

Sustainability of manufacturing platform: A dedicated rooftop solar asset can increase the renewable-energy component of power consumed at the Falcon manufacturing site and supports the Company's broader focus on operational efficiency and sustainability.

Scalable operating infrastructure: Energy infrastructure at a manufacturing facility is an important part of supporting production operations. Progress on the solar project strengthens the supporting infrastructure around the Falcon facility as the broader manufacturing platform is developed.

This Registration shall be governed by the provisions of Gujarat Integrated Renewable Energy Policy – 2025 & GERC Net Metering Regulations from time to time and its amendments thereof, if any.
2. In the event if you have to change your selected Installer after the Registration, you need to cancel this Registration and apply under a fresh application.
3. You have registered the solar PV plant under the Clause no. 9.2 of Gujarat Integrated Renewable Energy Policy – 2025.

4. You shall ensure that the location proposed for installation of the system is shadow free during the entire day and also keep the system clean and dust free for optimum output.
5. You shall sign the connectivity agreement with the DISCOM upon its ascertaining the technical feasibility of the system installation.
6. You shall allow access to your premises by representatives of GEDA/ DISCOM/ CEI for installation of respective meter as per provision of Gujarat Integrated Renewable Energy Policy – 2025 and its amendments thereof, if any / inspection/ verification of the system.
7. The respective meter shall be installed in accordance to the technical specifications defined by the DISCOM.
8. The technical specifications of the Solar PV system and all its allied components, shall be mutually agreed between YOU and the INSTALLER selected by you.
9. It is YOUR sole responsibility to ensure and check all the components properly with the selected INSTALLER. In no case, GEDA shall responsible for the delay in installation, sub-standard material, low generation or any issue related to performance and quality. However, it is advisable to always install solar PV system in the shadow free area and with proper sizing and structures for maximum generation. Further, the Applicant shall check the requisite documents and reports from the suitable simulation tools on its own or through the Installer to ascertain the above mentioned points.
10. This Application has been submitted under **Industrial/commercial** Category.
11. The Provision of "Approved List of Models and Manufacturers" (ALMM List-I & List -II) & its amendment issued by MNRE from time to time shall be applicable.
12. The Provision & amendment issued by GERC/ EPD from time to time shall be applicable.
13. This project shall be governed by the Gujarat Integrated Renewable Energy Policy – 2025 and the GERC regulations issued from time to time. The Renewable Energy Generator shall be bound by all the provisions as decided by the GERC.
