I would like to express my gratitude to the Board of Directors and the entire management team for the support extended to me during my tenure as an Independent Director of the Company.

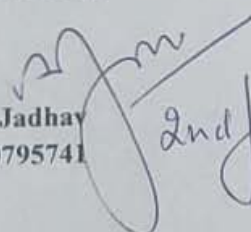
