This is reference to our earlier intimations dated 18th August 2025, 22nd August'2025 and 29th January'2026, regarding the search action initiated under Section 132 of the Income-tax Act, 1961 by the Income Tax Department

Pursuant to Regulation 30 read with Para A(19) and Para B(8) of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), and in continuation of our earlier intimations referred to above, we wish to inform you that, the Company has received on 15th September, 2026 at 9:46 A.M. (IST), through the e-Filing portal of the Income Tax Department, a notice dated 14 September, 2026 (DIN & Notice No. ITBA/AST/F/142(1)/2026-27/1093417308(1)) under sub-section (1) of Section 142 of the Income-tax Act, 1961 ("the Act") from the Office of the Assistant Commissioner of Income Tax, Central Circle 7, Delhi, in connection with the assessment for the block period 1 April 2019 to 17 October 2025 under Chapter XIV-B of the Act, consequent to the search and seizure action conducted under Section 132 of the Act on 18 August 2025 in the case of the Company along with its associated entities and other related persons.

The notice requires the Company to produce the accounts and documents, and to furnish the information (verified in the manner prescribed under Rule 14 of the Income-tax Rules, 1962), called for in the annexure to the notice, electronically through the "e-Proceedings" facility on or before 29 September, 2026 at 11:00 AM. The annexure sets out the issues identified by the Department during the search and post-search investigation, in respect of which issue-wise explanations and supporting documentary evidence have been sought, together with year-wise questionnaires relating to the returns of income for Assessment Years 2020-21 to 2025-26 and certain other matters. The notice does not determine any undisclosed income and does not raise any demand for tax, interest or penalty.
