Learned counsel for the petitioner(s), on instructions stated submitted that a sum of Rs.20,00,000/- (Rupees Twenty Lakhs) in addition to Rs.13,00,000/- (Rupees Thirteen Lakhs) already paid by the petitioner(s) to the respondent/Bank would be paid by the petitioner(s) to the respondent/Bank and further the auction purchaser would be suitably compensated in case there is a settlement between the parties.

2. In order to seek instructions on this proposal by the respective learned counsel, we refer the matter back to the Court.

3. The petitioner is also ready and willing to deposit Rs.20,94,000/- (Rupees Twenty Lakhs Ninety Four Thousand) with the Registry of this Court within a period of one week from today.

4. On such deposit being made, the Registry of this Court shall deposit the said amount in an interest-bearing fixed deposit account of a nationalised bank for an initial period of six months subject to automatic renewal.

5. In case of settlement between the borrower and auction purchaser, the amount deposited by the auction purchaser with the Bank shall be returned by the Bank to the auction purchaser.
