Pursuant to Regulation 30 read with Para A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, and in continuation of the Company's earlier disclosures regarding the Share Purchase Agreement ("SPA") and the Open Offer, we hereby inform that M/s Farmico International Private Limited ("Acquirer") has completed the acquisition of 22,81,615 equity shares of the Company, representing 74.64% of the paid-up equity share capital, on May 21, 2026, in accordance with Regulation 22(2) of the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and the terms of the SPA.

Consequent to the completion of the aforesaid acquisition and the Open Offer, the Acquirer has acquired substantial shareholding, voting rights and effective control over the Company.

Further, M/s Farmico International Private Limited and Mr. Chandraprakash Wadhvani, being the person exercising control over the Acquirer, have become part of the Promoter and Promoter Group of the Company in accordance with the applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the SEBI (Substantial Acquisition of Shares and Takeovers) Regulations, 2011 and other applicable laws.
