Order on Board

1. By filing the present petition, the petitioner calls in question the action of the respondents in reflecting the petitioner's name as a blacklisted employee on their web-portal (Annexure P-1).
2. Learned counsel for the petitioner submits that grievance of the petitioner is

that the petitioner is residing at near Shriram Phase -02, Rai Priya Shop, Rawatpura, Mathpuraina Ward No. 60, Raipur Chhattisgarh and he was appointed and selected on the post of Chief Salesman in Foreign Wine Shop Santoshi Nagar, Raipur, District Raipur Chhattisgarh. The petitioner was performing his duty sincerely and regularly on the post of Chief Salesman at Foreign Wine Shop Santoshi Nagar, Raipur, District Raipur Chhattisgarh without any complaint and without any dispute. Suddenly the respondent without any enquiry of department and without considering performance and serving of duty, has wrongly been reflected the petitioner's name in blacklist of the online attendance portal (excise.cg.nic.in) of the Chhattisgarh State Marketing Corporation Limited by wrongly mentioning the duty of the Govt. Wine Shop Konta Sukma in place of Foreign Wine Shop Santoshi Nagar, Raipur whereas, petitioner has neither performed his duty at the Govt. Wine Shop Konta Sukma nor got transferred. As per RTI information, the concerned respondent authorities has found that petitioner has neither appointed nor posted at Govt. Wine Shop Konta Sukma Chhattisgarh by letter dated 01.04.2026. The impugned list of blacklist employee (Annexure P-1) passed by the respondent no. 2 is completely illegal, erroneous and contrary to the law. He submits that in this respect he has moved representation before authorities which is still pending.

3. Considering the submissions made by learned counsel for the petitioner, without expressing any opinion on the merits of the case, this writ petition is **disposed of** with a direction to competent authority of respondents to consider and decide the petitioner's pending representation, in accordance with law, by passing a reasoned and speaking order, expeditiously,

preferably within a period of **45 days** from the date of receipt of a copy of this order.

4. It is made clear that this Court has not expressed any opinion on the merits of the petitioner's claim and the competent authority shall decide the representation independently, strictly in accordance with law, after taking into consideration all relevant records and documents, information relied upon by the petitioner.
