Gloria Steinem, potent voice of US feminism, dies at 92

New York: Gloria Steinem, the celebrated author and activist who became one of the most visible voices of the US women's movement and a lifelong advocate for feminist causes, has died. She was 92. Steinem, a co-founder of Ms Magazine, died on Wednesday at her home in New York City, as per social media posts by her foundation.

"Gloria's greatest gift was her ability to listen to others, to make others feel seen and heard," the posts said. "Her words, actions, and example gave people permission to be their truest selves."

Steinem began her career as a journalist and in 1963 went undercover to report on conditions in Hugh Hefner's Playboy empire. She later credited a 1969 meeting where women spoke in favour of abortion rights with changing her career path. "That speak-out was the beginning of activism for me," Steinem, who had undergone an illegal abortion at 22, told the Associated Press in 2022. She became an internationally recognised campaigner for women's equality, travelling and speaking well into her 80s. "Being a feminist means that you see the world as whole instead of half," she once said.

ZELENSKY HAILS INDIA'S PEACE INITIATIVE

Kyiv: Ukrainian President Volodymyr Zelenskyy met External Affairs Minister S Jaishankar on Thursday and thanked India for its commitment to ending the Ukraine-Russia war, as New Delhi reiterated its readiness to help find a peaceful solution.

"We are grateful to India for its commitment to ending

this unjust war, Russia's war against Ukraine. It certainly must not be a time of war. Peace is needed. This is India's clear position," Zelenskyy said on social media. Jaishankar, who held talks with Ukrainian Foreign Minister Andrii Sybiha, said India was ready to extend "any help in any manner" to end the conflict.



"India has consistently maintained that this is not an era of war, and that solutions

will not emerge from the battlefield," he said. "Every passing day of conflict only means more deaths and more destruction. Understandably, it is for the parties involved to find a way. But, if India can be of any help in any manner, we are ready," Jaishankar added.

His visit came two days after PM Narendra Modi told

Russian President Vladimir Putin that endless war must give way to the end of war. Sybiha welcomed Modi's call, saying Ukraine "stands ready for diplomacy". "India is a global power and we welcome PM Narendra Modi's call to move from an endless war towards an end to the war," he said.
