The preliminary determination is subject to verification and final determination by the U.S. Department of Commerce.

The Company is evaluating the impact of the preliminary determination on its business and financial performance. At this stage, the financial impact, if any, is not ascertainable.
6	Any other relevant information	As per the U.S. Department of Commerce, the final Countervailing Duty determination is currently scheduled to be announced along with the final Anti-Dumping Duty determination on December 8, 2026, unless postponed.
