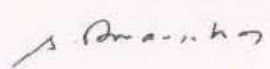

NOTES :

Section A

- 1) Pursuant to Clause 16 of the listing agreement with the Stock Exchanges, the Register of Members and Share Transfer Register will remain closed from 10.09.2026 to 16.09.2026 (both days inclusive) in connection with the 33rd Annual General Meeting of the Company and the Record date be 09.09.2026

2) Updation of PAN and other details:

SEBI vide its Circular dated March 16, 2023 mandated furnishing of PAN, KYC details (i.e. postal address with pin code, email address, mobile number, bank account details) and Nomination details by holders of physical securities through Form ISR-1.

It may be noted that any service request or complaint can be processed only after the folio is KYC compliant.

In terms of above Circular, Folios of Physical shareholders wherein any one of the above said details such as PAN, email address, mobile number, bank account details and nomination are not available, were frozen with effect from October 1, 2023 and such physical shareholders will not be eligible to lodge grievance or avail service request from the RTA of the Company and will not be eligible for receipt of dividend in physical mode.

Shareholders holding shares in physical form are requested to ensure that their PAN is linked to Aadhaar to avoid freezing of folios.

- 3) The Dividend which were not claimed within seven years from the date of transfer to the Unpaid Dividend Account will as per Section 124 of the Companies Act, 2013, be transferred to Investor Education and Protection Fund. The accompanying shares on which dividend not claimed for seven years be transferred to Investor Education and Protection Fund. The Company has uploaded the details of the unpaid and unclaimed dividend amounts on the website of the Company and also on the website of the Ministry of the Corporate Affairs. Members wishing to claim unclaimed dividends are requested to correspond with the Company Secretary and for claiming the transferred shares to apply to the IEPF.
- 4) This Notice and Annual Report will be available on the website of the Company.
- 5) Members holding shares in electronic form are hereby informed that Bank Account details registered against their depository accounts will be used by the Company for payment of dividend. Any changes of Bank particulars are to be advised to their Depository Participants

Section B

1. Pursuant to the Ministry of Corporate Affairs (MCA) General Circular No. 03/2025 dated 22.09.2025 and in accordance with the requirements laid down in the Para 3 and Para 4 of MCA General Circular No. 20/2020 dated 05.05.2020 allowed the companies to conduct the general meeting through video conferencing (VC) or other audio-visual means (OAVM) and the Company decided to conduct the AGM through video conferencing (VC) or other audio-visual means (OAVM). Hence, Members can attend and participate in the ensuing AGM through VC/OAVM.
2. Pursuant to the MCA Circular No. 14/2020 dated April 08, 2020, issued by the Ministry of Corporate Affairs, the facility to appoint proxy to attend and cast vote for the members is not available for this AGM. However, the Body Corporates are entitled to appoint authorised representatives to attend the AGM through VC/OAVM and participate thereat and cast their votes through e-voting.
3. The Members can join the AGM in the VC/OAVM mode between 15 minutes before and after the scheduled time of the commencement of the Meeting by following the procedure mentioned in the Notice. The facility of participation at the AGM through VC/OAVM will be made available for 1000 members on first come first served basis. This will not include large Shareholders (Shareholders

holding 2% or more shareholding), Promoters, Institutional Investors, Directors, Key Managerial Personnel, the Chairpersons of the Audit Committee, Nomination and Remuneration Committee and Stakeholders Relationship Committee, Auditors etc. who are allowed to attend the AGM without restriction on account of first come first served basis.

4. The attendance of the Members attending the AGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Companies Act, 2013.
5. Pursuant to the provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014 (as amended) and Regulation 44 of SEBI (Listing Obligations & Disclosure Requirements) Regulations 2015 (as amended), and the various Circulars issued by the Ministry of Corporate Affairs the Company is providing facility of remote e-Voting to its Members in respect of the business to be transacted at the AGM. For this purpose, the Company has entered into an agreement with National Securities Depository Limited (NSDL) for facilitating voting through electronic means, as the authorized agency. The facility of casting votes by a member using remote e-Voting system as well as venue voting on the date of the AGM will be provided by NSDL.
6. In line with the Ministry of Corporate Affairs (MCA) Circular No. 17/2020 dated April 13, 2020, the Notice calling the AGM has been uploaded on the website of the Company at www.nationalfitting.com The Notice can also be accessed from the website of the Stock Exchange i.e. BSE Limited at www.bseindia.com and the AGM Notice is also available on the website of NSDL (agency for providing the remote e-voting facility) i.e. www.evoting.nsdl.com.
7. AGM has been convened through VC/OAVM in compliance with applicable provisions of the Companies Act, 2013 read with various MCA Circulars as mentioned above.

THE INSTRUCTIONS FOR MEMBERS FOR REMOTE E-VOTING ARE AS UNDER:-

The remote e-voting period begins on 13.09.2026 at 09:00 A.M. and ends on 15.09.2026 at 05:00 P.M. The remote e-voting module shall be disabled by NSDL for voting thereafter. The Members, whose names appear in the Register of Members / Beneficial Owners as on the record date (cut-off date) i.e. 09.09.2026 may cast their vote electronically. The voting right of shareholders shall be in proportion to their share in the paid-up equity share capital of the Company as on the cut-off date, being 09.09.2026

How do I vote electronically using NSDL e-Voting system?

The way to vote electronically on NSDL e-Voting system consists of "Two Steps" which are mentioned below:

A) Login method for e-Voting and joining virtual meeting for Individual shareholders holding securities in demat mode

In terms of SEBI circular dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. How to cast your vote electronically and join General Meeting on NSDL e-Voting system?

1. After successful login at Step 1, you will be able to see all the companies “EVEN” in which you are holding shares and whose voting cycle and General Meeting is in active status.
2. Select “EVEN” of company for which you wish to cast your vote during the remote e-Voting period and casting your vote during the General Meeting. For joining virtual meeting, you need to click on “VC/OAVM” link placed under “Join General Meeting”.
3. Now you are ready for e-Voting as the Voting page opens.
4. Cast your vote by selecting appropriate options i.e. assent or dissent, verify/modify the number of shares for which you wish to cast your vote and click on “Submit” and also “Confirm” when prompted.
5. Upon confirmation, the message “Vote cast successfully” will be displayed.
6. You can also take the printout of the votes cast by you by clicking on the print option on the confirmation page.
7. Once you confirm your vote on the resolution, you will not be allowed to modify your vote.

General Guidelines for shareholders

2. It is strongly recommended not to share your password with any other person and take utmost care to keep your password confidential. Login to the e-voting website will be disabled upon five unsuccessful attempts to key in the correct password. In such an event, you will need to go through the "Forgot User Details/Password?" or "Physical User Reset Password?" option available on www.evoting.nsdl.com to reset the password.

2. Only those members/ shareholders, who will be present in the AGM through VC/OAVM facility and have not casted their vote on the resolutions through remote e-voting and are otherwise not barred from doing so, shall be eligible to vote through e-Voting system in the AGM.
3. Members who have voted through Remote e-voting will be eligible to attend the AGM. However, they will not be eligible to vote at the AGM.
4. The details of the person who may be contacted for any grievances connected with the facility for e-voting on the day of the AGM shall be the same person mentioned for remote e-voting.

INSTRUCTIONS FOR MEMBERS FOR ATTENDING THE AGM THROUGH VC/OAVM ARE AS UNDER:

1. Member will be provided with a facility to attend the AGM through VC/OAVM through the NSDL e-Voting system. members login where the EVEN of Company will be displayed. - (iii) A person, whose name is recorded in the register of members or in the register of beneficial owners maintained by the depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the VC/OAVM facility
- (iv) **Mr. B Krishnamoorthy**, Chartered Accountant (Membership No. 20439) has been appointed as the Scrutinizer for providing facility to the members of the Company to scrutinize the voting and remote e-voting process in a fair and transparent manner.
- (v) The Chairman shall, at the Annual General Meeting, at the end of discussion on the resolutions on which voting is to be held, allow voting with the assistance of scrutinizer, by use of "remote e-voting" for all those members who are present at the Annual General Meeting but have not cast their votes by availing the remote e-voting facility.
- (vi) The Scrutinizer shall after the conclusion of venue voting at the Annual General Meeting, unblock the votes cast through remote e-voting and venue voting in the presence of at least two witnesses not in the employment of the Company and shall make, not later than three days of the conclusion of the Annual General Meeting a consolidated scrutinizer's report of the total votes cast in favor or against, if any, to the Chairman or a person authorized by him in writing, who shall countersign the same and declare the result of the voting forthwith.

Communication to Shareholders

Building the Next Phase of Growth

Dear Shareholders,

FY 2025-26 was the year in which several strategic decisions set in motion over the preceding two years came to completion, and in which the Company's next phase of growth began to take visible shape.

The Company achieved its highest-ever revenue, and - on a like-for-like basis excluding last year's one-time exceptional gain - its strongest operating profit in at least five years. That improvement was not incidental. It reflects the benefit of the consolidation undertaken in FY 2023-24 and FY 2024-25 (the sale of the Thekkalur unit and relocation of foundry operations to Veda sandur), which has now had two full years to translate into better utilisation, tighter cost control and a stronger product mix.

The single most significant development of the year was the completion of the change in the Company's promoter group. M/s Himgiri Castings Private Limited, together with persons acting in concert, is now the Company's promoter, bringing over 40 years of experience in the pipe fittings and castings industry. Because castings are one of the Company's most critical raw material inputs, this is not a change in ownership alone — it is a strategic alignment that gives National Fittings Limited direct access to deep casting expertise for the first time in its history.

Three initiatives now under way translate that alignment into concrete growth for the Company:

- Backward integration into castings — two fully integrated manufacturing locations under direct ownership. The proposed merger of M/s Banil Castings Private Limited and M/s Avisia Private Limited into National Fittings Limited — approved by the Board on 22nd May, 2026 and now progressing through statutory and judicial approvals — brings the Company's principal casting supplier directly onto the Company's own balance sheet. On completion, National Fittings Limited will have two manufacturing locations — Goa and Gujarat — each 100% fully integrated, meaning each independently carries out both casting and finishing, and each under the Company's direct ownership and control. Neither location is dependent on the other for casting or finishing. This gives the Company genuine diversification and de-risking of its manufacturing supply chain, with both ends of the process under its own direct control at two separate sites, rather than depending on a single site or an external, related-party casting supplier. This is expected to secure raw material supply and remove a layer of related-party dependency that has historically sat outside the listed entity.
- New capacity in Gujarat — a 100% fully integrated facility in its own right, and a step-change in scale. The Company to build a new, fully integrated manufacturing facility at Village Mudhela, Gujarat, independently capable of both casting and finishing, with a total capacity of 2,500 MT per month (approximately 30,000 MT per annum) — over four times the Company's current capacity of 600 MT per month (approximately 7,200 MT per annum). Gujarat was selected over the Company's existing Tamil Nadu locations for the ready availability of power, labour and raw material — availability that Tamil Nadu does not offer to the same degree. Together with the Goa location under direct ownership through the Banil Castings merger — also 100% fully integrated — this gives the

Company two complete, independent manufacturing bases, reducing the quality and logistics risk that comes with depending on a single site or on an external, related-party casting supplier.

- A registered office aligned with the Company's operating centre of gravity. The shift of the registered office from Tamil Nadu to Gujarat, completed this year with all statutory approvals in place, positions the Company's legal seat alongside its newest and largest planned manufacturing investment.
- A deliberate shift toward the Indian domestic market, anchored in new R&D capability. The GCC remains a strategically important market for the Company, but the domestic market is where the Company has under-captured its own growth story. Alongside a dedicated national sales team and — critically — a new in-house Research & Development team, the Company has begun building the domestic regulatory approvals and new export markets needed to put its newly expanded manufacturing capacity to full use. Next Section sets this out in full.

Taken together, these are not four separate initiatives but one integrated strategy: bring casting supply inside the Company as a fully integrated second manufacturing location in Goa, build a new single-location, fully integrated facility in Gujarat, govern both from the same registered office, and sell increasingly into India's own infrastructure growth. The near-term milestones for the manufacturing and merger initiatives are set out below.

We enter FY 2026-27 with a stronger balance sheet, a promoter group whose core expertise complements our own, and a clear, funded path to greater manufacturing self-sufficiency. Our priorities for the year ahead are to complete the Banil Castings and Avisa merger, commission the Gujarat facility on schedule, secure the domestic approvals described in the next Section, and convert the resulting capacity, supply security and market access into sustained, profitable revenue growth — increasingly from India's own infrastructure investment cycle.

On behalf of the Board, I thank our employees for their dedication, our customers and distributors for their continued confidence, our new promoter group for the expertise and capital they bring, and our shareholders for their trust as we build this next phase of growth.

Strengthening Focus on the Indian Domestic Market

National Fittings is, to the Board's knowledge, the only 100% Made-in-India OEM manufacturing grooved piping products of this kind in the country. Despite that, and despite the exceptional pace of India's own infrastructure investment over the past decade, the Company has not been at the forefront of that growth. A meaningful share of the domestic market the Company is capable of serving has instead gone to imported products. The Board considers closing that gap — converting the Company's genuine Made-in-India status into actual order share — the single most important reason to build a much stronger domestic presence, and this is now the Company's central strategic priority.

The Company's export business has historically been anchored in the Gulf Cooperation Council (GCC) region, and the GCC remains, and will continue to remain, a strategically important market for the Company. That said, the regional conflict that erupted in the Gulf on 28 February 2026 — since eased by an April ceasefire and a June diplomatic framework — caused real disruption this year, and underlined that growth cannot rest on any single market alone, however important that market is to the Company. Building a stronger

Indian business is therefore not a retreat from the GCC, but an addition to it: growth the Company has been leaving on the table, and the right response to a year in which even a core, strategic market proved it could be disrupted.

The Company's response has two parts. First, an in-house Research & Development team, established this year, to develop and qualify products against the specifications India's infrastructure and defence projects require. Second, a national sales team to take those products directly to India's project owners and contractors. Together, these are what will let the Company compete for domestic orders on the strength of its Made-in-India manufacturing base, rather than continuing to lose share to imports on price alone.

This is not a standing start. National Fittings' products have already been supplied for metro railway projects, tunnel projects, and projects for the Airport Authority of India and Power Grid Corporation of India. Building on that record, the Company is this year seeking the following formal vendor and product approvals, each of which opens a further tranche of government and PSU infrastructure tenders where genuinely domestic manufacturers are given preference:

The Company's expanded manufacturing capacity in Gujarat adds a second, compounding reason for this diversification. At 2,500 MT per month, the new facility alone represents over four times the Company's current capacity — a scale of output the GCC market, important as it is, is unlikely to absorb on its own. Building demand in India and in new export markets — Canada, South America and Africa — alongside, not instead of, the Company's continued focus on the GCC, is therefore necessary both for resilience and to put the Company's new capacity to full use. The priority for the year ahead is to convert the Company's status as the country's only 100% Made-in-India OEM in this category, and its newly expanded capacity, into sustained order growth across all of these markets.

FINANCIAL PERFORMANCE:

The Company's income for the financial year ended 31st March, 2026 was Rs. 9618.57 lacs compared to Rs. 8109.95 lacs in the previous year. The profit before tax for the Company is Rs 1304.49. lacs as against Rs. 2623.56 lacs in the previous year. Last year profit included one-time exceptional gain arrived from the sale of foundry Units. The depreciation for the year is Rs 294.55 lacs compared to Rs. 295.00 lacs in the previous year. After providing Taxation, the Company's net profit stands at Rs 910.68 lacs as against Rs. 2330.34 lacs in the previous year.

An amount of Rs 6323.06 lacs is to be carried over to Balance Sheet.

The Net worth of the company is at Rs. 8905.31 lacs as on 31.03.2026 as against Rs. 8097.58 lacs in the previous year.

DIVIDEND

The Board of Directors has recommended a dividend of Re 1/- per Equity shares on 90,83,182 Equity shares of Rs 10/- each aggregating to Rs 90.83 lacs for the financial year ended 31.03.2026, (Previous year – Rs 90.83 lacs) which if approved by the shareholders in the ensuing Annual General Meeting will be paid to all the Equity shareholders, whose name appear in the Register of Members as on 09th September, 2026 and will be paid to the shareholders on or before 15.10.2026.

CHANGE OF PROMOTER AND PROMOTER GROUP

On 22.05.2025 the promoter of the Company, Mr A V Palaniswamy had conveyed his intention to divest his entire shareholding i.e. 30,92,093 fully paid-up equity shares, comprising 34.04% of the total paid-up capital of our Company, to M/s Himgiri Castings Pvt Limited ("Acquirer"), along with Persons Acting in Concert (PAC). The acquirer M/s Himgiri Castings Pvt Limited made an open offer on 10.09.2025 which ended on 08.10.2025. 31 equity shares had been acquired in the open offer.

Mr A V Palaniswamy sold his entire shareholding to M/s Himgiri Castings Pvt Limited ("Acquirer"), along with Persons Acting in Concert (PAC) on 18.10.2025 and seek reclassification of his status from Promoter to Public Category. M/s Himgiri Castings Private Limited with 556608 Equity Shares (6.13%) is now the promoter of the Company and the Persons Acting Concert by holding 2535516 Equity Shares (27.91%) are in the Promoter Group.

The re-classification of Mr Palaniswamy was approved by the shareholders resolution dated 25.12.2025 and on 04.02.2026 he was classified as public shareholder.

SHIFTING OF REGISTERED OFFICE OF THE COMPANY

The Company took step to shift its registered office from Tamil Nadu to Gujarat and was approved by the shareholders of the company through Postal Ballot on 12.02.2026. The Regional Director, Chennai was approved the shifting of registered office by his order dated 02.04.2026. Moreover, the Registrar of Companies, Ahmedabad issued a Certificate of Registration on 30.04.2026 for Change of Registrar Office of the State based on Regional Director, Chennai's order. The new registered office is at 314/315 Village Mudhela, Taluka, Savli, Savli, Vadodara - 391770, Gujarat, India and the new CIN is L29199GJ1993PLC177328.

NEW MANUFACTURING FACILITY, GUJARAT

The Company is establishing a new manufacturing unit at Village Mudhela, Gujarat, designed as a single-location, fully integrated facility — taking raw casting through to finished, machined pipe fittings and valves for industrial and non-industrial applications — with a total capacity of 2,500 MT per month (approximately 30,000 MT per annum) — over four times the Company's current capacity of 600 MT per month (approximately 7,200 MT per annum). The Company is investing in the facility across two phases. Phase I involving 60 crores already started.

Gujarat was chosen as the location for this facility, in preference to expanding at the Company's existing Tamil Nadu locations, primarily for the ready availability of power, labour and raw material in the region — availability that Tamil Nadu does not offer to the same degree. On completion, this facility is expected to be the Company's largest single manufacturing investment to date, and the single largest step-change in capacity in the Company's history.

The Company proposed to utilise the funds available from the sale of factory units at Thekkalur and Dindigul during 2024-25.

PROPOSED MERGER OF BANIL CASTINGS PRIVATE LIMITED AND AVISA PRIVATE LIMITED

The Board of Directors, on 22.05.2026, approved a Scheme of Arrangement for the merger of M/s Banil Castings Private Limited and M/s Avisa Private Limited into the Company. Banil Castings, located in Goa, currently supplies rough-iron-casting components to the Company. Avisa Private Limited holds the leasehold land at Village Mudhela, Gujarat, on which the Company's new manufacturing facility described in Section 8 above is being constructed. On completion of the Scheme, the Company will have two manufacturing locations under direct ownership — Goa and Gujarat — each 100% fully integrated, meaning each independently carries out both casting and finishing rather than depending on the other. This gives the Company direct control over both ends of its manufacturing process at two separate sites: genuine diversification and de-risking of its manufacturing supply chain, in place of the related-party arrangements that have historically sat outside the listed entity. The Company has filed the necessary application with BSE Limited for a No Objection Certificate, and the Scheme remains subject to the requisite statutory and judicial approvals.

PERFORMANCE:

Due to the change of promoter and promoter group various re-structuring initiative being carried out by the Company.

We expect this to have a positive impact on the supplies and improve the sales level.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

1. Financial and Operational Performance

FY26 was a year of strong operational progress for National Fittings Limited, reflecting the benefits of the strategic initiatives undertaken over the past two years.

Revenue from Operations increased by 16.98% to ₹91.40 crore, while Total Income increased by 18.61% to ₹96.19 crore, representing the highest annual revenue achieved by the Company. Improved demand across domestic and export markets, coupled with better operational efficiencies and enhanced manufacturing utilisation, contributed to this growth.

The Company's underlying profitability improved significantly during the year. Profit Before Tax before exceptional items increased by 85.8%, from ₹7.02 crore in FY25 to ₹13.04 crore in FY26, demonstrating the positive impact of operational consolidation, improved cost management and a stronger product mix.

Reported Profit Before Tax and Profit After Tax are lower than the previous year as FY25 included an exceptional gain arising from the sale of manufacturing assets as part of the Company's restructuring programme. Accordingly, the reported profits for FY25 and FY26 are not directly comparable. On a like-for-like basis, the Company's core operating performance improved substantially during the year.

The Company continued to maintain a strong financial position with shareholders' funds increasing to ₹89.05 crore and cash and cash equivalents remaining healthy at ₹44.23 crore, providing adequate financial flexibility to support future growth opportunities.

2. Strategic Developments

FY26 marked an important milestone in the Company's strategic evolution.

The successful completion of the change in the Company's promoter group following receipt of all regulatory approvals introduce a promoter group M/s Himgiri Castings Private Limited with over 40 years of experience in the pipe fittings and castings industry. This represents a strong strategic alignment with the Company's core business, as castings constitute one of the principal raw material inputs for its products. The new promoter group's extensive manufacturing expertise is expected to strengthen the Company's capabilities through greater backward integration, improved manufacturing processes, enhanced quality consistency and stronger supply chain resilience.

During the year, the Board also approved a Scheme of Arrangement for the merger of M/s Banil Castings Private Limited and M/s Avisa Private Limited with National Fittings Limited. The proposed merger is currently progressing through the statutory approval process and is expected to further strengthen the Company's manufacturing platform through greater operational integration.

The proposed integration is expected to improve coordination between casting and downstream manufacturing operations, optimise procurement, enhance production planning and strengthen long-term competitiveness while supporting sustainable and profitable growth.

3. Market Environment

Demand conditions improved during FY26, contributing to the Company's highest-ever annual revenue. Export markets continued to remain an important contributor to business, while domestic infrastructure investments created additional growth opportunities.

We continue to focus on specialised grooved piping products where our quality, manufacturing capabilities, certifications and customer service differentiate us from lower-cost competition. Our ability to manufacture technically demanding and specialised products enables us to maintain longstanding customer relationships across domestic and international markets.

The Company also continues to benefit from increasing awareness of quality standards, growing infrastructure investments and the continued adoption of reliable mechanical piping systems across industrial and commercial applications.

RISK MANAGEMENT AND FUTURE OUTLOOK

The Company continues to monitor both domestic and international developments that could influence its operating environment.

Geopolitical Environment

The Middle East remains one of the Company's important export markets. While infrastructure investments across the region continue to present significant opportunities, ongoing geopolitical developments have the potential to affect project execution schedules, customer purchasing decisions, logistics and freight costs. We continue to work closely with our customers and distribution partners to minimise any potential disruptions while maintaining the flexibility to respond to changing market conditions.

International Trade

Recent changes in tariff policies and global trade dynamics have the potential to alter competitive conditions across several export markets. While these developments may create new opportunities for Indian manufacturers in certain regions, the eventual response of competing suppliers through pricing, sourcing and market strategies remains uncertain. The Company continues to closely monitor these developments and remains committed to maintaining its competitiveness through product quality, operational efficiency and customer service.

Foreign Exchange

As an export-oriented business, the Company remains exposed to fluctuations in foreign exchange rates. Management continues to closely monitor currency movements while maintaining a balanced approach between domestic and export sales to mitigate the impact of exchange rate volatility. Raw Material and Supply Chain Castings remain one of the Company's principal raw material inputs. The completed promoter transition and the proposed integration of casting operations are expected to strengthen supply chain resilience, improve manufacturing coordination and reduce long-term procurement risks through greater backward integration. The Company also continues to diversify its supplier base and optimise inventory management to minimise supply chain disruptions.

Outlook

FY26 represents the completion of one phase in National Fittings Limited's evolution and the beginning of another.

The operational restructuring undertaken over recent years has translated into stronger operating performance, improved profitability and record revenues. The successful transition to the new promoter group introduces significant industry expertise that complements the Company's existing strengths, while the proposed merger of Banil Castings Private Limited and Avisa Private Limited is expected to further strengthen manufacturing integration and operational efficiency.

Although geopolitical developments and evolving global trade policies continue to create uncertainty, we believe the Company is well positioned to navigate these challenges through its strengthened balance sheet, integrated manufacturing strategy, diversified customer base and continued focus on quality and customer service.

As we enter FY27, we remain committed to building on the strong foundation established over the past several years. Our priorities continue to be operational excellence, profitable growth, manufacturing integration and long-term value creation for our shareholders and all other stakeholders.

SIGNIFICANT CHANGES

Operating profit and net profit margin increased over previous year due to increase in selling prices in the export and domestic markets and also due to increase in Turnover and other income.

Capital expenditure to the extent of 3.09 Crores was done during the year in the infrastructure and on Valve design, machines, tooling.

Debtors, Inventories, turnover ratio, current sale ratio and debt equity ratio has not changed significantly over the previous year.

As indicated above Return on Net Worth was also affected compared to previous year. Ratios are detailed in Note 2.32 of the Notes to the Financial Statements.

DIRECTORS

Mr Anil Kumar Agarwal was appointed as Non-Executive Non-Independent Director and Mr Arpit Agarwal was appointed as Managing Director on 18.10.2025. Their appointments were approved by the shareholders of the company through Postal Ballot on 24.12.2025

Mr Jayaram Govindarajan has also been appointed as Managing Director with effect from 18.10.2025

Mr Arpit Agarwal, Director, who retires by rotation, and being eligible, offered himself for reappointment.

1.1 Corporate Information

National Fittings Limited (referred to as “the Company”) manufacture and sells SG Iron Grooved and Screwed Pipe Fittings, Stainless Pipe Fittings and Ball Valves for industrial and non-industrial applications.

The Company is a Public limited company incorporated and domiciled in India, whose shares are publicly traded.

1.2 Significant accounting policies

a) Statement of compliance

The Standalone Financial Statements comply, in all material aspects, with Indian Accounting Standards ('Ind AS') notified under Section 133 of the Companies Act, 2013 ('the Act') read with Rule 3 of the Companies (Indian Accounting Standards) Rules, 2015 and other relevant provisions of the Act.

b) Basis of Preparation

These financial statements have been prepared in accordance with the Generally Accepted Accounting Principles in India ('Indian GAAP') to comply with the Accounting Standards specified under Section 133 of the Companies Act, 2013, read with Rule 7 of the Companies (Accounts) Rules, 2014 and the relevant provisions of the Companies Act, 2013. The financial statements have been prepared under the historical cost convention on accrual basis, except for certain items which are measured at fair value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date, regardless of the price is directly observable or estimated using another valuation technique.

All assets and liabilities have been classified as current or non current as per the Company's normal operating cycle and other criteria set out in the Schedule III of the Companies Act, 2013 and Ind AS, based on the nature of products and the time between the acquisition of assets or processing and their realisation in cash and cash accruals

c) Property, plant and equipment

Property, plant and equipment are stated at cost, less accumulated depreciation and impairment loss, if any. Depreciation is provided for property, plant and equipment so as to expense the cost less residual value over their estimated useful lives based on technical evaluation. The estimated useful lives and residual value are reviewed at the end of each reporting period, with the effect of any change in estimate accounted for on a prospective basis.

Depreciation on tangible assets is provided on the straight-line method over the useful lives of assets as prescribed under Part C of Schedule II of the Companies Act 2013 except for Building and Plant and Machinery for which the Management estimates the useful lives as follows:

(1)	For these Building and Plant and Machinery, based on the internal assessment and independent technical evaluation carried out by the management, the useful lives as given above represent the period over which management expects to use these assets. Hence useful lives of these assets is different from the part C of Schedule II of the Companies Act, 2013. Depreciation is not recorded on capital work In progress until construction and installation is complete and the asset is ready for its intended use.

d) Intangible assets

Intangible assets that the Company controls and from which Intangible Assets that the Company controls and from which it expects future economic benefits are capitalised upon acquisition and measured initially:

- a. for assets acquired in a business combination, at fair value on the date of acquisition.
- b. for separately acquired assets, at cost comprising the purchase price (including import duties and non-refundable taxes) and directly attributable costs to prepare the asset for its intended use.

e) Leases

The determination of whether an arrangement is (or contains) a lease is based on the substance of the arrangement at the inception of the lease. The arrangement is, or contains, a lease if fulfillment of the arrangement is dependent on the use of a specific asset or assets and the arrangement conveys a right to use the asset or assets, even if that right is not explicitly specified in an arrangement.

(i) As a lessee

A lease is classified at the inception date as a finance lease or an operating lease. Leases of property, plant and equipment where the company, as lessee, has substantially all the risks and rewards of ownership are classified as finance leases.

Leases in which a significant portion of the risks and rewards of ownership are not transferred to the Company as lessee are classified as operating leases. Payments made under operating leases are charged to profit or loss on a straight-line basis over the period of the lease unless the payments are structured to increase in line with expected general inflation to compensate for the lessor's expected inflationary cost increases.

(ii) As a lessor

Leases are classified as finance leases when substantially all of the risks and rewards of ownership transfer from the Company to the lessee. Amounts due from lessees under finance leases are recorded as receivables at the Company's net investment in the leases. Finance lease income is allocated to accounting periods so as to reflect a constant periodic rate of return on the net investment outstanding in respect of the lease.

Lease income from operating leases where the company is a lessor is recognised in income on a straight-line basis over the lease term unless the receipts are structured to increase in line with expected general inflation to compensate for the expected inflationary cost increases. The respective leased assets are included in the balance sheet based on their nature.

Expected credit losses are assessed and loss allowances recognised if the credit quality of the financial asset has deteriorated significantly since initial recognition
g) Investments	Long-term investments , are carried individually at cost less provision for diminution, other than temporary, in the value of such investments. Current investments are carried individually, at the lower of cost and fair value. Cost of investments include acquisition charges such as brokerage, fees and duties.
h) Employee benefits	Short Term Employee Benefits All employee benefits payable within twelve months of rendering the services are recognized in the period in which the employee renders the related service. Post Employment / Retirement Benefits Defined Contribution Plans such as Provident Fund etc., are charged to the Profit and Loss account as incurred. Defined Obligation Plans - The Present Value of the obligation under such plans, is determined based on an actuary valuation, using the Projected Unit Credit Method. Actuarial gains and losses arising on such valuation are recognized immediately in the Profit and Loss account. Other Long Term Employee Benefits are recognized in the same manner as Defined Benefit Plans. Termination Benefits Termination Benefits are recognized as and when incurred.

Deferred tax assets and liabilities are offset when there is legally enforceable right to offset current tax assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on net basis, or to realize the asset and settle the liability simultaneously. k) Foreign currency transactions The Functional and presentation currency of the Company is Indian Rupee. - The transactions involving Foreign Currencies are accounted for at the rates prevailing on the date of transactions and accordingly Gains/(Losses) arising out of fluctuation in exchange rates are recognized in the Profit & Loss Statement - In case of forward contracts, if any, the difference between the forward rate and the exchange rate at the prevailing period is recognized in the Profit & Loss Statement over the life of the contract. - Foreign currency monetary Assets & Liabilities such as cash, receivables, payables etc., are translated at the exchange rate prevailing at the year end and overall net gain/loss is adjusted to the Profit & Loss Statement. - Non-monetary items denominated in foreign currency such as investment, fixed assets etc., are valued at the exchange rate prevailing on the date of transactions l) Inventories Inventories of Raw Materials, Stores and Spares parts, Work in progress and Finished goods are valued at the lower of cost ascertained on weighted average cost basis and the net realisable value after providing for obsolescence and other losses, where considered necessary. Cost includes all charges in bringing the goods to the point of sale, including octroi and other levies, transit insurance and receiving charges. Work-in-progress and finished goods include appropriate proportion of overheads .

Provisions (excluding retirement benefits) are not discounted to their present value and are determined based on the best estimate required to settle the obligation at the Balance Sheet date. These are reviewed at each Balance Sheet date and adjusted to reflect the current best estimates. Contingent liabilities are disclosed in the Notes. Contingent assets are neither recognised or disclosed in the financial statements.
n) Dividend Distribution	Dividends paid (including income tax thereon) are recognised in the period in which the interim dividends are approved by the Board of Directors, or in respect of the final dividend when approved by shareholders.
o) Earnings per share	Basic and diluted earning per share is computed by dividing the profit / (loss) after tax (including the post tax effect of extraordinary items, if any) by the weighted average number of equity shares outstanding during the year.
p) Segment reporting	The Company identifies primary segments based on the dominant source, nature of risks and returns and the internal organisation and management structure. The operating segments are the segments for which separate financial information is available and for which operating profit/loss amounts are evaluated regularly by the Executive Management in deciding how to allocate resources and in assessing performance. The accounting policies adopted for segment reporting are in line with the accounting policies of the Company. Segment revenue, segment expenses, segment assets and segment liabilities have been identified to segments on the basis of their relationship to the operating activities of the segment. Inter-segment revenue is accounted on the basis of transactions which are primarily determined based on market / fair value factors. Revenue, expenses, assets and liabilities which relate to the Company as a whole and are not allocable to segments on reasonable basis have been included under “unallocated revenue / expenses / assets / liabilities”.
q) Cost recognition	Cost and expenses are recognised when incurred and have been classified according to their nature. The borrowing cost represents interest payable on loans taken for carrying out business operations and the same is charged to revenue.

r) Financial instruments, Financial Assets, Financial Liabilities

Financial assets and financial liabilities are recognised when a Company becomes a party to the contractual provisions of the instruments.

Initial Recognition

Financial assets and financial liabilities are initially measured at fair value. Transaction costs that are directly attributable to the acquisition or issue of financial assets and financial liabilities (other than financial assets and financial liabilities at fair value through profit or loss and ancillary costs related to borrowings) are added to or deducted from the fair value of the financial assets or financial liabilities, as appropriate, on initial recognition. Transaction costs directly attributable to the acquisition of financial assets or financial liabilities at fair value through profit or loss are recognised immediately in Statement of Profit and Loss.

Classification and Subsequent Measurement: Financial Assets

The Company classifies financial assets as subsequently measured at amortised cost, fair value through other comprehensive income ("FVOCI") or fair value through profit or loss ("FVTPL") on the basis of following:

the entity's business model for managing the financial assets and

the contractual cash flow characteristics of the financial asset.

(i) Amortised Cost

A financial asset shall be classified and measured at amortised cost if both of the following conditions are met:

- the financial asset is held within a business model whose objective is to hold financial assets in order to collect contractual cash flows and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(ii) Fair Value through other comprehensive income

A financial asset shall be classified and measured at fair value through OCI if both of the following conditions are met:

- the financial asset is held within a business model whose objective is achieved by both collecting contractual cash flows and selling financial assets and
- the contractual terms of the financial asset give rise on specified dates to cash flows that are solely payments of principal and interest on the principal amount outstanding.

(iii) Fair Value through Profit or Loss

A financial asset shall be classified and measured at fair value through profit or loss unless it is measured at amortised cost or at fair value through OCI.

All recognised financial assets are subsequently measured in their entirety at either amortised cost or fair value, depending on the classification of the financial assets.

Classification and Subsequent Measurement: Financial liabilities

Financial liabilities are classified as either financial liabilities at FVTPL or 'other financial liabilities'.

(i) Financial Liabilities at FVTPL

Financial liabilities are classified as at FVTPL when the financial liability is held for trading or are designated upon initial recognition as FVTPL. Gains or Losses on liabilities held for trading are recognised in the Statement of Profit and Loss.

(ii) Other Financial Liabilities:

Other financial liabilities (including borrowings and trade and other payables) are subsequently measured at amortised cost using the effective interest method.

The effective interest method is a method of calculating the amortised cost of a financial liability and of allocating interest expense over the relevant period. The effective interest rate is the rate that exactly discounts estimated future cash payments (including all fees and points paid or received that form an integral part of the effective interest rate, transaction costs and other premiums or discounts) through the expected life of the financial liability, or (where appropriate) a shorter period, to the net carrying amount on initial recognition.

Impairment of financial assets

Financial assets, other than those at FVTPL, are assessed for indicators of impairment at the end of each reporting period. The Company recognises a loss allowance for expected credit losses on financial asset. In case of trade receivables, the Company follows the simplified approach permitted by Ind AS 109 – Financial Instruments for recognition of impairment loss allowance. The application of simplified approach does not require the Company to track changes in credit risk. The Company calculates the expected credit losses on trade receivables using a provision matrix on the basis of its historical credit loss experience.

Derecognition of financial assets

The Company derecognises a financial asset when the contractual rights to the cash flows from the asset expire, or when it transfers the financial asset and substantially all the risks and rewards of ownership of the asset to another party. If the Company neither transfers nor retains substantially all the risks and rewards of ownership and continues to control the transferred asset, the Company recognises its retained interest in the asset and an associated liability for amounts it may have to pay. If the Company retains substantially all the risks and rewards of ownership of a transferred financial asset, the Company continues to recognise the financial asset and also recognises a collateralised borrowing for the proceeds received.

On derecognition of a financial asset in its entirety, the difference between the asset's carrying amount and the sum of the consideration received and receivable and the cumulative gain or loss that had been recognised in other comprehensive income and accumulated in equity is recognised in profit or loss if such gain or loss would have otherwise been recognised in profit or loss on disposal of that financial asset.

Derecognition of financial liabilities

A financial liability is derecognized when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially

different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognized in the statement of profit or loss.

Equity investment in subsidiaries, joint ventures and associates

Investment in subsidiaries, joint ventures and associates are carried at cost. Impairment recognized, if any, is reduced from the carrying value.

Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

Derivative financial instruments

Derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently re-measured at fair value. Derivatives are carried as financial assets when the fair value is positive and as financial liabilities when the fair value is negative.

1.3 Use of estimates

The preparation of financial statements requires the management of the Company to make estimates and assumptions that affect the reported balances of assets and liabilities and disclosures relating to the contingent liabilities as at the date of the financial statements and reported amounts of income and expense during the year. Future results could differ due to changes in these estimates and the difference between the actual result and the estimates are recognised in the period in which the results are known / materialise.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

1.5 Recent Indian Accounting Standard (Ind AS) pronouncements which are not yet effective

Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time.

In May 2025, MCA notified amendments to Ind AS 21 - The Effects of Changes in Foreign Exchange Rates, applicable w.e.f. April 1, 2025. The Company has reviewed the amendment and based on its evaluation has determined that it does not have any significant impact in its financial statements.

In August 2025, MCA notified the following amendments to:

- a. Ind AS 1, Presentation of Financial Statements, applicable w.e.f. April 1, 2025 – The amendment relates to classification of liabilities as current or noncurrent and non-current liabilities with covenants. In the context of classifying a liability as current, it removes the requirement of existence of a right to defer settlement for atleast 12 months after the reporting date and instead requires that the said right should exist on the reporting date and have substance. The amendment also introduces guidance on classification of liabilities with covenants. The Company has no impact of these amendments in its classification criteria of current and non-current liabilities.
- b. Ind AS 7, Statement of Cash Flows and Ind AS 107, Financial Instruments: Disclosures, applicable w.e.f. April 1, 2025 – The amendment in Ind AS 7 requires to inform users of financial statements of the existence of supplier finance arrangements and explain the nature of the arrangements, the carrying amount of liabilities and the range of payment due dates. Ind AS 107 has been amended to add supplier finance arrangements as a factor that may cause concentration of liquidity risk. The Company has reviewed the amendment and based on its evaluation has determined that it does not have any significant impact in its financial statements.
- c. Ind AS 12, International Tax Reform – Pillar Two Model Rules applicable immediately - The Company has reviewed the amendment and based on its evaluation has determined that it does not have any significant impact on its financial statements.

C) Market risk
