O R D E R

1. Respondent No.2-Union of India has filed its reply through the Ministry of Consumer Affairs, Food and Public Distribution. Reply, if any, to be furnished by the Union of India through the Ministry of Health and Family Welfare/Respondent No.1 and the National Medical Commission/Respondent No. 3, be filed within four weeks.
2. Rejoinder affidavit, if any, be filed within two weeks thereafter.
3. IA No.102245/2026, which seeks intervention on behalf of the Indian Orthopaedic Association, is allowed. The applicant is ordered to be impleaded as Respondent No.4.
4. IA No.118161/2026, which seeks intervention on behalf of the VOICE Society is also allowed. The applicant is ordered to be impleaded as Respondent No.5.
5. The amended memo of parties shall be filed forthwith. The newly added respondents may also file their respective counter affidavits.
