This disclosure is being submitted in reference to the email communication received from BSE Limited today i.e. on 02<sup>nd</sup> June, 2026 seeking additional details regarding the timeline of disclosure and with reference to our earlier intimation dated 01<sup>st</sup> June, 2026 and pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, read with Part A of Schedule III and SEBI Circular No. SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated 13<sup>th</sup> July, 2023, we wish to submit that the communication from the Mediation Centre, Mumbai District Legal Services Authority, City Civil & Sessions Court, Dindoshi, Mumbai, was received by the Company on Saturday, 30<sup>th</sup> May, 2026 **during the late evening.**

Since the subsequent day, i.e., 31<sup>st</sup> May, 2026, being Sunday, was a non-working day, the said communication came to the attention of the concerned officials of the Company on the next working day, i.e., 01<sup>st</sup> June, 2026. Upon review of the communication and assessment of the disclosure requirements, the Company promptly submitted the disclosure to the Stock Exchange on the same day.

The Company sincerely regrets the inadvertent delay, if any, in dissemination of the aforesaid information. The delay was neither intentional nor due to any negligence, but occurred solely on account of the communication having been received during late evening hours immediately preceding a non-working day.

We respectfully request the Exchange to kindly take the above explanation on record. The Company remains committed to maintaining the highest standards of corporate governance and regulatory compliance and shall continue to take all necessary steps to ensure timely disclosures in accordance with the applicable provisions of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015. The Company has also noted the observations of the Exchange and shall exercise due care to avoid such instances in future. The Company has always made every effort to ensure timely disclosures and compliance with all applicable regulatory requirements, and this delay was purely due to the circumstances explained above.

We request your good office to kindly take the same on record.



Further to the above, we wish to inform that the Company has received a further communication from the Mediation Centre, Mumbai District Legal Services Authority, City Civil & Sessions Court, Dindoshi, Mumbai.
