Pursuant to Regulation 30 read with sub-paragraph 20 of Paragraph A of Part A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company submitted the Intimation of Adjudication Order received from the Registrar of Companies, Goa, in XBRL format, together with the signed PDF intimation on 26th August 2026 through BSE's single-filing system. The filing was acknowledged by the National Stock Exchange of India Limited(NSE) and BSE.

During subsequent verification, the Company observed that the corresponding PDF intimation was not reflecting under the Corporate Announcements section of the NSE and BSE website.
