ORDER

Per: Bidisha Banerjee, Member (Judicial)

- 1) This Company Petition has been filed by Parmanand Singh u/s. 252(3) of the Companies Act, 2013 for restoration of name of the struck off company in the Register Of Companies, maintained in the office of the Registrar of Companies, West Bengal. It is stated that the name of N P Infotech Pvt Ltd ("Company" / "Petitioner Company") was struck off on **25/07/2012**.
- 2) It is contended that the Company had not filed the Financial Statements for the financial years ended 31/03/2007 to 31/03/2025 and Annual Returns of the Company for the financial years ended 31/03/2007 to 31/03/2025, due to inadvertent mistake whereas mistake was purely unintentional and has produced copies of the said financial statements and has produced copies of the said financial statements. It is further contended that the Company has as on 31/03/2025 current liabilities amounting to Rs 2500/- ,Investments amounting to Rs 85,26,49,500/- and Cash Equivalents amounting to Rs 27,992/- and it will be unfair to the Creditors and the Company if the company is struck-off and the Creditors do not receive their

dues. Upon the said contentions, the Ld. Counsel for the Petitioner prayed for passing of an order for restoration of the name of the appellant company.

- 3) Notices were issued to the Registrar of Companies, West Bengal. The Registrar of Companies, West Bengal has submitted a report. It was stated in the report that only after compliance of the requirements to be met under Section 248 of the Companies Act, 2013, Registrar of Companies, West Bengal has struck off the name of the company from the register.
- 4) Registrar of Companies, West Bengal has not objected to this application for restoration of the name of the company. On perusal of the application we are satisfied that the name of the company should be restored to the register.

Therefore, this petition deserves sympathetic consideration. Accordingly, the present petition is allowed on the following terms:-

- a) The Registrar of Companies, West Bengal the respondent herein, is directed to restore the original status of the petitioner company as if the name of the Company had not been struck off from the register of Companies with the resultant and consequential actions like changing status of petitioner company from 'struck off' to 'Active'.
- b) The Petitioner Company is directed to file all pending statutory document(s) including Annual Accounts for the period 31/03/2007 to 31/03/2025 and Annual returns for the period 31/03/2007 to 31/03/2025 respectively along with prescribed fees/additional fee/fine as decided by Registrar of Companies, West Bengal within 45 days from the date on which its name is restored on the register of companies maintained by the Registrar of Companies, West Bengal

- c) The restoration of the Company's name is also subject to the payment of cost of Rs.1,40,000/- (Rupees One Lakh Fourty Thousand Only) through online payment in www.mca.gov.in under miscellaneous fee by mentioning particulars as "**Payment of cost for restoration of company pursuant to orders of NCLT in CP No. 77/KB/2026**".
- d) The petitioner is directed to deliver a certified copy of this order with Registrar of Companies-1, West Bengal within thirty days of the receipt of this order.
- e) On such delivery and after due compliance with the above directions, the Registrar of Companies-1, West Bengal is directed to publish the order in the Official Gazette under his office name and seal;
- f) This order is confined to the violations, which ultimately led to the impugned action of striking off the name of the Company, and it will not come in the way
- of Registrar of Companies-1, West Bengal to take appropriate action(s) in accordance with law, for any other violations / offences, if any, committed by the petitioner company prior to or during the period the name of the Company remained struck off.
- 5) **The CP No. 77/KB/2026 is disposed** of accordingly.
- 6) The Registry is directed to send e-mail copies of the order forthwith to all the parties inclusive of the Counsel.
