ORDER

(Hybrid Mode)

08.07.2026: There is certain urgency expressed by the Appellant in these matters. Indeed, there has been some submissions made before us, and we also understand that before the predecessor Bench issue was raised as it concerns the appointment of the Resolution Professional.

2. The Adjudicating Authority has appointed certain individual as the RP in its order admitting the Corporate Debtor to CIRP. However, the RP so named was not alive on the date. Therefore, an application in IA No.1772 of 2025 came to be filed even before order under Section 7 was passed but it is appeared to have been overlooked by the Adjudicating Authority. Indeed, IA No.1772 of 2025, filed bringing it to the notice of the Adjudicating Authority and it was allowed on 19.05.2026 whereas the impugned order in the appeals were passed on 22.06.2026.

3. However, while passing the order, the Adjudicating Authority appears to have overlooked its own order passed in IA No.1772 of 2025.

4. So far as other issues are concerned, the matter will be taken up on 13.07.2026 only for the limited purpose of considering whether there is any need to give any interim relief and also nature of relief to be so given. Since the impugned order is not yet rectified to substitute the deceased RP to make the impugned order effective, the appellants are relatively in safe zone today.
