ORDER

This Application has been filed by the Administrator General and Official Trustee (AG & OT) of Tamil Nadu, seeking permission to donate a sum of Rs. 15,000/- to the account of Archagar Mr.G.Shanmuga Gurukul, from the Trust Estate of Maligai Merchants Charities for conducting Ganapathi Homam, Abishagam, Sandana Alangaram and Sampavanam and to provide Prasatham to the devotees for the Vinayagar Chathurthi Festival which falls on 14.09.2026 and to be celebrated on 19.09.2026 at Vetha Vinayagar Thirukkoil, High Court Campus, Chennai – 600 104.

2. It is seen from the report submitted by the Administrator General and Official Trustee of Tamil Nadu that as per order of this Court in A.No.2155 of 2022 in C.S.No.274 of 1899 dated 17.06.2022, the Office of AG & OT has been donating Rs.10,000/- to the Temple for daily pooja expenses and monthly salary of Archagar by name Mr.G.Shanmuga Gurukul. It is also seen that Mr.Shanmuga Gurukkal has sent a letter dated 02.09.2026 seeking donation of Rs.15,000/- for celebration of Vinayagar Chathurthi Festival. Such request of Archagar was entertained by this Court on several occasions previously, by granting donation for the said purpose.



3. In view of the report of AG & OT, this Application is allowed. AG & OT of Tamil Nadu is hereby permitted to donate a sum of Rs. 15,000/- (Rupees Fifteen Thousand Only) from the Trust Estate of Maligai Merchants Charities to the account of Archagar Mr.G.Shanmuga Gurukul for conducting Vinayagar Chathurthi Festival, so as to perform Ganapathi Homam, Abishagam, Sandana Alangaram and Sampavanam and to provide Prasatham to the devotees on the day of celebration **(19.09.2026)**. Though Vinayagar Chathurthi Festival fell on 14.09.2026, Festival is going to be celebrated at Vetha Vinayagar Thirukkoil, High Court Campus, Chennai on **19.09.2026**.
