Pursuant to Regulation 30 read with Sub-para (20) of Para A of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, we wish to inform that the Company has received a communication/penalty notice from the Executive Engineer, Electricity Distribution Division, Paschimanchal Vidyut Vitran Nigam Limited (PVVNL), Sikandrabad, District Bulandshahr, Uttar Pradesh, in relation to alleged delayed renewal/submission of Bank Guarantees towards Additional Security Deposit.

The Company has disputed the alleged penalty and is in the process of making suitable representation/ appeal and exploring legal remedies, as the alleged penalty was due to the delay by the Electricity distribution in conveying the amount of guarantee required and providing approval of the change of guarantee issuing bank.
