UPON hearing the counsel the Court made the following
O R D E R

1. We are not inclined to interfere with the impugned judgment and order of

the High Court; hence, the special leave petition is dismissed.

2. However, we make it clear that since proceedings before the Arbitrator have been pending at its instance, the petitioner shall be free to urge the Arbitrator to independently assess the market value of the acquired land bearing in mind the provisions contained in Section 19(10) of the Maharashtra Highways Act, 1955, without being influenced by the determination of market value thereof by the District Level Committee on the ground urged before us, i.e., such Committee having no statutory sanction, has no authority to so determine.

3. Pending interlocutory application(s), if any, shall stand disposed of.
