We hereby inform you that, the 47th Annual General Meeting (AGM) of the Members of the Company will be held on Tuesday, 29th September, 2026 at 1:00 P.M. at the Registered office of the Company at 3, Bentinck Street, 2nd Floor, Kolkata -700 001. The Company has engaged the services of Central Depository Services (India) Limited (CDSL) for facilitating voting by electronic means.

Remote E-Voting:

We further wish to intimate that in terms of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration Rules) 2014 as amended and Regulation 44 of the Listing Regulations, the Company shall provide its Members the facility to exercise the votes electronically for transacting the items of business, as per details set out in the Notice convening the ensuing 47th Annual General Meeting of the Company. The remote e-voting period commence on Saturday, 26.09.2026 (9:00 A.M.) and ends on Monday, 28.09.2026 (5:00 P.M.). During this period, members of the Company, holding shares as on the cut-off date 22.09.2026 may cast their vote by remote e-voting. The remote e-voting module shall be disabled by CDSL after 5:00 PM on the closing date.

Cut-off date (record date):

The cut-off date (record date), for determining Members eligible for vote at the said ensuing AGM, has been fixed to be on 22nd September, 2026.

Book Closure Date:

Pursuant to Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 the Register of Members and Share Transfer Books of the Company will remain closed from 23rd September, 2026 to 29th September, 2026 (both days inclusive), for taking record of Members of the Company for the purpose of ensuing AGM.

1. Additional information for items 2 and 3 as required under Regulations 36(3) and 36(5) of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") and Clause 1.2.5 of the Secretarial Standards -2 ("SS-2") is annexed to the Notice.
2. A member entitled to attend and vote is also entitled to appoint a proxy to attend and vote instead of himself and such proxy need not be a member of the company. Proxies in order to be effective must be received by the company at its registered office not less than 48 hours before the meeting. A person can act as a proxy on behalf of members not exceeding fifty and holding in aggregate not more than ten percent of total share capital of the Company. A member holding more than ten percent of the total share capital of the Company carrying voting rights may appoint a single person as proxy and such person shall not act as proxy for any other person or member.
3. Proxies submitted on behalf of Limited Companies, Body Corporate, Societies etc. must be supported by appropriate resolution / authority, as applicable. Blank Proxy form is attached.
4. Route-map to the venue of the Meeting is provided in the notice for the convenience of the members.
5. Corporate members intending to send their Authorized Representatives to attend the Meeting are requested to send to the Company a certified copy of the Board resolution authorizing their representative to attend and vote on their behalf at the meeting.

Brief resume of the Director being re-appointed, nature of the expertise in specific functional areas, names of Indian Public Limited Companies in which she holds directorship and membership/Chairmanship of Board Committees, shareholding and relationships between directors inter-se as stipulated under regulation 36(3) SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 are provided in the notice forming part of Annual Report.
8. The Company's shares are listed on BSE Ltd. and The Calcutta Stock Exchange Ltd. with scrip Code 538895 and 10012144 are respectively.
9. All documents referred to in the accompanying Notice shall be open for inspection at the Registered Office of the Company during office hours on all working days except Sundays and Holidays between 11:00 a.m. and 1:00 p.m. up to the date of the Annual General Meeting.

The format of Register of Members prescribed by Ministry of Corporate Affairs under the Act requires the Company/Registrar and Share Transfer Agents to record additional details of Members, including their PAN details, e-mail address, bank details for payment of dividend, etc. A form requesting for such additional details is appended to this Notice. Members holding shares in physical form are requested to submit the form duly filled into the Company or ABS Consultant Private Limited.
11. Members are requested:

 - iii. To notify immediately any change in your address (including pincode), bank details to Company/RTA in case the shares are held in physical form; and
 - iv. In case the shares held in dematerialized form please update any change in your address (including pin code), bank details to your respective Depository Participant.
12. **Voting through electronic means**
In compliance with provisions of Section 108 of the Companies Act, 2013 read with Rule 20 of the Companies (Management and Administration) Rules, 2014, as amended from time to time and Regulation 44 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Members are provided with the facilities to cast their votes on all resolutions set forth in the Notice of the Annual General Meeting using electronic means and business may be transacted through remote e-voting. The Company has engaged the service of Central Depository Services (India) Ltd. (CDSL) as the authorized agency to provide the remote e-voting facilities.

The facility for voting through ballot paper shall be made available at the Annual General Meeting and the members attending the meeting who have not cast their vote by remote e-voting shall be able to exercise their right at the meeting through ballot paper.

The members who have cast their vote by remote e-voting prior to the Annual General Meeting may also attend the Annual General Meeting but shall not be entitled to cast their vote again.

The notice of the e-voting process along with printed Attendance Slip and Proxy Form is being dispatched to all the Members. The e-voting particulars are provided at the bottom of the Attendance Slip.

The Instructions for E-Voting are as under:

- (i) The remote e-voting period begins from 26-09-2026 from 9.00 A.M. and ends on 28-09-2026 till 5.00 P.M. During this period, shareholders' of the Company, holding shares either in physical form or in dematerialized form, as on the cut-off/entitlement date of 22-09-2026 may cast their vote electronically. The remote e-voting module shall be disabled by Central Depository Services (India) Ltd. for voting thereafter.
- (ii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' resolutions. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level.

Currently, there are multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India. This necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/websites of Depositories/Depository Participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

- (iii) In terms of SEBI circular no. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated December 9, 2020 on e-Voting facility provided by Listed Companies, Individual shareholders holding securities in demat mode are allowed to vote through their demat account maintained with Depositories and Depository Participants. Shareholders are advised to update their mobile number and email Id in their demat accounts in order to access Voting facility.

Pursuant to above said SEBI Circular, Login method for e-Voting and joining virtual meetings for Individual Shareholders holding securities in Demat mode is given below:

(x) Click on the “ RESOLUTIONS FILE LINK ” if you wish to view the entire Resolution details.

(xi) After selecting the resolution, you have decided to vote on, click on “SUBMIT”. A confirmation box will be displayed. If you wish to confirm your vote, click on “OK”, else to change your vote, click on “CANCEL” and accordingly modify your vote.

(xii) Once you “CONFIRM” your vote on the resolution, you will not be allowed to modify your vote.

(xiii) You can also take a print of the votes cast by clicking on “Click here to print” option on the Voting page.

(xv) If a demat account holder has forgotten the login password then Enter the User ID and the image verification code and click on Forgot Password & enter the details as prompted by the system.

(xvi) Facility for Non-Individual Shareholders and Custodians Remote Voting:

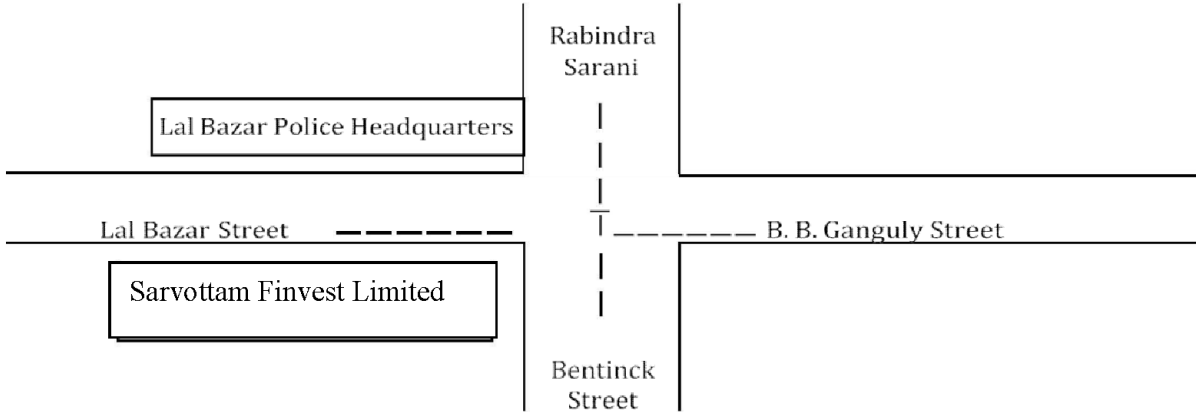

EXPLANATORY STATEMENT PURSUANT TO PROVISIONS OF SECTION 102 OF THE COMPANIES ACT, 2013 ("THE ACT") FORMING PART OF THE NOTICE DATED 3RD SEPTEMBER, 2026:

The following Explanatory Statement relating to the accompanying Notice sets out all material facts in respect of the resolutions:

ITEM NO. 3:

Mr. Dilip Kumar Gupta was re-appointed as the Managing Director of the Company for a period of five years effective from 1st October 2021 till 30th September, 2026, liable to retire by rotation, and the said re-appointment was approved by the shareholders at the 42nd Annual General Meeting held on 30th September, 2021.

MANAGEMENT DISCUSSION AND ANALYSIS REPORT

The Management Discussion and Analysis Report has to be read in conjunction with the Company's financial statements, covering overall performance and outlook of its activities which read as follows:

MACRO-ECONOMIC VIEW

The global economy exhibited uneven yet steady growth across major regions throughout calendar year 2025. According to the International Monetary Fund (IMF), global economic growth for CY25 is projected at 2.8%, a deceleration from the historical average (2000–2019) of 3.7% driven primarily by escalating trade tensions and a sharp surge in global economic policy uncertainty. This more muted global growth environment risks dampening international trade volumes, capital investments, and broad economic activity, which may consequently weigh on business sentiment, labor markets, and consumer discretionary spending.

Despite global trade volumes registering a year-on-year growth of 3.7% in 2024, the outlook for CY25 remains clouded by systemic uncertainty. Heightened risks regarding the scope, scale, and intensity of new tariff regimes are set to test the structural resilience of the global economy. This persistent policy friction is anticipated to drive structural realignments across global value chains, with the adverse ripple effects extending far beyond the United States amid ongoing geopolitical shifts. Prominent risks to global growth include escalating regional conflicts, prolonged monetary tightening, resurgent financial market volatility, and a rise in protectionist trade policies.

In contrast to the turbulent global environment, the Indian economy continues to demonstrate structural resilience, maintaining its position as one of the fastest-growing major economies. According to the Provisional Estimates released by the National Statistical Office (NSO), India's real GDP growth accelerated to 7.7% in FY26, up from the base of 7.1% recorded in FY25.

The growth trajectory throughout the fiscal year highlights a strong, stable performance:

H1-FY26 Performance: Real GDP growth slowed temporarily to a seven-quarter low of 5.6% in Q2-FY26, primarily weighed down by lower-than-anticipated government spending, severe heatwave conditions, a contraction in mining activity, and muted manufacturing output.

H2-FY26 Performance: Economic momentum staged a sharp recovery to 6.2% in the subsequent quarter and closed the final quarter on a strong note at 7.8% in Q4-FY26, supported by a strong rebound in rural demand and an acceleration in public capital expenditure.

On the supply side, Real Gross Value Added (GVA) registered an expansion of 7.7% in FY26. This expansion was structurally anchored by a stellar 11.5% growth in the manufacturing sector and an 8.9% expansion in the services sector, while the agriculture and allied sectors grew by a modest 2.4%.

Aggregate private consumption expenditure, measured via Private Final Consumption Expenditure (PFCE), grew at a steady clip of 7.7% in FY26, with its total share in GDP rising to 61.5%. However, the domestic market continued to navigate divergent demand dynamics:

Rural Markets: Demonstrated remarkable structural recovery and stable resilience, acting as a crucial anchor for mass-market consumer demand in the second half of the fiscal year, bolstered by strong agricultural performance.

Urban Markets: Faced temporary headwinds and selective consumption slack earlier in the year. This was driven by a combination of elevated borrowing costs, persistent food inflation in key pockets, stagnant inflation-adjusted salary growth, and a proactive, regulation-induced optimization of retail credit expansion.

Headline consumer inflation, measured via the Consumer Price Index (CPI), remained comfortably anchored within the Reserve Bank of India's (RBI) tolerance band, ending the fiscal period at 3.40% by March 2026 as structural food supply shocks abated. Crucially, core inflation remained comfortably anchored below the 4.0% threshold, reflecting well-contained demand-side pressures.

Despite stable headline prints, the fiscal year brought into sharp relief the intensifying impact of climate-related risks on primary supply chains. Extreme weather anomalies—highlighted by the percentage of heatwave days rising sharply to 18% during the 2023–2025 period compared to 5% in 2021–2023—frequently impacted crop yields. Consequently, the structural composition of inflation has fundamentally shifted over the years, with food inflation's contribution to headline CPI rising progressively over consecutive fiscal blocks (FY23 – 34% ; FY24 - 46% ; FY 25 – 59% ; FY-26 – 65%)

The Central Government maintained its strict commitment to fiscal consolidation, achieving a better-than-budgeted Fiscal Deficit-to-GDP ratio of 4.4% for FY26. While total capital outlays were slightly lower than initial budget estimates, the overall quality of public spending continued to improve, with capital expenditure growth notably outpacing revenue expenditure growth. Concurrently, compressed gross and net market borrowings alleviated pressure on sovereign yields and successfully supported a narrowing of the Public Debt-to-GDP ratio to 57.1% in FY26.

In the external sector, following a highly stable H1-FY26, the Indian Rupee (INR) experienced depreciation pressures in H2-FY26, depreciating by 2.3% due to a strengthening US Dollar index and global trade adjustments ("tariff tantrums"). To mitigate excess volatility, the RBI actively deployed its foreign exchange reserves, resulting in a drawdown of approximately US\$ 40 billion in H2-FY26, which contrasted with a net accretion of US\$ 60 billion during H1-FY26. Despite this active intervention, India's external systemic buffers remain highly robust, with foreign currency reserves providing a comfortable import cover of approximately 11 month.

INDUSTRY VIEW

The domestic credit landscape in FY25-26 presented a nuanced, two-sided picture. While financial institutions benefited from enhanced profitability metrics and remarkably stable asset quality (with systemic Gross Non-Performing Asset ratios dropping to a multi-decade low of 2.2%), overall credit expansion was intentionally tempered. This moderation was driven by proactive and stringent regulatory measures implemented by the central bank to prevent systemic overheating in specific unsecured retail lending pockets.

Consequently, credit uptake among new-to-credit (NTC) consumers and originations within consumption-led loan segments witnessed a sharp deceleration during the first half of the fiscal year as lenders adopted a highly cautious underwriting stance. However, toward the final quarters of the fiscal period, this regulatory-induced caution began to dissipate, giving way to renewed credit momentum as broader economic impulses grew fundamentally stronger.

The NBFC sector remains structurally healthy and well-insulated against potential external shocks, entering the new fiscal period characterized by comfortable capital cushions, robust earnings visibility, and consistently improving asset quality. Key operational benchmarks highlighting the sector's financial strength include; Total AUM growth for NBFCs is expected to expand within a healthy 12% to 18% range for the year, spearheaded by MSME loans, retail credits, and gold loans; Capital to Risk-Weighted Assets Ratio (CRAR) stands at a highly resilient systemic level of 26.1%; Net Interest Margins (NIM) remain robust at 5.1%, while Return on Assets (RoA) stands strong at 2.9%; Gross Non-Performing Assets (GNPA) improved significantly, dropping to a stable 3.4%.

FINANCIAL PERFORMANCE - OVERVIEW.

Sarvottam Finvest Limited ("The Company") is a registered Non-Banking Financial Company (NBFC). The performance of the Company is discussed in the Directors' Report. The Company is listed on Calcutta Stock Exchange Limited and Bombay Stock Exchange. The financial statements of the Company are prepared in compliance with applicable provision of the Companies Act, 2013 and applicable Indian Accounting Standards. The Company has earned income from financing, providing loans and advances trading of securities, interest and dividend. The Company will extend the business further through identification of promising investment opportunities, through leveraging its resources. Company is also looking forward to expand its operations in the other fields permitted by the regulator, in conformity with its present status. The Company is engaged in the businesses permitted for Non-Banking Financial Company and offered a wide range of fund based financial services to its customers. Nearly 100 percent of the operating profits were contributed by core businesses viz., lending, trading in securities and investments.

DISCLOSURE OF ACCOUNTING TREATMENT

The Company has followed the Standards of Accounting specified under Section 133 of the Act, read with Indian Accounting Standard (IndAS) as per the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time and notified under Section 133 in preparation of its financial statements.

There was no change in the accounting treatment during the year.

CAPABILITIES AND STRATEGY

India's financial services sector comprises of commercial banks/co-operative banks, non-banking financial companies, insurance companies, pension/mutual funds and other various entities. India is expected to be fourth largest private wealth market globally by 2028. The NBFC sector plays important role in financial inclusion by meeting credit needs of retail and MSME sector. The NBFC sector provides efficient credit distribution reach to untapped and under-penetrated regions and customer class. It brings the much-needed diversity to the financial sector by providing consumer credit, including automobile finance, home finance and consumer durable products finance, wholesale finance products such as bills discounting forms all and medium companies and fee based services such as investment banking and under writing. NBFCs have carved niche business areas for them within the financial sector space and are also popular for providing customized products. Few NBFCs have upheld their position in this market. However, intense competition, dynamic environment, compliance framework and stricter regulations are forcing companies to change its framework. The Company is helping enterprises to rationalize and making business operationally efficient and remain cost competitive in market. The Company is in process of creating a separate niche in market. The Company's strategy for longterm profitable growth is based on continuous scaling and updated to its core businesses, while investing in new customers, services, markets and industries. The Company's strategy of strengthening the current business and investing in future revolves around:

1. Customer centricity.
2. Proximity to client's location.
3. Transparent communication.
4. Flexible control systems

OPPORTUNITY AND THREATS

Non-Banking Financial Companies ("NBFCs") remain one of the most important pillars for us hering financial inclusion in India, reaching out to a hitherto under/unserved populace and in the process leading to "formalization" of the credit demand. The NBFC scatter the needs of both the retail as well as commercial sectors and, at times, have been able to develop strong niches with their specialized credit delivery models that even larger players including banks, have found hard to match. This has further provided a fillup to employment generation and wealth creation and in the process, bringing in the benefits of economic progress to the weaker sections of the society.

RISKS AND CONCERNS

The Company aims to operate with in an effective risk management framework to actively manage all the material risks faced by the organization and make it resilient to shocks in a rapidly changing environment. It aims to establish consistent approach in management of risks and strives to reach the efficient frontier of risk and return for the organization and its shareholders. Broad categories of risk faced by the Company are Credit Risk, Market Risk, Operational Risk, Fraud Risk, Compliance Risk, Cyber Security and Reputation Risk. The risk management policies are well defined for various risk categories supplemented by periodic monitoring through the sub committees of the Board

- (i) The Company reviews its risk factors annually in order to keep it aligned with the changing global risks.
- (ii) The Company manages such risks by maintaining a conservative financial profile and following prudent business and risk management practices.
- (iii) The company is operating on a well-defined plan and strategy; hence we are equipped to face any change in regulatory risk.
- (iv) The risk appetite is enunciated by the Board from time to time.

COMPLIANCE

We have a robust risk management framework covering all elements of risk management which is aligned to RBI requirements and also other international best practices. The company regularly monitors the changes in legislation pertaining to employment, labour and immigration laws across the globe to ensure total compliance assisted by regular audits. The key areas where the Company needs to introduce new policies or modify the existing policies to remain compliant are identified and acted upon. The Company has complied with all the regulations and guidelines of RBI applicable to a Non-Banking Finance Company.

INTERNAL CONTROL SYSTEMS AND THEIR ADEQUACY

The Company has adequate internal control system commensurate with its size and nature of business. Conforming to the requirements of the regulatory authorities such as the RBI and the SEBI and consistent with the requirements of the Listing agreements with the Stock Exchanges, the company has institutionalized an elaborate system of control processes designed to provide a high degree of assurance regarding the effectiveness and efficiency of operations, the adequacy of safeguards for assets, reliability of financial controls and compliance with applicable laws and regulations. These systems are designed in a manner to provide reasonable assurance about the integrity and reliability of the financial statements. The Internal Auditors are mandated to carry out periodical audit and report on areas of non-compliances/weaknesses. Corrective actions in case of reported deficiencies, if any, are taken actively to further strengthen the internal control systems. These reports are reviewed by the Audit Committee of the Board of Directors for follow-up action and instructions are issued for taking necessary measures. The Company's present business operations are preponderantly that of a Loan Company, future of which largely depends upon financial and capital markets. The Company has exposure in financially sound entities. The management is optimistic about the future outlook of the Company. Further, more promising areas of activity are being explored on a sustained basis. The Company will expand its activities, consistent with its status as a Non-Banking Finance Company.

HUMAN RESOURCES

The Company firmly believes that intellectual capital and human resources is the backbone of the Company's success. The Company always treats human resources as its most valuable assets and continuously evolves policies and process to attract and retain its substantial pool of managerial resources through friendly work environment. The Company has always aimed to create a work place where every person can achieve his optimum potential. In view of this, the Company encourages its people to balance their professional and personal responsibilities leading to a more productive tenure of its employees. The Company lays great emphasis on building a motivated workforce, which can participate constructively in the growth of the Company.

In terms of Regulation 25(8) of Listing Regulations, they have also confirmed that they are not aware of any circumstance or situation which exists or may be reasonably anticipated that could impair or impact their ability to discharge their duties. Based on the declarations received from the Independent Directors, Board confirms that the Independent Directors fulfill the conditions specified in the SEBI (LODR) Regulations, 2015 and are independent from the management.

Dispute Resolution Mechanism

Notes to the Financial Statements for the year ended March 31, 2026

Note No. 1 - Corporate Information

Sarvottam Finvest Ltd. ('the Company', 'SFL') is a company limited by shares, incorporated on 30 November 1978 and domiciled in India. The Company is engaged in the business of financing, providing loans and advances, inter-corporate deposits and investment & trading in shares & securities. It's shares are listed on The Calcutta Stock Exchange Limited and BSE Limited. The Company has its registered office at 3, Bentinck Street, Kolkata, West Bengal, India.

The Company is a non-deposit taking Non-Banking Financial Company (NBFC), registered with the Reserve Bank of India (RBI) with effect from 09-July-2012, with Registration No. B.05.01047 and classified as NBFC Investment and Credit Company (NBFC-ICC) pursuant to circular DNBR(PD) CC No. 097/03.10.001/2018-19 dated 22 February 2019. The company is classified as a base layer (BL) NBFC.

On 30 May, 2026, Board of Directors of the Company approved and recommended the audited financial statements for consideration and adoption by the shareholders in its annual general meeting.

Note No. 2 - Basis of Preparation**(i) Statement of Compliance with IndAS**

The financial statements have been prepared in accordance with Indian Accounting Standards (Ind AS) as per the Companies (Indian Accounting Standards) Rules, 2015 as amended from time to time and notified under Section 133 of the Companies Act, 2013 (the Act) along with other relevant provisions of the Act and the Master Direction –Reserve bank of india (Non-Banking Financial Company –scale based Regulation) Directions, 2025 ('the NBFC Master Directions') issued by RBI. The financial statements have been prepared on a going concern basis. The Company uses accrual basis of accounting except in case of significant uncertainties.

(ii) Functional and presentation currency

These financial statements are presented in Indian Rupees in lakhs (INR lakhs), which is also the Company's functional currency. All amounts have been rounded off to the nearest lakhs, unless otherwise indicated.

(iii) Use of Estimates & Judgements

The preparation of these Financial Statements requires management judgements, estimates and assumptions that affect the application of Accounting Policies, the Accounting disclosures made and the reported amounts of Assets, Liabilities, Income and Expenses. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to Accounting estimates are recognised in the period in which the estimates are revised and any future periods effected pursuant to such revision.

Note No. 3 - Material Accounting Policies

The note provides a list of the significant accounting policies adopted in the preparation of these financial statements. These policies have been consistently applied to all the years presented, unless otherwise stated.

3.1 Revenue Recognition*(i) Interest income*

Interest income is calculated by applying effective interest rate.

(ii) Dividend income

Dividend on shares & securities is recognised on receipt basis.

(iii) Net Gain/(Loss) on Fair Value Changes

Any differences between the fair values of Financial Assets (including investments, derivatives, and stock-in-trade) classified as fair value through the profit/loss (FVTPL) held by the company on the Balance Sheet date is recognised as an unrealised gain/loss. In other cases there is the net gain in the aggregate, the same is recognised in "Net Gains on fair value changes" under Income side and if there is a net loss the same is disclosed under "Expenses side" in the Statement of Profit and Loss.

3.2 Expenditures*(i) Finance costs*

Borrowing costs on financial liabilities are recognised using the Effective interest rate.

(ii) Employee Benefit Expenses

In Indian Accounting Standards (Ind AS), Ind AS 19, Employee Benefit Expenses include all forms of consideration given by a company in exchange for services rendered by its employees or for the termination of employment.

Note that in an Ind AS financial statement, these are presented in the Statement of Profit and Loss, while any outstanding liabilities or prepayments at the end of the year go into the Balance Sheet.

(iii) Other expenses

Other expenses which are not directly linked to the sourcing of financial assets are recognised in the Statement of Profit and Loss on an accrual basis.

3.3 Cash and cash equivalents

Cash and cash equivalents include cash on hand, other short term, highly liquid investments with original maturities of three months or less that are readily convertible to known amounts of cash and which are subject to an insignificant risk of changes in value.

3.4 Financial Instruments

A financial instrument is defined as any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity. Trade receivables and payables, loan receivables, investments in securities and subsidiaries, debt securities and other borrowings, preferential and equity capital etc. are some examples of financial instruments. All the financial instruments are recognised on the date when the Company becomes party to the contractual provisions of the financial instruments. For tradable securities, the Company recognises the financial instruments on settlement date.

3.5 Financial assets

Financial assets include cash, or an equity instrument of another entity, or a contractual right to receive cash or another financial asset from another entity. Few examples of financial assets are loan receivables, investment in equity and debt instruments, trade receivables and cash and cash equivalents.

3.5.1 Classification and subsequent measurement

The Company has applied Ind As 109 and classifies its financial assets in the following measurement categories: - Fair value through profit or loss (FVTPL)

- Fair value through other comprehensive income (FVOCI); or
- Amortised cost

Fair value through profit or loss: Assets that do not meet the criteria for amortised cost or FVOCI are measured at fair value through profit or loss; A gain or loss on a debt investment that is subsequently measured at fair value through profit or loss and is not part of a hedging relationship is recognised in statement of profit and loss in the period in which it arises, unless it arises from debt instruments that were designated at fair value or which are not held for trading. Interest income from these financial assets is included in 'interest income' using the effective interest rate method.

Fair value option for financial assets: The Company may also irrevocably designate financial assets at fair value through profit or loss if doing so significantly reduces or eliminates an accounting mismatch created by assets and liabilities being measured on different bases.

Amortised Cost: Assets that are held for collection of contractual cash flows where those cash flows represent solely payments of principal and interest ('SPPI'), and that are not designated at FVTPL, are measured at amortised cost. The carrying amount of these assets is adjusted by any expected credit loss allowance recognise and measured. Interest income from these financial assets is recognised using the effective interest rate method.

However, the loans granted by the company are in the nature of repayable on demand and the time period of the same is uncertain and as a result, amortised cost of loans has not been taken.

Under Ind AS 109, financial instruments are classified as held for trading if they are acquired principally for the purpose of selling or repurchasing in the near term to profit from short-term price fluctuations, which automatically includes all derivatives not designated as hedging instruments. On the Ind AS Balance Sheet, these liquid instruments must be measured at Fair Value Through Profit or Loss (FVTPL); positive-value instruments are reported under Current Assets (as Financial Assets - Investments), while negative-value instruments or short positions are reported under Current Liabilities (as Other Financial Liabilities), with any year-end market value changes recognized directly in the Statement of Profit and Loss.

3.5.2 Interest Income

Interest income is calculated by applying the effective interest rate to the gross carrying amount of financial assets, except for:

a) Purchased or originated credit impaired (POCI) financial assets, for which the original credit –adjusted effective interest rate is applied to the amortised cost of that financial assets.

b) Financial assets that are not 'POCI' but have subsequently become credit-impaired (or 'stage 3'), for which interest revenue is calculated by applying the effective interest rate to their amortised cost (i.e., net of the expected credit loss provision).

The effective interest rate is the exactly discounts estimated future cash payments or receipts through the expected life of the financial assets or liability to the gross carrying amount of a financial assets (i.e, its amortised cost before any impairment allowance) or to the amortised cost of a financial liability. The calculation does not consider expected credit losses and includes transaction cost, premiums or discounts and fees and points paid or received that are integral to the effective interest rate, such as origination fees. For FVOCI financial assets - assets that are credit impaired at initial recognition- the company calculates the credit-adjusted effective interest rate, which is calculated based on the amortised cost of the financial assets instead of its gross carrying amount and incorporates the impact of expected credit losses in estimated future cash flows.

3.5.3 Equity instruments

Equity instruments are instruments that meet the definition of equity from the issuer's perspective; that is, instruments that do not contain a contractual obligation to pay and that do not contain a contractual obligation to pay and that evidence a residual interest in the issuer's net assets. The Company subsequently measures all equity investments at fair value. Where the company's management has elected to present fair value gains and losses on equity investments in other comprehensive income, there is no subsequent reclassification of fair values gains and losses to profit or loss following the derecognition of the investment. Changes in the fair value of financial assets at fair value through profit or loss are recognised in net gain/loss on fair value changes in the statement of profit and loss. Impairment losses (and reversal of impairment losses) on equity investments measured at FVOIC are not reported separately from other changes in fair value.

Gains and losses on equity investments at FVTPL are included in the statement of Profit and Loss.

3.5.4 Equity Derivatives.

All Derivatives other than those hedging which do not meet the criteria for classification as subsequently measured at amortised cost or fair market value through other comprehensive income (FVOCI) are measured at fair value at each reporting date and all gains/losses are recognised in the statement of profit and loss.

3.5.5 Impairment

The Company assesses on a forward looking basis the expected credit losses (ECL) associated with its debt instruments carried at amortised cost and FVOCI and with the exposure arising from loan commitments and financial guarantee contracts. The Company recognizes a loss allowance for such losses at each reporting date.

The measurements of ECL reflects:

- An unbiased probability-weighted amount that is determined by evaluating a range of possible outcome;
- The time value of money; and
- Reasonable and supportable information that is available without undue cost or effort at the reporting date about past events, current conditions and forecasts of future economic conditions.

The measurement of the ECL allowance is an area that requires the use of complex models and significant assumptions about future economic condition and credit behaviour (e.g., the likelihood of customers defaulting and the resulting losses.)

3.5.6 Write-off policy

The Company writes off financial assets, in whole or in part, when it has exhausted all practical recovery efforts and has concluded there is no reasonable expectation of recovery. Indicators that there is no reasonable expectation of recovery include (i) ceasing enforcement activity and (ii) where the company's recovery method is foreclosing on collateral and the value of the collateral is such that there is no reasonable expectation of recovering in full.

3.5.7 Derecognition other than on a modification

Financial assets, or a portion thereof, are derecognised when the contractual rights to receive the cash flows from the assets have expired, or when they have been transferred and either (i) the Company transfers substantially all the risk and rewards of ownership, or (ii) the Company neither transfer nor retains substantially all the risks and rewards of ownership and the company has not retained control. The company directly reduces the gross carrying amount of a financial assets when there is no reasonable expectation of recovering a financial assets in its entirety or a portion thereof.

3.6 Property, plant and equipment (PPE)

Property, Plant and Equipment are stated at cost less accumulated depreciation and accumulated losses, if any. Cost includes expenses directly attributable to bringing the Asset to their location and conditions necessary for it to be capable of operating in the manner intended by the management.

Subsequent cost are included in the asset's carrying amount or recognized as separate asset, as appropriate, only when it is probable that is future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognized when replaced. All other repairs and maintenance are charged to profit or loss during the reporting period in which they are incurred.

Depreciation methods, estimated useful lives and residual value

Depreciation is calculated using the straight-line method to allocate their cost less their residual values on the basis of useful lives prescribed in Schedule II to the Companies Act, 2013.

The residual values are not more than 5% of the cost of an item of PPE. Depreciation methods, useful lives and residual values are reviewed at the end of each financial year and adjusted prospectively, if appropriate.

Gains and losses on disposals are determined by comparing proceeds with carrying amount. These are included in profit or loss within other gains/(losses).

3.7 Financial liabilities

Financial liabilities include liabilities that represent a contractual obligation to deliver cash or another financial assets to another entity, or a contract that may or will be settled in the entities own equity instruments. Few examples of financial liabilities are trade payables, debt securities and other borrowings and subordinated debts.

3.7.1 Initial measurement

All financial liabilities are recognised initially at fair value and, in the case of borrowings and payables, net of directly attributable transaction costs. The Company's financial liabilities include trade payables, other payables, debt securities and other borrowings.

3.7.2 Subsequent measurement

After initial recognition, all financial liabilities are subsequently measured at amortised cost using the EIR [Refer note no. 3.1(i)]. Any gains or losses arising on derecognition of liabilities are recognised in the Statement of Profit and Loss.

3.7.3 Derecognition

The Company derecognises a financial liability when the obligation under the liability is discharged, cancelled or expired.

3.8 Offsetting of financial instruments

Financial assets and financial liabilities are offset and the net amount is reported in the Balance Sheet only if there is an enforceable legal right to offset the recognised amounts with an intention to settle on a net basis or to realise the assets and settle the liabilities simultaneously.

3.9 Fair value measurement

The Company measures its qualifying financial instruments at fair value on each Balance Sheet date.

Fair value is the price that would be received against sale of an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The fair value measurement is based on the presumption that the transaction to sell the asset or transfer the liability takes place in the accessible principal market or the most advantageous accessible market as applicable. The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data is available to measure fair value, maximising the use of relevant observable inputs and minimising the use of unobservable inputs. All assets and liabilities for which fair value is measured or disclosed in the financial statements are categorised within the fair value hierarchy into Level I, Level II and Level III based on the lowest level input that is significant to the fair value measurement as a whole.

For a detailed information on the fair value hierarchy, refer note no. 35. For assets and liabilities that are fair valued in the financial statements on a recurring basis, the Company determines whether transfers have occurred between levels in the hierarchy by re-assessing categorisation (based on the lowest level input that is significant to the fair value measurement as a whole) at the end of each reporting period. For the purpose of fair value disclosures, the Company has determined classes of assets and liabilities on the basis of the nature, characteristics and risks of the asset or liability and the level of the fair value hierarchy.

3.10 Investment - held for trading

Investments are classified as Held for Trading ("HFT") where they are acquired principally for the purpose of selling or repurchasing them in the near term or form part of a portfolio of identified financial instruments that are managed together and for which there is evidence of a recent actual pattern of short-term profit taking, in accordance with Ind AS 109, Financial Instruments.

Investments classified as HFT are initially recognised at fair value. Transaction costs directly attributable to the acquisition are recognised immediately in the Statement of Profit and Loss. Subsequently, such investments are measured at fair value through profit or loss (FVTPL), with changes in fair value recognised in the Statement of Profit and Loss.

Interest income and dividend income are recognised in the Statement of Profit and Loss in accordance with the applicable requirements of Ind AS 109.

3.11 Trade receivable

All financial assets are recognised initially at fair value plus in case of financial assets not recorded at fair value through profit or loss(FVPTL) transaction costs that are attributable to the acquisition of the financial assets. However trade receivables that do not contain a significant financial component are measured at transaction price.

3.12 Taxes*3.12.1 Current tax*

Current tax assets and liabilities are measured at the amount expected to be recovered from or paid to the taxation authorities, in accordance with the Income Tax Act, 1961 and the Income Computation and Disclosure Standards (ICDS) prescribed therein. The tax rates and tax laws used to compute the amount are those that are enacted or substantively enacted, at the reporting date. Current tax relating to items recognised outside profit or loss is recognised in correlation to the underlying transaction either in OCI or directly in other equity. Management periodically evaluates positions taken in the tax returns with respect to situations in which applicable tax regulations are subject to interpretation and establishes provisions where appropriate. The company has opted for the New Tax regime u/s 115BAA of IT Act.

3.12.2 Deferred tax

A Deferred tax asset shall be recognised for the carry forward of unused tax losses and unused tax credit to the extent that it is probable that future taxable profit will be available against which the unused tax losses and unused tax credits can be utilised.

Deferred tax assets and liabilities are assets when there is legally enforceable right to offset current taxes assets and liabilities and when the deferred tax balances relate to the same taxation authority. Current tax assets and tax liabilities are offset where the entity has a legally enforceable right to offset and intends either to settle on net basis or to realise the asset and settle the liability simultaneously.

3.13 Impairment of non-financial assets

An assessment is done at each Balance Sheet date to ascertain whether there is any indication that an asset may be impaired. If any such indication exists, an estimate of the recoverable amount of asset is determined. If the carrying value of relevant asset is higher than the recoverable amount, the carrying value is written down accordingly.

3.14 Provisions and contingent liabilities

The Company creates a provision when there is present obligation as a result of a past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. The Company also discloses present obligations for which a reliable estimate cannot be made. When there is a possible obligation or a present obligation in respect of which the likelihood of outflow of resources is remote, no provision or disclosure is made.
